NOTES TO FINANCIAL STATEMENTS

A - DESCRIPTION OF PLAN

The following description of the Harold Jones Landscape Inc. 401(k) P/S Plan (the “plan”) is provided for general information purposes only. The plan sponsor is Harold Jones Landscape Inc. 401(k) P/S Plan Participants should refer to the Summary Plan Description (SPD) for additional information.

General

The plan was adopted effective January 1, 2009 and has been subsequently amended to conform to Federal regulations and is a qualified defined contribution plan covering all employees of Harold Jones Landscape Inc. (the Company) who have completed one year of service and have reached the age of 21. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Presberg Pensions, Inc. is the third-party administrator for the plan and American Trust Company is the custodian.

The plan invests in mutual funds through a contract with American Trust Company. The custodian of the plan has been designated to hold the assets of the plan for the benefit of plan Participants and their beneficiaries in accordance with the terms of this plan. The Trust Fund established by the plan's custodian will be the funding medium used for the accumulation of assets from which plan benefits will be distributed.

Allocations

Assets of the plan are allocated to participant accounts based on specific contributions made by each participant and respective matches made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

Contributions and allocations

To allow participants the opportunity to increase their retirement income, each participant may, in accordance with nondiscriminatory procedures established by the administrator, elect to make employee voluntary contributions to the plan. Such contributions must generally be paid to the custodian within a reasonable period of time after being received by the employer. There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401 (k) deferrals.

The Company may contribute a 3% safe harbor non-elective contribution. The contribution is based upon compensation and is given to all eligible employees, not just those who make salary deferral contributions. For the year ended 2024, the Company made safe-harbor contributions of \$63,493.

The Company may make a discretionary additional matching contribution. If the Company makes a discretionary additional matching contribution, the discretionary additional matching contribution will not apply as to elective deferrals exceeding 6% of participant's compensation. The total amount of this discretionary additional matching contribution will not exceed 4% of participants compensation. The Company elected to make a matching contribution \$294,999, which was accrued at December 31, 2024 to be deposited in 2025.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. In addition, participants are immediately vested in all safe harbor and discretionary matching contribution. Vesting in the Employer's discretionary nonelective contribution portion of the participant's accounts plus actual earnings thereon is 20% after the second year of service increasing by 20% per year through year six of service. A participant will be fully vested in all of their accounts under the plan (including those accounts attributable to the adopting employer's contributions) upon reaching the plan's normal retirement age (age 65), their disability or death.

Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant with an account balance of \$5,000 or less, the Plan will rollover the participant distribution to an IRA if they do not make an affirmative election to either receive or roll over the distribution.

If a participant's account balance (excluding any rollover contribution account but including any outstanding loan balance account) is greater than \$5,000 as of the applicable valuation date, in addition to either a lump sum or direct rollover, they may choose to receive installments, request a partial withdrawal, or defer receiving payments until age 70½.

A participant may receive a hardship distribution of his or her salary reduction contributions if the distribution is (1) on account of medical expenses incurred by the participant, their spouse or dependents, (2) to purchase (excluding mortgage payments) a principal residence of the participant, (3) for the payment of tuition, related educational fees and room and board for the next twelve months of post-secondary education for the participant, their spouse, children or dependents, (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence, (5) payments for burial or funeral expenses of your deceased parent, spouse, children or other dependents, or (6) expenses for the repair of damage to your principal residence that would qualify for the casualty deduction under the Internal Revenue Code and (7) expenses for disasters arising from federally declared disasters, such as expenses and losses (including loss of income) attributable to that disaster, provided the participant's principal residence or place of employment was in an area FEMA designates as qualifying for individual assistance.

Forfeitures

The Employer may use forfeitures to pay plan expenses, allocate as additional employer contributions or use them to reduce amounts otherwise required to be contributed to the plan. During the 2024, there were \$2,954 of forfeitures. As of December 31, 2024, there were no unallocated forfeitures.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment options

The plan allows each participant to direct investments of the balance of their participant account. Plan participants can change their investments at any time.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time, and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Because the plan is a defined contribution plan, it is not covered by Pension Benefit Guaranty Coverage insurance.

Notes receivable from participants

Participant loans are permitted under the plan. A participant can borrow the lesser of fifty percent of their vested account balance or \$50,000. The initial loan must at least \$500. All loans are considered directed investment of the participant's account and all payments of principal and interest will be credited to their account. A participant may only have two (2) loans outstanding at any given time. Loan terms may not exceed five years except in the case of a loan for a primary residence which may not be longer than thirty years. The participant's loan is collateralized by the balance in the participant's account and bears interest at Wall Street Journal prime plus two percent.

Participant rollovers

Participants are allowed to transfer or rollover funds into the plan from other qualified plans.

Administrative expenses

Any fees related to the administration of the plan or associated with the investment of plan assets may be paid by the plan or by the plan sponsor. Participant transaction fees are charged directly to participant accounts.

B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following summary of the plan's significant accounting policies is presented to assist in understanding the financial statements. The financial statements and notes are representations of the plan's management, who is responsible for their integrity and objectivity.

Basis of presentation and use of estimates

The plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The accrual basis of accounting requires the use of estimates and assumptions that affect the assets, liabilities, revenues and expenses reported in the financial statements, as well as amounts included in the notes thereto, including discussion and disclosure of contingent liabilities. Although the plan uses its best estimates and judgments, actual results could differ from these estimates as future confirming events occur.

Investment valuation and income recognition

Mutual funds are reported at fair value based on published market prices, which represent the quoted net asset values of shares held by the plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the exdividend date. Net appreciation in fair value of investments includes the plan's realized gains and losses on investments bought and sold as well as unrealized gains and losses on investments held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis when received. Related fees are charged directly to the borrowing participant's account when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Contributions

Contributions from employees are recorded in the period in which they are deducted from participant earnings. Company contributions may be recorded when received or accrued.

Plan expenses and payments of benefits

Plan expenses and the payment of benefits are recorded when paid by the plan.

C - TAX STATUS

Harold Jones Landscape Inc. 401(k) P/S Plan document is based upon a volume submitter plan instrument from The Retirement Plan Company, LLC which received an IRS advisory letter dated October 6, 2020. The volume submitter plan instrument has been updated for legislative and regulatory changes. Management Committee of The Retirement Plan Company, LLC and plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for state or federal income taxes has been included in the plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL Regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Fees incurred by the plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

During 2024, the Plan made direct payments of \$17,583 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA.

## H - CONCENTRATIONS OF RISK

The following is a summary of financial instruments subject to credit risk at year end.

### Investment Securities

The plan's investments are not insured by agencies of the United States government. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits. The maximum amount of loss due to credit risk that the plan would incur if parties to the financial instruments failed to perform according to the terms of the contracts and the collateral, in any, proved to be of no value would approximate the balances that appear on the Statement of Net Assets Available for Benefits.

### Notes Receivable from Participants

As discussed in Note A above, if a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document. Consequently, an allowance for collectability is not considered necessary by plan management.

### General business economy

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

## I - SUBSEQUENT EVENTS AND DATE OF MANAGEMENT'S REVIEW

The plan's management has evaluated subsequent events through date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.
