We have performed audits of the accompanying financial statements of the Futures Community Support Services, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Futures Community Support Services, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Futures Community Support Services, Inc. (the "Company") excluding non-resident alien and contracted employees. Employees are eligible to participate in the Plan upon reaching age 21 and completion of one year of service and 1,000 hours within that year of service. Entry dates into the plan during 2023 were January 1st or July 1st following the date the employee became eligible to participate. Effective beginning June 2024, entry dates became quarterly on the 1st day of each quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration

The Company is the plan administrator and two of its employees served as the Plan's trustees during 2023. Effective January 1, 2024, the two former trustees of the Plan were replaced by a new trustee, who is also an employee of the Company. During 2023 and through July 31, 2024, all Plan assets were held in trust and managed by Voya Retirement Insurance and Annuity Company, a wholly owned subsidiary of Voya Financial ("Voya"). Effective August 1, 2024, all Plan assets were held in trust and managed by Matrix Trust Company ("Matrix"). During 2023 and through July 31, 2024, Valley Forge Pension Management, Inc. provided third-party administrative services to the Plan. Effective August 1, 2024, the Plan changed to Citizens & Northern Bank to provide third-party administrative services to the Plan. Administrative expenses are paid by the Plan and allocated proportionately to each Plan participant.

Contributions

Participants can contribute up to 100% of compensation, subject to the maximum dollar amount permissible under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The matching contribution to the Plan ranges from 3% to 9% of eligible employee compensation, based on the employee deferral amount and years of service, as defined in the plan document. The matching contributions made to the Plan for the years ended December 31, 2024 and 2023 totaled \$82,980 and \$66,467 respectively. For the 2024 matching contributions, the Plan used \$21,593 of forfeitures to fund the matching contribution. No forfeitures were used to fund the 2023 matching contribution.

At the discretion of the Sponsor, the Plan may make employer profit sharing contributions which are allocated based on the participants respective compensation and years of service, as defined in the plan document. The Plan made profit-sharing contributions for both of the years ended December 31, 2024 and 2023. The profit-sharing contributions made to the Plan for the years ended December 31, 2024 and 2023 totaled \$188,255 and \$176,448, respectively.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Participants' accounts are credited with their contributions and allocations of (a) the Company's matching and profit-sharing contributions, (b) the Plan's earnings and (c) administrative expenses and fees. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their individual contributions and actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions and actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of service, and vests 20% per year until they are 100% vested after five years of credited service or upon death, disability, or reaching the age of 65.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options as indicated by the Plan sponsor, which provide diversified investment allocations. Participants may change their investment options electronically at any time during the year.

Payment of Benefits

On termination of service due to health, disability, retirement or death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account, partial withdrawals of at least \$1,000, or annual installments over a specified period.

In-service distributions are allowed for participants who have attained age 59 ½ and whose accounts from which the distributions will be taken are 100% vested.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from vested accounts. Hardship withdrawals can only be made for payment of qualifying expenses to satisfy financial hardship, as defined in the plan document.

Forfeitures

Any forfeitures arising under the Plan may be used to pay plan expenses or reduce amounts otherwise required to be contributed to the Plan. The Plan's forfeiture balance totaled \$38,151 and \$5,233 as of the years ended December 31, 2024 and 2023, respectively. Forfeitures used to offset matching contributions totaled \$21,593 during the 2024 plan year. No forfeitures were used during 2023.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100 percent vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States ("GAAP").

Investment Valuation and Income Recognition

The Plan's mutual fund and money market investments are stated at fair value based upon quoted market prices, as determined by the custodian of the Plan's assets. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's guaranteed investment contract ("GIC") was considered fully benefit-responsive and was stated at contract value in the accompanying statement of net assets available for benefits as of December 31, 2023. Contract value was equal to participant deposits minus participant withdrawals plus credited interest. Contract value was subject to market value adjustments in connection with contract holder directed withdrawals or under limited circumstances for certain in-service participant withdrawals. The fair value of the Voya Fixed Account, which consisted of an underlying GIC owned by the Plan, was calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The change in fair value of investments and realized gains (losses) are reflected in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Fair Value of Financial Instruments

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's money market fund and mutual funds are valued utilizing Level 1 inputs.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan does not have any investments that are valued utilizing level 2 inputs.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan does not have any investments that are valued utilizing level 3 inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value of Financial Instruments (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual and money market funds – Stated at fair value based on quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Income Taxes

The plan sponsor determines whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024 and 2023, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Events Occurring After Reporting Date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and January 5, 2026, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had one guaranteed investment contract option with Voya. The account was credited with earnings on the underlying investments and charged for the Plan withdrawals and administrative expenses charged by Voya. In accordance with the terms of ASC Topic 962, the contract was considered to be fully benefit responsive. As such, the contract is included in the financial statements at contract value. The contract value of the investment contract at December 31, 2023 was \$665,400. The crediting interest rate to participants for the contract as of December 31, 2023 was 3.00%. The guaranteed minimum crediting interest rate for the contract for the year ending December 31, 2023 was 3.00%. No guaranteed investment contract option investments were held by the Plan as of December 31, 2024.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

6. TAX STATUS

The Plan obtained an opinion letter for the prototype for the Plan, dated January 1, 2022, in which the Internal Revenue Service stated that the form of the Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are held in mutual funds and a guaranteed investment account that are managed by Voya and Matrix. Voya was the custodian of the Plan through August 1, 2024 and Matrix is the custodian of the Plan beginning August 1, 2024 and, therefore, these transactions qualified as party-in-interest transactions.

8. NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor did not timely remit certain participant contributions for fifteen (15) separate pay periods during 2023, with total contributions remitted late being \$57,059. All contributions have been remitted as of January 2024, with certain of the pay periods remitted, albeit late, during the 2023 year.

Once discovered, the Company corrected the error through the IRS self-correction program, and the participant accounts were credited with the amount of investment income that would have been earned had the participant contributions been made on a timely basis. Such amounts are not material to the Plan's financial statements.

8. NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS (Continued)

The Plan sponsor also did not timely deposit employer profit sharing and matching contributions for both the 2024 and 2023 years by their respective due dates. These delinquent contributions totaled \$249,642 and \$242,915 for the years ended December 31, 2024 and 2023 and are included in employer contributions receivable at December 31, 2024 and 2023, respectively, in the accompanying statement of net assets available for benefits. These contributions for the years ended December 31, 2024 and 2023 were deposited by the Plan sponsor in December 2025 and February 2025, respectively.
