## INDEPENDENT AUDITORS' REPORT

To the Participants and Trustees of

### Opinion

## **1. DESCRIPTION OF PLAN:**

The following description of the Column Health, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all employees except union and nonresident alien employees of the Column Health LLC (Plan Sponsor or Company) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 9, 2023, the Plan Sponsor approved the merger of the Plan with Brightview, LLC 401(k) Plan. The Plan's assets totaling \$1,127,857 were transferred to the Brightview, LLC 401(k) Plan on February 9, 2023.

### **Contributions**

Prior to February 9, 2023, participants could contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employee were automatically enrolled in the Plan unless they affirmatively elected another contribution election. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. There was also an auto escalation of 1% at the beginning of each plan year up to 10%.

Company matching and profit sharing amounts could be contributed at the discretion of the Company. During the period ended February 9, 2023 and the year ended December 31, 2022, the Company did not elect to make any discretionary matching or profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### **Participant accounts**

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after four years of credited service. Participants became 100% vested in the Company's contribution portion of their accounts in the event of death or total and permanent disability.

**Payment of benefits**

On termination of service due to death, disability, or retirement, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also provides for automatic cash out distributions for terminated participants with account balances of \$500 or less.

**Forfeited accounts**

At February 9, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0-. These accounts could be used to reduce Company contributions. During the period ended February 9, 2023 and the year ended December 31, 2022, forfeitures were not used to reduce contributions.

**2. SUMMARY OF ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements of the plan have been prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits were recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Fees related to participant directed transactions were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through December 31, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at February 9, 2023 and December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**4. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments were managed by T. Rowe Price, the trustee for the year ended December 31, 2022, and the period ended February 9, 2023, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor paid directly any other fees related to the plan's operations.

**5. TAX STATUS:**

The Company adopted a pre-approved plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**6. PLAN AMENDMENT CARES ACT:**

On March 27, 2020, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided temporary relief for retirement plan sponsors and their participants with respect to distributions during 2020. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the plan document.
