Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Data Systems Analysts, Inc. Cash or Deferral Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of the Data Systems Analysts, Inc. Cash or Deferral Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan

General

The Plan is a contributory defined contribution 401(k) plan available to qualifying employees of Data Systems Analysts, Inc. and its subsidiaries (collectively, the Company or Employer). An employee is eligible to participate in the Plan immediately upon the first day of employment and can enter the Plan on the first day of the pay period after employment begins. Leased employees, nonresident aliens with no U.S. source of income, temporary employees and those employees covered under a collective bargaining agreement are excluded from eligibility.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The administrator of the Plan is the Company. Vanguard Fiduciary Trust Company (Vanguard) holds all assets and is the recordkeeper for the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, subject to legal limit of \$23,000 in 2024. The Plan has an automatic enrollment feature for new employees at a rate of 6% of eligible compensation. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment, unless the employee was automatically enrolled within three months of the increase date (January 1st). The Plan allows participants age 50 years and older to make an additional contribution (referred to as employee catch-up contributions), subject to legal limits of \$7,500 in 2024. Participants may contribute amounts representing rollover distributions from other qualified plans, including diversification from the Company's Employee Stock Ownership Plan (ESOP), or conduit Individual Retirement Account subject to certain requirements.

The Company may make a discretionary Employer matching contribution. During 2024, the Company's discretionary matching contribution was 20% of the participants' contributions.

Participants may direct their contributions and investments into various options offered by the Plan.

Diversification is offered to participants in the Company-sponsored ESOP. Those participants who have reached the age of 55 and have at least ten years of service may choose to allocate a certain portion of their ESOP balance into this Plan. Diversification is offered to each eligible participant over a six-year period. Diversifications received by the Plan are shown as contributions on the Statement of Changes in Net Assets Available for Benefits.

Annual additions under the Plan are limited to the lesser of 100% of eligible compensation or other applicable Internal Revenue Code (IRC) limits, established to be \$69,000 for calendar year 2024. Annual additions are defined as employee and employer matching contributions. Contributions to all of the Company's qualified Plans are subject to the annual limitation noted above.

Participant Accounts

Each participant's account is credited with the participant's and the Company's discretionary contributions and an allocation of net Plan earnings or losses. Allocations are based on participant deferrals, earnings or account balances, as defined. Processing fees relating to distributions and loans are charged directly against the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their individual contributions and the allocated earnings thereon. Vesting in the Company's discretionary contribution (employer matching) portion of participants' accounts is based on the following schedule:

If employment is terminated for reasons other than death, disability or retirement, participants are entitled to receive only the portion of their benefit which is vested and the non-vested portion is forfeited.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as specified in the Plan. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the respective participant's account during the prior 12 month period or 50% of their vested account balance. The loans are paid ratably through payroll deductions over a period of five years or less with the exception of loans to purchase a primary residence which may have a longer term. The loans are secured by the balance in the participant's account and bear interest at 1% over the prevailing prime rate at the time of the loan. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC.

Forfeitures

Forfeitures of non-vested participant accounts are used to reduce future employer contributions and to pay administrative expenses of the Plan. Forfeitures outstanding as of December 31, 2024 and 2023 amounted to \$135,829 and \$75,428, respectively. There were no forfeitures used to offset employer contributions or pay administrative expenses during 2024.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the amounts reported of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by the Company or the Plan, as provided by the Plan's service agreements. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in

administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used or transfers between levels at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - Valued at the daily closing price as reported by the fund.

Collective Investment Trust (CIT) - The Putnam Stable Value Fund is a common investment trust composed primarily of fully benefit-responsive investment contracts. The Stable Value Fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest and Related Party Transactions

The Plan invests in various investments managed by Vanguard or its subsidiaries and affiliates, therefore, these transactions qualify as party-in-interest. Participant loan and distribution processing fees are paid to Vanguard by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although the Company has not expressed any intention to do so, it has the right under the Plan to discontinue its contributions at any time and to amend or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

7. Tax Status

The Plan uses a Nonstandardized Profit Sharing/401(k) Plan (Pre-approved Plan) sponsored by The Vanguard Group. The Internal Revenue Service (IRS) has determined and informed The Vanguard Group by an opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal, state and/or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
