Basis for Opinion

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Publicis Benefits Connection 401(k) Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the Plan document and summary Plan description for more complete details on the Plan's provisions.

General

In January 2000, Leo Burnett U.S.A. Inc. and MacManus Group, Inc. merged to form Bcom3 Group, Inc. (Bcom3). Effective December 31, 2001, the Burnett Profit Sharing Plan merged into the MacManus Group Inc. 401(k) Plan, and sponsorship of the merged plan transferred to Bcom3 Management Corp. The merged plan was amended and restated as the Bcom3 401(k) Plan, effective January 1, 2002. On July 1, 2004, Plan sponsorship transferred to MMS USA Holdings, Inc. (formerly known as Philadelphia Merger Corp.; the Company). Effective January 1, 2005, the Company became the Plan Sponsor when the 401(k) plans of the 12 subsidiaries, including Bcom3, merged with the Bcom3 401(k) Plan. As a result, the Bcom3 401(k) Plan was amended and restated as the Plan.

The Freud and Williams-Labadie plans merged into the Plan, effective June 17, 2009, and April 1, 2009, respectively. Effective December 31, 2008, Bromley Communications spun off from the Plan. The 401(k) plans formerly acquired by the Companies of Act Now, Resolute, and Razorfish merged into the Plan, effective December 31, 2011. Effective April 1, 2011, the Amazon Advertising LLC 401(k) Profit Sharing Plan and Trust merged into the Plan as a result of a corporate transaction.

Effective December 15, 2011, the Big Fuel Communication, LLC 401(k) Plan (Big Fuel Plan) was frozen, where Big Fuel Communication, LLC is a member of the Publicis Groupe controlled group. Effective January 1, 2012, the Big Fuel Plan merged into the Plan.

Effective December 31, 2011, the Schwartz Communications, Inc. 401(k) Retirement Plan (Schwartz Plan) was frozen, where Schwartz MSL LLC is a member of the Publicis Groupe controlled group. Effective January 1, 2012, the Schwartz Plan merged into the Plan.

Effective June 30, 2012, the Rosetta Marketing Group, LLC East 401(k) Plan (Rosetta Plan) was frozen, where Rosetta Marketing Group, LLC is a member of the Publicis Groupe controlled group. Effective July 1, 2012, the Rosetta Plan merged into the Plan.

Effective June 30, 2012, the LEVEL Studios, LLC 401(k) Plan (LEVEL Plan) was frozen, where LEVEL Studios, LLC is a member of the Publicis Groupe controlled group. Effective July 1, 2012, the LEVEL Plan merged into the Plan.

General *(continued)*

Effective December 31, 2012, the Bartle Bogle Hegarty Profit Sharing 401(k) Plan (BBH Plan) was frozen, where Bartle Bogle Hegarty is a member of the Publicis Groupe controlled group. Effective December 31, 2012, the BBH Plan merged into the Plan.

Effective December 31, 2012, the AR Media, Inc. 401(k) Profit Sharing Plan (AR Plan) was frozen, where AR Media, Inc. became a member of the Publicis Groupe controlled group. Effective January 1, 2013, the AR Plan merged into the Plan.

Effective December 30, 2016, the Sapient Corporation 401(k) Plan, which is a part of the Publicis Groupe controlled group with the Plan Sponsor, merged into the Plan.

Effective October 13, 2017, any employee of Sapient Corporation who is an employee as a result of an assignment from a foreign affiliate, even if on the United States payroll, is not eligible to participate in the Plan.

The Plan, as amended, is a participant-directed, defined-contribution plan with elective employee participation on a pretax basis under Section 401(k) of the Internal Revenue Code (the Code). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers all employees of the Company and its subsidiaries in the United States. The Plan's Administrative Committee is responsible for the Plan's general administration. Fidelity Management Trust Company (the Trustee) is the trustee of the Plan, with Fidelity Institutional Retirement Services Company as the record-keeper for the Plan.

Contributions

The Plan allows participants to make contributions via payroll deductions. Non-highly compensated employees may elect to make contributions from 0% up to 50% of the participant's compensation to the Plan, and highly compensated employees may elect to make contributions from 0% up to 15% of the participant's compensation to the Plan. Both contributions are subject to the Internal Revenue Service (IRS) maximum limitation, which was \$23,000 in 2024 and \$22,500 in 2023. The Plan also permits "catch-up" contributions for participants who are age 50 or older.

The Company provides matching contributions on behalf of each participant equal to 100% of the first 3% of compensation that a participant contributes as an elective pretax contribution and 50% of the next 2% of compensation that a participant contributes as an elective pretax contribution. The total matching contribution for a participant should not exceed 4% of his or her compensation for the Plan year.

Contributions *(continued)*

In addition, the Company's Board of Directors may determine by resolution to contribute to the Plan. Any such resolution will specify the amount of the contribution or a definite basis or formula by which the contribution can be determined with respect to each employee. Such employer discretionary contribution, if any, will be made solely at the discretion of the Company. There were no discretionary contributions made in 2024 and 2023 by the Company.

Participant Accounts

Each participant's account is credited with his or her contributions, the Company's matching contributions, and allocations of Plan earnings, which include a charge for the allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of creditable service. A participant is 100% vested after four years of creditable service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participant's non-vested accounts are used to reduce future Company contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023, were \$10,848,512 and \$6,915,171, respectively, and forfeitures used to reduce Company contributions were \$10,473,788 for 2024 and \$9,192,690 for 2023.

Participant Loans

Active participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000, or 50%, of their account balance, whichever is less. The interest rate is based on the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years.

Payment of Benefits

Upon separation of service from the Company because of death, disability, retirement, or termination, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, rollover their vested balance into an individual retirement account or qualified employer plan or leave the money in the Plan until a later date.

Hardship Withdrawals

Hardship withdrawals from the Plan are available for participants who can demonstrate an immediate financial need as set forth in the Plan document. The withdrawal must be a minimum of \$1,000 and only one hardship withdrawal may be made during any 12-month period. Rollover contributions must be accessed first according to the order set forth in the Plan document.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided in the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and Trustee fees. Expenses related to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. The Company pays for all other administrative expenses of the Plan.

Plan Termination

The Company anticipates the Plan to continue without interruption, but it reserves the right to terminate or freeze the Plan at any time. In the event that this occurs, all amounts not yet allocated to participants' accounts will be allocated in accordance with the provisions of the Plan. The resultant participants' accounts then become fully vested. Should the Plan terminate, its assets will be completely distributed. If the Plan is frozen, the assets will be retained by the Plan for distribution at such time and in such manner as provided in the Plan document.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. Deemed distributions for the years ended December 31, 2024 and 2023, were \$588,293 and \$650,656, respectively.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (*i.e.*, an exit price). See Note 4 for further discussion and disclosures of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (Codification or ASC) 820, *Fair Value Measurements and Disclosures*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

Level 1: Based on unadjusted quoted prices for identical assets in an active market that the Plan may access at the measurement date.

Level 2: Based on quoted prices in inactive markets, quoted prices for similar assets and liabilities in active markets, and observable inputs for the assets or liabilities, either directly or indirectly, for substantially the full term of the asset or liability.

Investment Valuation and Income Recognition *(continued)*

Level 3: Based on prices or valuation techniques that require unobservable inputs that are significant to the fair value measurement. These inputs reflect management's judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

NOTE 3 INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (*i.e.*, an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets;

Level 2: *(continued)*

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for the asset or liability (*i.e.*, supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used for fair value measurements at December 31, 2024 and 2023. The valuation methodologies used for assets at fair value are described below.

Mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

Self-directed brokerage accounts consist primarily of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Common/collective trust fund is valued at the NAV practical expedient per unit held by the Plan at year end as reported by the respective funds.

The preceding methods may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant-directed redemptions have no restrictions; however, withdrawals initiated by a Plan Sponsor will normally be provided at contract value as soon as practicable within 12 months following written notice to the Trustee. The fair values of these funds have been estimated using NAV per share, as a practical expedient. NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term.

The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 RELATED-PARTY TRANSACTIONS

The Plan holds units of common/collective trust funds and mutual funds managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. During 2024 and 2023, fees paid by the Plan for Trustee fees amounted to \$1,546,659 and \$1,656,595, respectively.

NOTE 7 TAX STATUS

The Plan has been amended and restated, effective January 1, 2015, and has received a new determination letter from the IRS, dated January 2, 2016, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires the Plan's management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain tax positions taken or are expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes the Plan is no longer subject to income tax examinations for years prior to 2021.
