**NOTE A - DESCRIPTION OF PLAN**

The following description of the Children's Crisis Treatment Center Health & Welfare Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan covers all full-time or part-time employees, who regularly work 22.5 or more hours of service per week, of Children's Crisis Treatment Center (the "Company") and their eligible dependents, once the employee completes a 60-day waiting period from their first day of employment. In 2020, the Plan sponsor contracted with Veris Benefits Consortium to self-fund medical insurance benefits. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

**Bank Overdraft**

There was a bank overdraft at 6/30/2025 of (\$44,161) due to timing of a stop loss reimbursement deposit. Benecon, the TPA recorded the stop loss reimbursement deposit of \$45,000 as of 6/30/2025 in the Plan's general ledger. However, the deposit was posted by UMB bank on 7/1/2025; the deposit brought the cash account to a positive balance.

**Benefits**

The Plan provides medical, dental, vision, life insurance, accidental death and dismemberment, short- and long-term disability benefits to the full-time or part-time employees and their eligible dependents.

**Self-Insured Benefits**

The Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Contributions**

The Company and the participants' share the premiums for the self-funded medical insurance with the participants contributing based on bi-weekly payroll deductions in accordance with the provisions of the plan. The Company and the participants share the premiums for the vision, dental, short-term disability, long-term disability, AD&D, and life insurance benefits available in the plan with the participant contributing based on bi-weekly payroll deductions in accordance with the provisions of the plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and non-discriminating manner towards the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Investments are reported at fair value. Contributions are recorded when received and are not accrued. Accordingly, the accompanying financial statements are not intended to present net assets (deficit) available for benefits and changes in net assets (deficit) available for benefits in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; claims incurred but not reported; and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Concentration of Credit Risk**

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash deposits. Accounts at each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At June 30, 2025, the Plan had no amounts in excess of federally insured amounts. Cash amounts not covered by the FDIC may be covered by the Plan's Fidelity Bond insurance. Plan Management does not believe this has a material impact on the financial statements.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Tax Status**

The trust established under the Plan to hold the Plan's assets is not qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is not exempt from income taxes. The Plan did not make any income tax payments for the year ended June 30, 2025, and as such, no provision was recorded for income taxes paid. Income taxes are recorded when paid.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Payment of Benefits**

Claims and premiums are reported when paid. Premiums paid by either the Company or the trust are recorded as premium payments and self-insured benefits paid in the accompanying statement of changes in net assets available for benefits--modified cash basis.

**Stop Loss**

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in premium payments for healthcare and insurance in the accompanying statement of changes in net assets (deficit) available for benefits--modified cash basis. During the year ended June 30, 2025, stop loss reimbursements netted against claim payments to healthcare providers on the statement of changes in net assets (deficit)--modified cash basis were \$786,327.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan Sponsor by making a contribution to the plan's trust account. Veris Benefit Consortium provides an invoice for the administrative expenses due each month. The contribution receipt and the payment of the administrative expenses is recorded in plan's trust activity.

**Cash and Cash Equivalents**

Cash included currency on hand, demand deposits, and highly liquid investments purchased with financial institutions with a maturity of three months or less.

**Date of Management's Review**

Management has evaluated subsequent events through December 19, 2025, the date which the financial statements were available to be issued.
