## Independent Auditors' Report

To the Plan Administrator and Trustees of the  
AVORS Medical Group 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the AVORS Medical Group 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The following description of the AVORS Medical Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by AVORS Medical Group (the Plan Sponsor, Employer, and Company) under the provisions of Section 401(a) of the United States Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

The following adopting employers are allowed to participate in the Plan:

- Alpha Revenue Management Cycle LLC
- United Specialist LP
- FamilyFirst Family Medical Practice Inc.
- Alon Antebi, D.O., Inc.
- Thomas Nasser, D.O., Inc. dba A V Rehab Specialists LLC
- Nasser Family Medical Corp
- TSN Business Management LLC

All employees of the Company and adopting employers are subject to the following eligibility requirements:

- Age: 21
- Service: 1 year and 1000 hours
- Status Exclusions:
  - a. Members of collective bargaining agreement
  - b. Non-resident aliens with no U.S. earned income
  - c. Leased employees

Upon satisfying the eligibility requirements, employees may participate in the Plan on the first day of the plan year or the first day of the 7th month of the plan year.

#### Contributions

The Plan is funded through employee elective deferrals and Company contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or “rollover” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

### Note 1 – Description of Plan (Continued)

#### Contributions (Continued)

The following contribution types are allowed by the Plan:

- Elective deferrals
- Roth deferrals
- Rollover contributions
- Employer profit sharing
- Employer safe harbor
- Employer matching

The Plan has an automatic enrollment provision of three percent salary deferral whereby employees must elect out of the Plan if they do not wish to participate.

The Plan is considered a safe harbor plan in which all eligible employees are credited with three percent of eligible compensation. During the year ended December 31, 2024, the Company elected to make \$105,106 in safe harbor contributions to the Plan.

The Company may make discretionary employer matching contributions not to exceed four percent of employee compensation. For the year ended December 31, 2024, the Company elected not to make any employer matching contributions.

The Company may make discretionary profit sharing contributions to the Plan. The Company may establish various classifications of employees and in doing so, may contribute a different percentage of compensation to each classification of employees. The Company's practice has been to make profit sharing contributions to each non-highly compensated employee in an amount that is sufficient for the Plan to pass its annual compliance testing when combined with the compliance testing of the Company's cash balance plan. The Company's cash balance plan was terminated effective June, 15 2024. During the year ended December 31, 2024, the Company elected to make \$95,381 in profit sharing contributions to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100 percent vested in their elective deferrals including catch-up contributions and rollover contributions from other plans, as well as Company safe harbor contributions, and actual earnings thereon. The method for crediting vesting service for Company matching and profit sharing contributions is based on vesting years of service. Participants are credited with a year of vesting service for each Plan year in which the participant performs 1,000 or more hours of service. If participants are employed on or after their Normal Retirement Age or if they terminate employment on account of death or disability, they are 100 percent vested in their Company matching and profit sharing contributions.

#### Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested Company contributions to be used as follows:

- Reallocated as Company contributions
- Reduce Company contributions
- Pay administrative expenses

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,998 and \$35,223, respectively. During the year ended December 31, 2024, \$83,561 of forfeited non-vested accounts were used to pay plan expenses.

#### Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

#### Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- Hardship
- Involuntary cash-outs
- In service
- Rollover source withdrawal at any time

#### Plan Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments. Third party administrator and auditor fees are paid by the Plan.

#### Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100 percent vested. The Company will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

### Note 2 – Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of these financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of net assets available for benefits, net appreciation in fair value of investments, as well as the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Accounting principles generally accepted in the United States of America requires investment contracts held by a defined contribution plan to be reported at contract value for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

#### Contributions

Contributions from Plan participants are recognized in the year in which the participant contributions are withheld from compensation. Employer contributions are recognized in the same period as the related participant contributions.

#### Payment of Benefits

Benefits are recorded when paid.

#### Subsequent Events

Plan management has considered events occurring through December 29, 2025 in its evaluation of the conditions on which estimates were based or for changes in conditions subsequent to the date of the statement of net assets available for benefits, which should be disclosed. The financial statements were available to be issued at this date.

### Note 3 – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), the custodian of the Plan.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### Note 4 – Fair Value Measurements (Continued)

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Collective Investment Trust Funds:* Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

*Mutual Funds:* Valued at the NAV of shares held by the Plan at year end based on quoted market prices.

### Note 5 – Stable Value Fund (Unaudited)

The Plan has a group annuity contract with The Standard Insurance Company (the Standard). Through the group annuity contract participants may invest in The Standard Stable Asset Fund (the Stable Value Fund). The Standard invests the deposits received from plan participants as part of its general account assets, which include its fixed income securities portfolio and its commercial mortgage loan portfolio. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the group annuity contract. The crediting rate for the Stable Value Fund is based on the group annuity contract but may not be less than 1.00. The credit rate is expressed as an annual rate, which is determined daily and compounded quarterly.

Because the Stable Value Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Stable Value Fund, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investments in the Stable Value Fund.

### Note 5 – Stable Value Fund (Unaudited) (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The Plan's contract specifies certain conditions under which distributions from the contract may be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. Currently, management believes it is improbable that an event will occur which would cause the Plan to transact contract distributions at less than contract value.

The Standard may terminate the contract if it has determined that certain circumstances that The Standard deems reasonable cause for termination have occurred. Such circumstances include the Plan not abiding by state and federal law, not complying with the terms of the contract, the balance of the investment funds falling below \$25,000, the IRS disqualifying the Plan, or if the Plan has not been adopted within a reasonable time. Payment of the balance in the investment contracts may differ from contract value if the contract holder elects to receive the contract owners account balance using a market value lump sum calculation.

The contract value of the Stable Value Fund is listed on the statement of net assets available for benefits.

### Note 6 – Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

The excess contributions as of December 31, 2024 were distributed by the Plan to the applicable participants on October 29, 2025.

### Note 7 – Prohibited Transactions

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$33,105, all of which represented employee salary deferrals that were not remitted timely. These contributions are considered prohibited transactions.

### Note 8 – Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024, the Plan made direct payments of \$100,466 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 10 – Tax Status**

The Plan sponsor adopted a plan which received a favorable determination letter, issued to the document provider, from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
