Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. DESCRIPTION OF THE PLAN

OPTO 22 Money Purchase Pension Plan and Trust (the “Plan”) is sponsored by OPTO 22 (the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a money purchase pension plan covering all eligible employees of the Company and was established in 1983. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the provisions of the Internal Revenue Code Section 401(a) (the “Code”). The Plan does not allow participant loans, hardship withdrawals, participant rollovers or other participant contributions.

Eligibility

All employees of the Company, that are not a member of a collective bargaining unit, are eligible to participate in the Plan when they have completed six months of service within the Plan year (must be hired on or before December 1 to participate in the Plan year beginning the following June 1).

Contributions

The Company makes annual contributions of 8% of eligible compensation, subject to certain statutory limits. To receive a contribution, a participant must be employed on the last day of the Plan year (May 31) and have completed at least 1,000 hours of service during the Plan year. Eligible compensation is compensation for the calendar year ending within the Plan year or, for participants’ first year in the Plan, compensation for the period from June 1 to December 31 of the current Plan year.

The Company’s fiscal year ends December 31, and it funds the Plan contribution before May 31 of the following year. As the Plan has an ‘employed on the last day’ requirement, the contribution allocation is finalized immediately following May 31. The previously-funded contribution is held in an income-earning unallocated account until the actual allocations are made. The earnings during this period are used to offset future Plan administrative expenses and/or Company contributions. Funded contributions relating to employees who terminate prior to May 31 remain in the Plan and are treated as unallocated assets and may be used to offset future Plan administrative expenses and/or Company contributions.

Participant Accounts

Separate participant-directed accounts are maintained within the Plan for each participant.

Investment Options

Participants may choose to direct the investment of their accounts among various investment options available.

Vesting

All amounts in a participant's account will be 100% vested upon reaching normal retirement age prior to termination of employment, and also upon disability or death prior to termination of employment. Vesting prior to retirement or disability is as follows:

Forfeitures

Terminated participants' non-vested amounts and earnings thereon are retained in an unallocated account to offset future Plan administrative expenses and/or Company contributions. During the years May 31, 2025 and 2024, the amounts forfeited were \$5,560 and \$21,373, respectively. Forfeitures of \$21,408 and \$21,438 were used to reduce the Company's contributions and pay certain plan expenses in the years May 31, 2025 and 2024, respectively. The forfeiture account had a balance of \$5,642 and \$21,402 as of May 31, 2025 and 2024, respectively.

Payment of Benefits

Upon termination of service, for their vested portion, participants may leave their money in the Plan (subject to IRS minimum-distribution rules and small balances the Plan administrator can distribute in a lump sum), receive a lump sum payout, purchase annuities, receive a direct rollover, or some combination of these choices.

Administrative Expenses

Trustee and fund management expenses are paid with Plan assets, including as direct assessments on participant investment accounts. Certain administrative services are performed by employees of the Company at no charge to the Plan, and certain Plan expenses are paid by the Company and/or using funds in the unallocated or forfeiture accounts.

Note 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan maintains its books and financial records using the modified cash basis of accounting. Under this method, contributions and revenues are recognized when received rather than when earned, and expenses are recorded when paid rather than when incurred. Additionally under this method, investments are reflected at their estimated fair value.

Investment Valuation

Investments are stated at fair value as provided by the Trustees. Investments in registered investment companies are valued using quoted market prices. Investments in common/collective trusts (i.e. investment contracts) are stated at fair value based on the net asset value of shares held by the Plan at year end.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements as well as the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Note 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Fair values are based on publicly quoted prices in active markets for identical assets or liabilities. The fair value of investments in registered investment companies is based on the publicly quoted net asset value of the shares held by the Plan at year-end. The fair value of investments in shares of common/collective trust is based on net asset value per unit.

Level 2 Fair Value Measurements

Fair values are based on observable inputs other than publicly quoted prices in active markets for identical assets.

Level 3 Fair Value Measurements

Fair values are based on unobservable inputs used for valuing the asset.

Note 4. INVESTMENTS

All funds allocated to participants are participant-directed. Unallocated funds, held in the Galliard Stable Return Fund at May 31, 2025, aggregated \$744,124, of which \$730,509 represents the Company contribution made during the fiscal year, net of certain expenses and other transactions. Unallocated funds, held in the Galliard Stable Return Fund at May 31, 2024, aggregated \$700,564, of which \$691,418 represents the Company contribution made during the fiscal year, net of certain expenses and other transactions. Of these amounts, \$738,527 and \$714,035 were allocated to participant accounts in the days immediately following May 31, 2025 and 2024, respectively, in accordance with the Plan document. Earnings from unallocated funds included in the net realized and unrealized gain in fair value of common/collective trust are insignificant.

Note 6. PLAN TERMINATION

The Company anticipates that the Plan will continue without interruption but reserves the right to amend or discontinue the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the account of each participant would be fully vested.

Note 7. TAX STATUS

The Plan is operated pursuant to a volume submitter plan that is intended to be a qualified pension plan under the provisions of IRC Section 401(a) and Section 501(a).

Effective June 1, 2022, the Plan was amended and restated to comply with the Internal Revenue Service's (the "IRS") every-six year restatement requirement. The IRS has determined and informed the Plan administrator by a letter dated June 30, 2020 (for the prototype plan effective June 1, 2022), that the volume submitter plan has met the requirements of the applicable sections of the Code and thus is exempt from federal income taxes. Although the Plan has been amended since receipt of the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt. No provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to the Plan year ended May 31, 2022.

Note 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. PARTY-IN-INTEREST

Trustee fees are paid with assets of the Plan. Principal Trust Company is the Plan recordkeeper and manages certain investments for the Plan for the Plan years ended May 31, 2025 and 2024. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. To the extent the Plan invests in funds managed by the trustee or their affiliates, such transactions qualify as party-in-interest transactions permitted under ERISA.

Certain administrative services are performed by employees of the Company at no charge to the Plan.

Note 10. SUBSEQUENT EVENTS

Management has evaluated subsequent events for accrual and disclosure through December 12, 2025, which is the date the May 31, 2025 financial statements were available to be issued.
