1. DESCRIPTION OF PLAN:

The following description of the G. A. Wintzer & Son Company Health and Welfare Benefits Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan agreement for a more complete description of Plan provisions.

General

The Plan provides health and other benefits to eligible employees, eligible retirees, and eligible dependents (as defined by the Plan) of G. A. Wintzer & Son Company (the Company or Employer). Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, management elected to draw down the funds of the trust used to fund certain benefits and terminate the trust. Following the termination of the trust, the Plan continued providing benefits and the Employer began funding all Plan benefits outside of a trust.

Effective January 1, 2025, the Plan was amended to no longer provide medical benefits for post retirees. Plan management implemented health reimbursement accounts for all retirees that are funded at the discretion of the Employer.

Benefits

The Plan provides for fully insured life insurance, accidental death, disability and long-term disability, dental, vision, and certain other benefits. The Company purchases annual insurance contracts for these insured benefits.

Medical and prescription benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Board of trustees has the right under the Plan to modify the benefits provided to active and retired members.

Contributions

The Company makes contributions to the Plan as necessary to pay claims, insurance premiums, and related claims administration expenses to the extent they are not paid by the participant contributions.

Participants contribute specified amounts to obtain elected coverages. Participant contributions are used directly to purchase coverage.

Medicare Subsidy

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy.

Stop-loss

The Plan maintains a stop-loss insurance policy for medical and prescription claims in excess of \$45,000 per year per subscriber in an effort to limit its exposure for self-insured benefits. The amount of stop-loss reimbursements netted against medical expenses for the years ended December 31, 2024 and 2023 totaled \$308,791 and \$159,932, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Changes in circumstances could cause actual results to differ materially from those estimates.

The amounts reported for estimated health claims incurred but not reported and postretirement benefit obligations are subject to significant fluctuation due to various factors, including participants' claim experience, actuarial assumptions used and changes in the health care cost trend rate. Due to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Investment valuations and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan benefits

Benefits are recorded when paid. The obligation for claims payable and estimated health claims incurred but not reported is based on the amount of claims processed and paid by a third-party administrator before December 31 that were reimbursed by the Plan to the administrator subsequent to year end plus an estimate of claims incurred but not reported by the Plan's management.

As of December 31, 2023, the obligation for postretirement benefits is estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party administrator. As discussed in Note 1, postretirement benefits are no longer offered after December 31, 2024.

Administrative expenses

Certain administrative and legal fees of the Plan are paid by the Employer on behalf of the Plan and are excluded from these financial statements.

Subsequent event

The Plan has evaluated subsequent events through January 5, 2026, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market fund: Equivalent to cash and valued at \$1 per share, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. POSTRETIREMENT BENEFIT OBLIGATIONS:

As of December 31, 2023, a postretirement benefit obligation has been recognized for retiree medical and dental benefits. The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to participants' service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and from existing plan assets, net of participant contributions. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service for the Company rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary using the projected unit credit method and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those from death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Plan obligations at December 31, for health claims incurred by active participants but not reported at that date, for accumulated eligibility of participants, and for future disability payments to participants considered permanently disabled at December 31 are estimated by the Plan's management in accordance with accepted actuarial principles. Health claims incurred by retired participants but not reported at year end are included in the post-retirement benefit obligation.

For measurement purposes, the health care cost trend rate assumed for the next year was 7.50% for pre-Medicare and 6.75% for Medicare at December 31, 2023. These rates are assumed to decrease by 0.25% and 0.25% in 2024 and beyond, respectively.

During 2023, health care cost-sharing for salaried retirees under age 65 was \$16 per week for retiree plus one; there was no cost for retiree only. Health care cost-sharing for salaried retirees over age 65 was \$77.29 per month for the year ended December 31, 2023.

The following were other significant assumptions used in the valuation as December 31, 2024 and 2023:

- Discount rate – 5.70% for 2023.
- Retirement Age – 80% are assumed to retire at age 62, 10% at age 63, 10% at age 64, and 100% at age 65.
- Mortality – Pri-2012 Headcount-Weighted Healthy Mortality Table (base year 2012) with Fully Generational Projection using Scale MP-2021. Contingent Survivor Pri-2012 Headcount-Weighted Mortality Table (base year 2012) with Fully Generational Projection using Scale MP-2021.

The health care cost trend rate assumption has a significant effect on the postretirement benefit obligations reported. If assumed rates increased by one percentage point in each year the obligation at December 31, 2023 would be \$11,817,959.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

5. INCOME TAXES:

The Trust established under the Plan to hold the Plan's assets had applied for exemption from income taxes but had not received the exemption notice prior to termination of the Trust. The Trustees believe that the Trust does not have any net taxable income for the years ended December 31, 2023 or 2024, respectively, for which they would owe income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believe that the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

6. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Company has the right to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the trustee shall apply the net assets to pay any and all obligations of the Plan and the remainder, if any, will be used to provide benefits under the terms of the Plan until all funds are exhausted.

7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

As noted in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

8. RISKS AND UNCERTAINTIES:

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
