Opinion

We have audited the accompanying financial statements of Systems Connection of Maryland, Inc. Notes to Financial Statements

-
1. **Description of the Plan** The following description of the Systems Connection of Maryland, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Systems Connection of Maryland, Inc. (the "Company"), who have reached age 21 and completed one year of service except for employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. Employees may enter the Plan on the January 1 or July 1 coincident with or following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is designed to qualify under Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("IRC"). In 1997 and 1998, the Company contributed a total of 2,438.8 treasury shares to the Plan. In 2001, an additional 125 shares were purchased from a related party. Participants are entitled to direct the voting of any voting shares of Company stock allocated to their accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation. In all other instances, all Company stock held by the Plan shall be voted by the Plan trustees.

Contributions: Employer discretionary contributions to the Plan are determined annually by the Company. Participants must be employed on the last day of the Plan year and have at least 1,000 hours of service in the Plan year to receive an allocation of the discretionary employer contributions. The allocation requirements are waived for those participants that terminate due to retirement, disability, or death. For the year ended December 31, 2024, there were no discretionary contributions made to the Plan. Contributions are subject to certain limitations.

Systems Connection of Maryland, Inc. Employee Stock Ownership Plan

Notes to Financial Statements

Participant accounts: Each participant's account consists of two sub accounts: (1) a Company Stock account, which reflects the number of shares of Company stock credited on his or her behalf; and (2) an Other Investments account, which reflects the participant's share of Plan assets invested in other than Company stock. Each participant's account is credited with an allocation of (1) Company contributions, if any; (2) plan earnings, net of administrative expenses, and (3) forfeitures of terminated participants' non-vested accounts. Allocations of employer contributions and forfeitures are based on participant compensation, as defined by the Plan. Allocation of plan earnings is based upon the beginning Other Investments account balance of each participant less any distribution from such account.

Payment of benefits: Benefits are payable upon the later of retirement at age 65 or five years of participation, disability, death, or termination of employment. The Plan permits in-service and hardship distributions as described in the plan document. Benefits are payable in a single lump sum.

At December 31, 2024 and 2023, taxes withheld from benefit payments but not yet remitted to taxing authorities are reported as withholding taxes payable in the Statements of Net Assets Available for Benefits.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year the participant may diversify up to 50%. Participants who elect to diversify may have their benefits paid to them in cash or transferred to another qualified plan of the Company.

Vesting: Vesting in contributions is based upon years of service. A participant is fully vested upon completion of three years of service. Additionally, a participant becomes fully vested upon reaching normal retirement age of 65 with at least five years of participation, death or full and permanent disability. Participants who terminate employment for any other reason with fewer than three years of service are 0% vested.

Forfeitures: Forfeitures of terminated non-vested account balances are allocated to participants as of the last day of the Plan year. For the year ended December 31, 2024, there were no amounts allocated to participants from forfeitures.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits: Benefits are recorded when paid.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses: The Company pays a significant portion of the administrative expenses of the Plan.

Cash - non interest bearing: Cash consists of readily liquid assets and investments with initial maturities of ninety days or less. The Plan maintains cash balances that may exceed the FDIC insured deposit limit of \$250,000 per financial institution. At December 31, 2024 and 2023, the Plan's cash balance did not exceed the FDIC limit. The Plan sponsor has not experienced any losses through the date when the financial statements were available to be issued.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through December 22, 2025, which is the date the financial statements were available to be issued.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest bearing cash is reported at cost, which approximates fair value.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The Plan's investment in shares of the Company's common stock is considered a level 3 investment and reported at its fair value as determined by an independent appraiser retained for the purpose by the Plan's trustees. The independent fair value appraisal is dependent upon historical and forecasted operations of the Company as represented by management, and general industry and market conditions affecting the Company's business. The fair value appraisal was determined using the income approach and cost approach. Within the income approach the capitalized cash flow method was used. Within the cost approach the excess earnings method was used. At December 31, 2024 and 2023, the fair value of the Company's common stock was determined to be \$1,161 per share and \$280 per share, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
6. **Risks and uncertainties** The Plan provides for investments in securities that are exposed to Company specific and general economic risks, such as interest rate, credit, and market risks. In addition, the Company stock value is determined using valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with investment securities, and to uncertainties in estimates and assumptions, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
7. **Tax status** The Plan has not obtained a determination letter from the Internal Revenue Service (“IRS”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
8. **Related party and party-in-interest transactions** The Plan invests in Company common stock. As discussed in Note 2, the Company pays a significant portion of Plan expenses. Investment management fees are paid to SEI Private Trust Company by the Plan. During December 2024, the Company advanced the Plan the necessary amount to fund distributions which was repaid in full during January 2025. The amount is reported as Due to Plan sponsor on the Statements of Net Assets Available for Benefits at December 31, 2024. These are related party and party-in-interest transactions.
