### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Pyrotek, Inc. 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of the Pyrotek, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted May 1, 2001 by Pyrotek, Inc. (the Company), and the Company is the sponsor of the Plan. The Plan was most recently restated effective July 1, 2022. The Plan is a 401(k) salary deferral and profit-sharing plan covering substantially all employees of the Company as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The Trustee and recordkeeper of the Plan is Principal Trust Company (the Trustee) and its affiliates. The administrator of the Plan is the Company. The Trustee and its affiliates hold all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees whose benefits are covered under a collective bargaining agreement, residents of Puerto Rico, nonresident aliens without U.S. income, leased employees and independent contractors are excluded from participating in the Plan. All other employees of the Company are eligible to participate in the Plan after completing three months of service within a 12-month period. Any participants active during the Plan year are eligible for employer matching contributions.

#### *Contributions*

Participants may elect to contribute up to 60% of eligible compensation to the Plan each year, up to the maximum allowable under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who are projected to be age 50 or older at the end of the Plan year may also make a catch-up contribution, subject to IRC limits. Unless a participant elects a specific deferral percentage, they are automatically enrolled to defer 3% of eligible compensation, which will increase each year by 1% up to a maximum 8%.

The Plan allows for a nondiscretionary matching contribution in an amount equal to 100% of elective deferral contributions that are not over 1% of eligible compensation, plus 50% of elective deferral contributions that are over 1% of eligible compensation but are not over 6% of eligible compensation. During the Plan year ended June 30, 2025, the Company made nondiscretionary matching contributions of \$1,788,690, net of forfeitures. The Plan also allows for an employer discretionary matching contribution. During the Plan year ended June 30, 2025, the Plan sponsor did not elect to make employer discretionary contributions.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### *Vesting*

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in employer contributions is based on years of service as follows:

### *Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account balance, or annual, quarterly, or monthly installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant whose vested account balance exceeds \$7,000 at the time of termination of employment is entitled to leave their account in the Plan. An involuntary distribution of a terminated or retired participant's account balance occurs when their balance is \$7,000 or less.

### *Forfeitures*

Forfeited balances of terminated participants' non-vested accounts are retained in the Plan and may be used to pay administrative expenses under the Plan, as directed by the Company, or may be used to reduce future employer contributions payable under the Plan. As of June 30, 2025 and 2024, forfeited non-vested accounts totaled \$40,755 and \$66,214, respectively. For the year ended June 30, 2025, forfeitures were used to reduce employer contributions in the amount of \$67,196.

### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance of the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan Administrator. The maximum note term is five years unless the note is for the purchase of a principal residence, in which the repayment period must be within a reasonable time consistent with loan

practices for residential loans. Each participant may be granted one loan during any one-year period and participants may not have more than one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions.

### **2. Summary of Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses of the Plan are deducted from net assets, including expenses associated with recordkeeping, participant website access, participant statements, Plan compliance services, and financial professional services. Expenses that are paid by the Company are excluded from these

financial statements. Certain fees for participant directed transactions are paid by participants and charged directly to the participant's account, including distribution fees, loan set-up fees and a portion of Plan level administrative expenses.

### **Revenue Credits**

The Plan's trust agreement with Principal Trust Company provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. There were no unallocated revenue credits as of June 30, 2025, and 2024. During the year ended June 30, 2025, the Plan received credits of \$23,562 which was allocated to participants. Revenue credits are presented in other income in the statement of changes in net assets available for benefits.

### **3. Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June, 2025 or 2024. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds (Registered Investment Companies)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts* - Valued at the NAV of units of pooled separate account. The NAV is the basis for current transactions and the pooled separate account (PSA) can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP in accordance with investment company measurement principles. The NAV of a PSA is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. There are no unfunded commitments or redemption restrictions associated with these PSAs. As such, the PSAs are determined to have a "Readily Determinable Fair Value" and classified within Level 1 of the valuation hierarchy.

*Common Collective Investment Trusts* - Valued at the NAV of units of the collective trust fund. The Plan owns and transacts at units of a common collective investment trust (CIT), not the underlying assets; and therefore, the unit of account would be at the fund level, not at the underlying investments level. The NAV is not a publicly quoted price in an active market but is available to current investors via the Employer website or when plan participants access their account values.

The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date for all funds. Therefore, the CITs have a "Readily Determinable Fair Value". The NAV is calculated in a manner consistent with GAAP in accordance with investment company measurement principles. As such, the CITs are valued similar to mutual funds, aside from the Stable Value Fund, and classified within Level 1 of the valuation hierarchy.

The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of the common collective investment trusts are calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. There are no unfunded commitments or redemption

restrictions associated with these common collective investment trusts, except as described in the following paragraphs for the Stable Value Fund.

*Common Collective Investment Trust- Stable Value Fund* - The Plan has investments in the Principal Stable Value Fund (the Fund), which is a collective investment trust that invests mainly in conventional, synthetic, and separate account investment contracts issued by life insurance companies, banks, and other financial institutions. The Fund holds guaranteed investment contracts, which typically have a fixed maturity. Each contract contains a provision the issuer will, if required, repay principal at the stated contract value for the purpose of paying benefit payments (fully benefit-responsive). Withdrawals from the Fund for benefit payments and participant transfers to noncompeting options shall be made as soon as practicable after written notification has been received and are considered as made immediately after the next valuation date subsequent the Trustee's approval. Plan level withdrawals require a twelve-month advance written notification.

The Fund is valued using the NAV per share as a practical expedient of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The fund is a direct filing entity and there were no unfunded commitments, no redemption restrictions or notice period as of June 30, 2025 and 2024.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are in funds and accounts that are managed by Principal Trust Company or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Principal by participants. The Plan receives revenue credits from Principal. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants would become fully vested in their accounts.

### 8. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal Life Insurance Company which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through January 5, 2026, the date the financial statements were available to be issued.
