Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Villara Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Villara Corporation 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan established in 1982 to provide benefits to eligible employees of Villara Corporation (the "Company"). The plan administrator believes the Plan is currently designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Administration and Expenses

Empower Trust Company, LLC and Empower Annuity Insurance Company of America ("Empower"), serve as directed trustee of the Plan. Empower Retirement is the third-party recordkeeper of the Plan responsible for maintaining participant records.

Certain investment related expenses are charged directly by the investment funds and are thereby factored into each fund as a reduction in investment return. An asset-based fee is charged to each participant account on a quarterly basis for costs of Plan administration including record keeping, trust and investment advisory expenses. Participant loan administration and withdrawal fees are charged directly to participants. Other costs of administering the Plan are paid by the Company.

C. Eligibility

Employees covered by a collective bargaining agreement are excluded from the Plan. Substantially all other employees of the Company who have attained age 18 and who have completed a minimum of 500 hours of service within six months of commencement of employment are eligible to participate. Employees who do not complete the hours of service requirement during this time period become eligible on completion of one year of service. Employees may begin elective deferrals on the first day of the month coincident with or next following the date of meeting eligibility requirements.

D. Participant Contributions

Participants may elect to contribute their pre-tax compensation and/or elect to make Roth after-tax contributions. Participants of age 50 or older may make additional catch-up contributions not to exceed the maximum statutory amount. Pre-tax, Roth and catch-up contributions are subject to applicable Code limits. The Plan permits participants to make rollover contributions of eligible amounts received from other tax-qualified retirement plans. Such contributions are subject to the approval of the plan administrator and are invested in accordance with participant directions.

Eligible participants who have attained one year of service and who have not made an affirmative election to participate in the Plan are auto-enrolled at a pre-tax deferral rate of 1% of eligible compensation, unless the participants opt out of deferral. The pre-tax deferral rate for a participant whose deferral rate is less than 6% is automatically increased by 1% annually on April 1 to a maximum deferral rate of 6% unless the participant makes an alternative election.

E. Employer Contributions

The Company may make discretionary matching contributions equal to a percentage of participant elective deferrals up to a specified percentage of participant compensation. For the year ended March 31, 2025, the Company matched 25% of the first 6% of compensation deferred by each participant.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, an allocation of Company matching contributions, if any, and the participant's share of Plan earnings or losses and expenses. Participants direct the investment of their accounts among a diversified menu of investment funds provided under the Plan. The accounts of participants who decline to make an investment election are invested in the American Funds Target Retirement Fund that is appropriate for an individual's normal retirement date, as defined by the Plan document.

G. Vesting and Forfeitures

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. A participant becomes vested in his or her Company matching contribution account after three years of credited service. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan administrative expenses or to reduce Company contributions. For the year ended March 31, 2025, approximately \$32,000 of forfeitures were used to reduce company contributions. The balance of unapplied forfeitures was approximately \$4,000 and \$0 as of March 31, 2025 and 2024, respectively.

H. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account balance, bears a fixed rate of interest established at loan inception that is commensurate with interest rates charged by persons in the business of lending money and must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the repayment period may be extended. The plan administrator approves the specific terms and conditions of each loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at March 31, 2025 carry interest rates ranging from 5.25% to 10.50% with various maturities through October 2048.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

I. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, attainment of age 59½ or retirement, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits in a lump sum equal to the value of the participant's vested account balance. Hardship distributions are permitted under limited circumstances, as defined in the Plan, subject to approval of the plan administrator.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan maintains its accounting records on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Plan investments are stated at fair value except for the fully benefit-responsive investment contract which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made to the account plus earnings less withdrawals and expenses. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividends and interest. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Payment of Benefits

Benefits are recorded when paid.

E. Risks and Uncertainties

Investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an advisory letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Payment of expenses relating to Plan administration and investment activity are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at March 31, 2025 and 2024, and net appreciation of investments, interest and dividends for the year ended March 31, 2025 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower, the trustee.

NOTE 7 - FAIR VALUE MEASUREMENTS

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value as follows: Level 1 refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2 refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3 refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement.

Mutual funds are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

NOTE 9 - EMPOWER INVESTMENT FIXED ACCOUNT

Investments in the Empower Investment Fixed Account are maintained in a general account by Empower. Empower is contractually obligated to repay principal and a specified interest rate to the Plan. Because the fund is a fully benefit-responsive investment, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund. Participants may direct the withdrawal or transfer of all or a portion of their investment in the fund at contract value. The crediting interest rate of the fund is based on a formula. The average yield earned by the Plan was 1.44% and 1.28% for the years ended March 31, 2025 and 2024, respectively.

Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Fixed Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through November 24, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in these financial statements.
