Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Korg USA Inc. 401(k) Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Plan Description

The following description of Korg USA Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, established on April 1, 1998, and restated on April 1, 2017, is a defined contribution plan covering eligible employees of Korg USA, Inc. (Company). All full-time employees who have attained the age of twenty and a half, with six months of service are eligible to participate in the Plan. For employee deferrals, the employee's entry date into the Plan is the first day of each month coinciding with or following the date of eligibility. The Company makes safe harbor contributions for eligible employees who have attained the age of 21 years old, with one year and 1,000 hours of service. For safe harbor deferrals, the employee's entry date into the Plan is the first day of the next plan year coinciding with or following the date of eligibility, but in no event later than six months after satisfaction of the eligibility requirements. Effective with the restatement, the Plan may make discretionary nonelective contributions on an annual basis for all eligible employees who have one year and 1,000 hours of service. An employee's entry date into the nonelective contribution portion of the Plan is April 1st or the date six months later, coinciding with or following the date of eligibility. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). Effective January 1, 2025, the Plan's trustee changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

Participant Salary Deferral

Participants in the Plan may contribute up to 90% of their annual compensation provided that the participant's contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (IRS) each calendar year, \$23,000 and \$22,500 for the calendar years ended December 31, 2024 and 2023, respectively. Participants over the age of 50 can elect to contribute an additional \$7,500 for the calendar years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer Contributions

The Company has elected to make "safe harbor" contributions equal to 3% of participants' compensation. The Company has also made discretionary nonelective contributions equal to 3% of participants' compensation. The "safe harbor" and nonelective contributions are made on an annual basis and totaled \$428,228 for the year ended March 31, 2025.

Vesting

All participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Participants vest in the Company's discretionary nonelective contributions plus actual earnings thereon based on a six-year graded vesting schedule in which the participant is vested 20% after two years and then 20% each year thereafter until fully vested.

Participant Accounts

Individual participant accounts are credited with applicable participant contributions, an allocation of the Company's contributions, and investment earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Investment Options

Participants may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the nonvested portion of their account. Forfeitures are retained in the Plan and may be first used to restore any previously forfeited balances and then to reduce the employer contribution. There were \$9,200 of forfeitures into the Plan and \$0 of forfeitures utilized during the year ended March 31, 2025. The unallocated forfeiture balance at March 31, 2025 and 2024, amounted to \$29,432 and \$20,232, respectively.

Distributions

On termination of service, the Plan provides for a participant to have the option to receive a lump-sum or installment payments based on the value of the participant's account at that time. Amounts are not distributed except by reason of retirement, death, disability, separation from service, hardship, or the attainment of age 59 1/2. If a participant has less than \$5,000 in his account, the distribution may only be made in a lump-sum payment.

Notes Receivable from Participants

The Plan Administrator may permit participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of either \$50,000 or 50% of the account balance. A participant may only have two outstanding loans at any given time.

Loans are secured by the balance in the participant's account and bear interest at rates available for similar loans from commercial lending institutions (rates ranged from 4.25% to 9.50% per annum at March 31, 2025). Loans shall be repaid over a period of up to 5 years unless the loan is for the purchase of a primary residence for which the loan can be repaid over a period of 30 years. Loans are repaid through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amount of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3. Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, qualified institutions ADP Retirement Trust Services, LLC and Reliance Trust Company for March 31, 2025 and 2024, respectively, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of March 31, 2025 and 2024
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended March 31, 2025
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of March 31, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA- required supplemental schedule.

Note 4. Disclosure about Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments at March 31, 2025 and 2024.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Fees paid to Raymond James for investment advisory services amounted to \$59,987 for the year ended March 31, 2025, are included in the administrative fees on the statement of changes in net assets available for benefits.

Note 6. Tax Status

The Plan is a prototype nonstandardized profit-sharing plan sponsored by DATAIR Employee Benefit Systems Inc. (DATAIR). DATAIR has obtained an opinion letter on the prototype plan dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (Code). The Plan has not been amended since receiving the determination letter and the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the Plan Administrator will handle the distributions of account balances under the provisions of ERISA, until all assets have been administered and distributed by the Trustee.

Note 9. Subsequent Events

Subsequent events have been evaluated through November 13, 2025, which is the date the financial statements were available to be issued.
