Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc of Crawford County 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc of Crawford County 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investments of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE A DESCRIPTION OF THE PLAN

General

The following description of The Arc of Crawford County 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by The Arc of Crawford County, Inc. (Sponsor) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Sponsor. Participants are required to have one year of service to be eligible for Sponsor matching contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Mutual of America Life Insurance Company served as the trustee and custodian of the Plan through October 2023, with Wells Fargo Bank, National Association, also serving as their directed custodian. American United Life Insurance Company serves as the custodian of the Plan beginning in October 2023. An employee of the Sponsor is the trustee of the Plan.

Contributions

The Plan permits eligible employees to have the Sponsor make annual contributions of up to 100 percent of their eligible compensation through a salary deferral election. The Sponsor had made matching contributions equal to 100 percent of employees' salary deferral amounts on the first 6 percent of employees' compensation. Effective July 1, 2024, the Sponsor makes safe harbor matching contributions of 100 percent of employees' salary deferral amounts on the first 6 percent of employees' compensation. Sponsor additional matching contributions are discretionary as determined by the Sponsor's Board of Directors and are limited to the maximum of 4 percent. Contributions are subject to certain limitations, and employee rollover contributions are permitted. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant Investment Account Options

Investment account options available include various variable annuity account funds and a group annuity contract. Each participant has the option of directing contributions into any of the investment account options selected by the Sponsor and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions and the Sponsor's matching contributions plus earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of their account or annual installments. A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Variable annuities are valued at estimated fair value as provided by American United Life Insurance Company, utilizing the net asset value (NAV) of shares held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value of the variable annuities.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date, if applicable. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Sponsor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

NOTE C CERTIFICATION OF PLAN CUSTODIAN AND FORMER TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. American United Life Insurance Company, the current custodian of the Plan from October 2023 to June 30, 2025, and Mutual of America, the former trustee of the Plan from July 1, 2023 to October 2023, have certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of June 30, 2025.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are units of variable annuity funds and a group annuity contract that are managed by American United Life Insurance Company. American United Life Insurance Company is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly certain other fees related to the Plan's operation.

The Plan paid \$0 and \$298 in recordkeeping fees to the Mutual of America Life Insurance Company during the years ended June 30, 2025 and 2024, respectively. The Plan paid \$1,060 and \$1,595 in recordkeeping fees to American United Life Insurance Company during the years ended June 30, 2025 and 2024, respectively. The Sponsor provides certain administrative services at no cost to the Plan.

NOTE E PLAN AMENDMENTS

Effective October 1, 2023, the Plan was amended and restated with the adoption of a volume submitter 403(b) plan adoption agreement sponsored by OneAmerica Financial Partners, Inc. The restatement of the Plan modified certain provisions to comply with the recent regulatory requirements. Additionally, the following provisions were also amended with the restatement:

- The name of the Plan was changed to The Arc of Crawford County 403(b) Plan.
- Updated provisions to allow forfeitures to be used to reduce employer contributions or offset Plan administrative expenses.
- Removed the provision to allow Section 403(b) catch-up contributions for those participants with 15 years of service.

NOTES TO FINANCIAL STATEMENTS

In January 2024, the Plan was retroactively amended effective January 1, 2020 to incorporate the following provisions of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) that had been previously operationally adopted:

- Allowed qualified individuals to take coronavirus-related distributions up to \$100,000 from their vested account balance beginning on or after January 1, 2020 and before December 31, 2020. This provision also allowed the qualified individuals to repay this amount any time over a three-year period.
- Allowed for a waiver of the requirement for participants to receive a required minimum distribution for the 2020 year.

Effective July 1, 2024, the Plan was amended to modify the following provisions:

- Removed the regular Sponsor matching contribution and replaced it with an enhanced Safe Harbor provision that provides eligible participants with matching contributions equal to 100% of employees' salary deferral amounts on the first 6 percent of employees' compensation.
- Added a provision that allows Sponsor additional matching contributions on a discretionary basis up to a maximum of 4% of the employees' total compensation.

NOTE F DISCLOSURES ABOUT FAIR VALUE OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced parameters including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

NOTES TO FINANCIAL STATEMENTS

NOTE G INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive traditional investment contract with American United Life Insurance Company. American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of The Arc of Crawford County, Inc. or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE H TRANSFER OF PLAN ASSETS

When the transfer of assets from Mutual of America Life Insurance Company to American United Life Insurance Company occurred in October 2023, another retirement plan sponsored by The Arc of Crawford County, Inc. was also transferred to this Plan. The assets of The Arc of Crawford County, Inc. - Tax Deferred Annuity Plan were transferred in the amount of \$17,649. This is included as a transfer on the statements of changes in net assets available for benefits.

NOTE I PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100 percent vested in their Sponsor matching contributions.

NOTE J TAX STATUS

The Company has adopted a volume submitter plan document that has received an opinion letter from the Internal Revenue Service dated November 22, 2017, stating that the form of the volume submitter plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the volume submitter plan document, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE M SUBSEQUENT EVENTS

Subsequent events have been evaluated through December 29, 2025, which is the date the financial statements were available to be issued.

Plan Amendment

Effective July 1, 2025, the Plan was amended to remove the service requirement, so participants will now be immediately eligible for all Sponsor contributions immediately upon hire.
