We have performed audits of the accompanying financial statements of Collum's Administration & Maintenance Company, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of Plan**

The following description of the Collum's Administration & Maintenance Company, LLC (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Company is the Plan Administrator.

**General** – The Company is wholly owned by Collum's Lumber Products, LLC ("Collum's Lumber"). Collum's Lumber is a lumber company operating principally in the southeastern United States. All employees are employees of and are compensated through the Company. The Plan commenced in 1980 and was last amended in 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Charles Schwab Trust Bank ("Charles Schwab") serves as the trustee of the Plan. The Plan is a defined contribution 401(k) plan covering all full-time employees of the Company who have at least twelve months of service and are age 21 or older.

**Contributions** – Each year, participants may contribute to the Plan a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute, or rollover, distributions from other qualified defined benefit or contribution plans. Contributions are invested in a portfolio of investments as directed by the Company. The Company may make matching or other discretionary contributions to the Plan at the discretion of the Company owners. The Company need not have profits to make an annual contribution. Discretionary contributions made by the Company are allocated in a uniform and non-discriminatory manner in the ratio that each eligible participant's compensation bears to total compensation, as defined. Contributions are subject to certain limits prescribed by the Internal Revenue Code ("IRC"). The Company declared a profit-sharing contributions to the Plan of \$600,000 and \$1,000,000 for the years ended March 31, 2025 and 2024. No allowance for credit losses was deemed necessary as it relates to these contributions for the years ended March 31, 2025 and 2024.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and, if applicable, allocations of (a) the Company's discretionary contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined in the Plan document. The benefit to which a participant is entitled is accumulated and limited to the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant vests 20% after two years of service and an additional 20% for every year of service thereafter. At the end of six years of credited service, a participant is fully vested in the Company's contributions.

**Payment of Benefits** – Benefit payments generally begin upon normal retirement, as defined. A participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account upon termination of service with the Company. The Plan records benefit payments to withdrawing participants when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which had been approved but not yet paid at year-end, if any. There were approved unpaid distributions of \$31,945 and \$0 as of March 31, 2025 and 2024, respectively.

**Note 1. Description of Plan (continued)**

**Forfeited Accounts** – Forfeited accounts totaled approximately \$23,000 and \$22,000 as of March 31, 2025 and 2024, respectively. No forfeited accounts were used to reduce expenses during the year ended March 31, 2025. The forfeitures held as of March 31, 2025 and 2024 were allocated to participant accounts as an additional profit-sharing contribution during the following fiscal year.

**Plan Administration** – The Company is the designated Plan Administrator but delegates most of the administrative duties to Ameritas, the Plan's Recordkeeper. Officers and employees of the Company perform certain administrative functions and may be Plan participants, but they receive no compensation from the Plan.

**Note 2. Summary of Accounting Policies**

**Basis of Accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and use assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The most significant estimate affecting these financial statements is the fair value of investments. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Earnings on investments are allocated using balance forward accounting in which each participant's account shares proportionately in the allocation of earnings and expenses.

**Operating Expenses** – Operating expenses consist of certain record keeping expenses and investment management expenses. Certain other administrative expenses of the Plan, including legal and audit fees, are paid directly by the Company and, as such, are not expenses of the Plan. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

**Note 3. Investments**

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated by \$372,177 and \$1,803,084 during 2025 and 2024, respectively.

*Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at March 31, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 3. Investments (continued)**

*Collective investment trust:* The collective investment trust is valued at net asset value ("NAV") as provided by the administrators of the fund. NAV is used as the practical expedient to estimate fair value. The NAV is based on the value of the underlying assets of the fund, less liabilities, and then divided by the number of units outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been recorded for the years ended March 31, 2025 and 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5. Information Certified by the Plan’s Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and accompanying supplemental schedules is complete and accurate as of March 31:

**Note 6. Related Party and Party-In-Interest Transactions**

Fees paid directly by the Plan for the administration services and investment transaction fees amount to \$64,711 and \$61,139 for the years ended March 31, 2025 and 2024, respectively. As noted in Note 2, the Company pays annual audit fees; all trustee and administrative fees are paid by the Plan.

Certain members of the Company's management perform administrative and fiduciary duties for the Plan that qualify them as parties-in-interest and/or related parties of the Plan. Transactions between such members of the Company's management and the Plan were routine in nature and conducted pursuant to the Plan's provisions as of and during the years ended March 31, 2025 and 2024.

Delinquent participant contributions represent non-exempt party-in-interest transactions. Plan management identified certain instances of delinquent participant contributions related to the year ended March 31, 2025. As reported on Form 5500 Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ending March 31, 2025, certain participant contributions totaling \$97,640 were not remitted to the trust within the period specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company.

**Note 7. Concentrations of Credit Risk**

All Plan assets are invested with the Trustee. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the Trustee, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.
