Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Opengate, Inc. 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS MARCH 31, 2025 AND 2024

1. THE PLAN

The following description of the Opengate, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan established for employees of Opengate, Inc. (the Company). The Plan is administered by management of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees at least age 21 and have completed at least one thousand hours of service within a twelve-month period are eligible to begin salary deferrals and receive employer discretionary and safe harbor contributions on either the first day of the Plan year or the first day of the seventh month of the plan year coinciding or following completion of the eligibility requirements.

Contributions

The Plan automatically enrolls eligible participants for salary deferral under its automatic enrollment feature. Under automatic enrollment, 2% of the participant's paycheck before taxes will be contributed to the Plan as pre-tax contributions unless the participant elected to either not make elective deferral contributions or contribute a different percentage. Participants may elect to defer a percentage of their eligible pay every pay period. At its discretion, the Company may contribute employer profit sharing contributions to the Plan for each employee that meets the eligibility requirements. This contribution is in proportion to the employee's eligible earnings compared to the eligible earnings of other employees who will also share in the contribution. If the Company decides to make a contribution, it will be allocated to the employees at the end of each Plan year. In addition, the Company has committed to make safe harbor matching contributions for eligible employees. This contribution is equal to 100% of the employee's salary deferrals that do not exceed 3% of the employee's compensation plus 50% of the employee's salary deferral between 3% and 5% of the employee's compensation, not to exceed 4% of an eligible participant's compensation.

Vesting

A participant is vested immediately in their contributions and safe harbor matching contributions plus actual earnings. Vesting of Company profit sharing contributions is as follows:

Participant Accounts

Each participant's account is credited with the participant's contributions along with an allocation of (a) the Company's contributions, if applicable, and (b) Plan earnings and losses. Contributions allocated to an employee's account are invested according to the employee's discretion. The entitled benefit is the participant's account balance subject to vesting.

Investment Options

The Plan currently offers investment options through a regulated investment company, including mutual funds and common collective trusts. Participants may change their investment options daily.

Payment of Benefits

Upon termination of employment, participants are entitled to receive a lump-sum distribution or periodic payments, which is equal to the vested value of their account. Benefits to terminated participants are recorded when paid. The Plan has a mandatory rollover provision if the participant terminates employment, and the vested account balance does not exceed \$5,000, exclusive of the balance of the rollover account.

Forfeitures

Participants who terminate employment before they vest will forfeit their interest in employer contribution account balances. These account balances will be used to reduce employer contributions. The balance of available plan forfeitures totaled \$55,832 and \$21,152 at March 31, 2025 and March 31, 2024, respectively. Additionally, \$55,832 and \$21,152 of forfeitures were then used to reduce the 2025 and 2024 employer contributions, respectively, which is paid after the Plan's year-end.

Administrative Expenses

The Plan permits the payment of certain Plan expenses to be made from the Plan's assets. Any expenses paid by the Plan are paid by Plan participants as a reduction of investment income.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Risks and Uncertainties

Investments, consisting of mutual funds and shares in common collective trusts are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the value of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable From Participants (Continued)

Participants can borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of the total vested account balance. No loans less than \$500 will be made. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at Wall Street Journal Prime rate plus 1 percent. Principal and interest are paid in substantially equal payments over the life of the loan through payroll deductions. The loan in its entirety must be repaid within 5 years of the date the loan proceeds are received, unless used to acquire a principal residence.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual fund investments are stated at fair value. Investments in common collective trusts are stated at net asset value (NAV), as a practical expedient for determining fair value. Changes in the current value of investments, including realized/unrealized gains and losses on assets sold/held during the year, are reflected in the statement of changes in net assets available for benefits as appreciation or depreciation in the fair value of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are rendered on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

Fair value of the Plan's investments represent the price that would be received upon the sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants as of the measurement date. Financial instruments are measured and reported at fair value and are classified and disclosed in one of the following categories based on the lowest level input that is significant to the fair value management in its entirety:

- Level 1 inputs are quoted prices in active markets that are accessible at the measurement date for assets or liabilities. The Plan's investments in mutual funds are valued based upon quoted prices in active markets.
- Level 2 inputs are observable prices that are based on inputs not quoted in active markets but corroborated by market data. The Plan does not have any Level 2 investments as of March 31, 2025 and 2024.
- Level 3 inputs are unobservable inputs that are used when little or no market data is available. The Plan does not have any Level 3 investments as of March 31, 2025 and 2024.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

3. INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended March 31, 2025 and 2024.

There have been no changes in valuation techniques during 2025 and 2024.

The Plan's investments valued at net asset value per share as of March 31, 2025 and 2024 represent common collective trust funds that invest in fixed and floating rate securities through commingled investment vehicles. The investments were organized by the Plan sponsor to maximize investment opportunities and returns. The investments are managed by professional investment management firms and are overseen by the Plan sponsor. Income is allocated to the Plan based on the percentage of the net asset value of its individual funds to the total investment balance. The investments had no unfunded commitments in 2025 and 2024.

4. FAIR VALUE MEASUREMENTS (Continued)

The Plan utilizes the NAV reported by common collective trust managers as a practical expedient for determining the value of the investment. These investments are redeemable at NAV with a ten day redemption notice period, and have a daily redemption frequency. Due to the nature of the investments held, changes in market conditions and the economic environment may significantly impact the NAV and, consequently, the recorded value of the Plan's interests in the funds. Furthermore, changes to the liquidity provisions of the funds may significantly impact the value of the Plan's interest in the funds. Additionally, although certain investments may be sold in a secondary market transaction, subject to meeting certain requirements of the governing documents of the funds, the secondary market is not active and individual transactions are not necessarily observable. It is therefore reasonably possible that if the Plan were to sell a fund in the secondary market, the sale could occur at an amount different from the reported value, and the difference could be material. The Plan has no plans to sell a fund in a secondary market.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution.

6. INCOME TAX STATUS

The Plan is a Prototype Non-Standardized 401(k) Profit Sharing Plan with CODA issued through ADP, Inc. The Internal Revenue Service has determined by letter dated July 16, 2014 that the Plan and related trust were designed, at that time, in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, were exempt from federal income taxes. The Plan has been amended since that date. The plan administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants having loans and the Plan qualify as party-in-interest transactions.
