INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
of MWI, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MWI, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS
MARCH 31, 2025 AND 2024**

1. DESCRIPTION OF PLAN

The following description of the MWI, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General -

The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all employees of MWI, Inc. (the “Company”). Employees are permitted to make elective deferrals to the Plan upon the attainment of the age of 21 and completion of six consecutive months of employment. Participants are eligible for any Company discretionary matching and discretionary profit sharing contributions upon completion of 1,000 hours of service during the Plan year and if they are employed on the last day of the Plan year. The effective date of the Plan is July 1, 1981. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration -

The Company serves as Plan administrator (the “Administrator”) and is solely responsible for the general administration of the Plan and carrying out Plan provisions.

As of March 31, 2024 and for the period from April 1, 2024 to December 31, 2024, Reliance Trust Company (“Reliance”), a wholly owned subsidiary of Automatic Data Processing, Inc. (“ADP”), served as the trustee of the Plan and custodian of Plan assets. As of January 1, 2025, ADP Retirement Trust Services, LLC (the “Trustee”), a wholly owned subsidiary of ADP, serves as the trustee of the Plan and custodian of Plan assets. ADP’s Retirement Services provides third-party recordkeeping services. UBS Retirement Plan Consulting Services provides investment advisory services to the Plan.

Contributions -

Participants may elect to contribute up to 90% of their eligible compensation to the Plan, subject to the maximum amount allowed under the Internal Revenue Code (the “Code”). Deferral limits under the Code were \$23,000 for the calendar year ended December 31, 2024. In addition, participants age fifty and over at the end of the Plan year could elect to contribute a “catch-up” contribution of \$7,500 during the calendar year ended December 31, 2024.

Each year, the Company may make discretionary profit sharing or discretionary matching contributions. For the year ended March 31, 2025, the Company elected to make a discretionary profit sharing contribution which was allocated to participants based on the relationship of their individual annual eligible compensation to the total annual eligible compensation for all participants. The Company’s discretionary profit sharing contribution totaled \$150,000 for the year ended March 31, 2025. The Company elected not to make a discretionary matching contribution for the year ended March 31, 2025.

Participants are allowed to make rollover contributions from other qualified plans into the Plan in accordance with regulations under the Code. Further, participants are allowed to make Roth elective deferrals into the Plan.

Participant accounts -

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary profit sharing and discretionary matching contributions and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan, if not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately vested in their elective deferrals, rollover, and Roth contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing and discretionary matching contribution portion of their account plus earnings is based on years of continuous service as follows:

Less than two	0%
At least two but less than three	20%
At least three but less than four	40%
At least four but less than five	60%
At least five but less than six	80%
Six or more	100%

Investment options -

Participants direct the investment of their account into various investment options offered by the Plan. The Plan offers a number of investment options including mutual funds and a money market fund as selected by the Administrator.

Notes receivable from participants -

Participants may borrow a minimum of \$1,000, up to a maximum of 50% of their vested account balance, or \$50,000, whichever is less. Note repayment terms range up to a maximum of five years unless used for the purpose of purchasing a participant's principal residence, with interest generally at the prime rate at the time of issuance plus 1% and are collateralized by the individual participant's account. Principal and interest are paid ratably through payroll deductions. A participant may only have two loans outstanding at any time, but only one loan can be a primary residence loan.

Payment of benefits -

Amounts contributed through payroll deductions may be withdrawn by, or distributed to, a participant only upon termination of employment or attaining the age of 59 ½. Withdrawals prior to attaining the age of 59 ½ are only permitted in the event of death, disability, or as a hardship distribution. Upon proof of an immediate and heavy financial need, to the satisfaction of the Administrator, amounts contributed may be withdrawn for a hardship distribution. Upon termination of service due to death, disability or retirement, a participant or beneficiary may receive a lump-sum amount equal to the vested value of his or her account.

If upon termination of service, a participant does not attain normal retirement age and the participant's vested account balance is greater than \$5,000, the participant may elect to receive a lump-sum amount, a direct rollover to a qualified plan under the Code, a direct rollover to a qualified Individual Retirement Account equal to the value of his or her vested account balance, or may elect to keep their investments in the Plan. If the vested account balance is less than \$5,000, the balance will be distributed to the participant as soon as administratively feasible. Such distributions will be rolled over to an individual retirement account designated by the Plan Administrator.

Forfeitures -

Participants whose employment with the Company has been terminated and who receive a distribution of the vested percentage of their account shall forfeit any amounts which are in excess of their vested interest as of the date of distribution. Forfeitures may be used to reduce Company discretionary contributions or pay administrative expenses. The cumulative balance of forfeitures available to offset future Company discretionary contributions or administrative expenses totaled \$20,295 at March 31, 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting -

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates -

The preparation of financial statements in conformity with GAAP requires the Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include, but are not limited to, the valuation of investments and notes receivable from participants. Actual results may differ from those estimates.

Investment valuation and income recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Contributions are recorded by the Plan when withheld from participants. Interest income is recorded by the Plan as earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowances for credit losses has been recorded as of March 31, 2025 or 2024. If a participant ceases to make loan repayments and the Administrator deems the participant note receivable to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits -

Benefit payments to participants are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan, including audit fees, are paid directly by the Company and are excluded from these financial statements. Administrative expenses include third-party recordkeeping, trustee, and investment advisory fees. Participants are also charged administrative expenses for specific transactions within the Plan. Administrative expenses charged to the Plan totaled \$40,694 for the year ended March 31, 2025.

Investment related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

3. FINANCIAL INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investment information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared by, or derived from, information provided by Reliance and the Trustee and furnished to the Administrator. The Administrator has obtained a certification from Reliance as of March 31, 2024 and for the period from April 1, 2024 to December 31, 2024. The Administrator also obtained a certification from the Trustee as of March 31, 2025 and for the period from January 1, 2025 to March 31, 2025.

The Administrator, therefore, has obtained certifications that the information below is complete and accurate as of March 31, 2025 and 2024, and for the year ended March 31, 2025:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in methodologies used at March 31, 2025 and 2024.

Mutual and money market funds: Mutual and money market funds are valued at the net asset value ("NAV") of shares held by the Plan at year end. NAV is derived from the quoted prices in active markets of the underlying investments. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

5. PARTY-IN-INTEREST TRANSACTIONS

The Trustee serves as custodian of the Plan's assets. All transactions between the Plan and the Trustee qualify as exempt party-in-interest transactions. Transactions involving notes receivable from participants also qualify as exempt party-in-interest transactions.

6. TAX STATUS

The Company adopted a prototype non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement plan sponsored by ADP, LLC that received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020. The opinion letter stated that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements for the year ended March 31, 2025.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary profit sharing and discretionary matching contribution account balances as of the date of termination.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.


