Note 1: Description of Plan

The following description of Innovative Learning, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by Innovative Learning, Inc. (the Organization) under a prototype plan sponsored by Ascensus, LLC. The Plan was adopted on October 19, 1996 and restated on January 1, 2020. The Plan generally covers all employees of the Organization who work at least 20 hours per week during the Plan year. The Plan provides for employee voluntary contributions, employer matching contributions, and participant-directed investments. The Plan qualifies under Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute an amount not to exceed the lesser of 100% of their compensation or an amount which, when added to other additions (exclusive of earnings) to the participant's account in any plan year, does not exceed the maximum limitation on annual additions to a participant's account under applicable provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Contributions to a Roth account are also permitted. Participant contributions are made through payroll deductions. Each participant designates the amount of their contributions which are to be invested in one or more of the available investment fund options. Participants are also allowed to contribute distributions received from other qualified retirement plans. In the event the Plan fails to satisfy relevant nondiscrimination provisions, participant contributions may be returned to certain active participants and will also be included in the Plan's statements of net assets available for benefits as excess participant contributions payable.

Employer Contributions: The Plan allows matching contributions equal to a discretionary percentage determined annually by the Organization. For the years ended June 30, 2025 and 2024, the Organization elected to match 50% of each participant's eligible contributions. The discretionary contributions to the Plan are subject to the annual limitations set by the IRC.

Participant Accounts: Each participant's account is credited with the participant's contributions, employer contributions, and allocations of Plan earnings and losses. Plan earnings and losses are allocated based on the account balances of the participants. The employer's matching contributions are allocated to the participants based on each participant's contributions to the Plan during the plan year. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

Vesting: Participants are immediately vested in all their contributions and investment earnings thereon. Vesting in the Organization's contributions plus earnings thereon is based on years of service. A participant becomes fully vested after five years of service. In the event of death, disability or retirement, a participant's interest is immediately fully vested in the employer contributions and related earnings under terms set forth in the Plan agreement.

Payment of Benefits: Upon termination of employment, a participant must elect to have plan benefits to which they are entitled distributed as a lump-sum payment or a direct rollover to another qualified plan. Participants are generally required to take minimum distributions upon reaching the age of 73. Hardship withdrawals by a participant are permitted under certain circumstances as defined by the Plan document.

Note 1: Description of Plan (Continued)

Forfeitures: The non-vested portion of a participant's account is forfeited upon termination of employment. Forfeitures are utilized to pay for employer matching contributions and the Plan's administrative expenses. For the years ended June 30, 2025 and 2024, forfeitures were used to pay \$13,612 and \$7,319 in plan expenses, respectively. As of June 30, 2025 and 2024, forfeited non-vested accounts were \$30,980 and \$8,070, respectively.

Note 2: Summary of Significant Accounting Policies

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants.

Benefits Paid to Participants: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through December 18, 2025, the date the financial statements were available to be issued. During the period from July 1, 2025 through December 18, 2025, the Plan did not have any subsequent events that require recognition or disclosure.

Note 3: Fair Value Measurements

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the assets or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-Bearing Cash: The Plan classifies investments in a money market mutual fund as interest-bearing cash and is valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at June 30, 2025 and 2024.

Note 4: Information Certified by the Plan Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Ascensus Trust Company, the custodian of the Plan, as of June 30, 2025 and 2024, except to compare such information to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments in interest-bearing cash and mutual funds at June 30, 2025 and 2024, and net appreciation in fair value of investments, and dividends and interest income for the years ended June 30, 2025 and 2024, were derived from information certified as complete and accurate by Ascensus Trust Company.

Note 5: Plan Termination

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all participants will become fully vested. The Organization has not indicated any intention to terminate the Plan.

Note 6: Income Tax Status

The Internal Revenue Service (IRS) has ruled in a letter dated January 1, 2018, that the Volume Submitter 403(b) Plan sponsored by Ascensus LLC (see Note 1), qualifies under applicable sections of the Internal Revenue Code (IRC). An employer who adopts this plan is generally considered to have a plan that is also qualified. The plan administrator and the plan sponsor believe that the Plan, as amended, is designed and currently operating in compliance with the applicable requirements of the IRC. The Plan's federal information returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 7: Administrative Expenses

The Plan provides that the Organization, at its discretion, can agree to pay administrative expenses on behalf of the Plan. Expenses paid directly by the Organization are excluded from these financial statements.

Note 8: Reconciliation of Financial Statements to Form 5500

For the years ended June 30, 2025 and 2024, there were no significant differences between the financial statements of the Plan and the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan) filed with the Internal Revenue Service.

Note 9: Parties in Interest

The Plan is responsible for various costs of administration which include custodial, recordkeeping, and investment management expenses under service agreements with Ascensus Trust Company (Ascensus). Administrative fees totaling \$17,705 and \$11,982 for the years ended June 30, 2025 and 2024, respectively, were charged by Ascensus to individual participants' accounts and are reported separately on the statements of changes in net assets available for benefits.

Certain officers and employees of the Plan sponsor that are administrators of the plan acting as fiduciaries and as Trustees, are also participants in the Plan.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
