INDEPENDENT AUDITOR'S REPORT

To the Trustees of
the Hader Industries Inc. Employee Benefit Trust

Opinion

We have audited the accompanying financial statements of Hader Industries Inc. Employee Benefit Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits and of plan benefit obligations as of March 31, 2025 and 2024, the related statement of changes in net assets available for plan benefits for the year ended March 31, 2025, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for plan benefits and plan benefit obligations of Hader Industries Inc. Employee Benefit Trust as of March 31, 2025 and 2024, and the changes in its net assets available for plan benefits for the year ended March 31, 2025, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hader Industries Inc. Employee Benefit Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Hader Industries Inc. Employee Benefit Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Notes to Financial Statements

NOTE 1 - Description of Plan

The following description of the Hader Industries, Inc. Employee Benefit Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions. Employees of Hader Inc., Hader Industries, Inc., Hader-Seitz Inc., and Fabri-Tech Inc. (collectively, the Company) are covered by the Plan.

A. Nature of the Plan

The Plan was implemented December 29, 1998 in order to provide comprehensive hospital-surgical, medical and dental benefits to participants and to their covered dependents. All full-time hourly employees of the Company are eligible to participate the first of the month following 30 consecutive days of employment and salaried employees are eligible immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Contributions

The Plan is funded by the Company through a trust, which is covered by Section 501(c)(9) of the Internal Revenue Code. Periodic contributions are made to the trust to ensure there are adequate funds to cover claims of the Plan.

The Sponsor's policy is to contribute the maximum amounts allowed as a tax deduction by the Internal Revenue Code. Under present law, the Sponsor is not permitted to deduct amounts for future benefits to current employees and retirees.

Employees and retirees may contribute specified amounts, determined periodically by the Plan's insurance companies, to extend coverage to eligible dependents.

C. Stop Loss Insurance

The Company holds a stop-loss insurance policy limiting the liability of the Plan to certain maximum limits for covered employees and their dependents. The policy activates after the Plan pays \$50,000 in medical benefits for an individual per year. The premiums are paid directly by the Company.

D. Administrative Services Agreement

The Plan utilizes UMR to process all health and dental claims incurred and to perform other necessary functions with respect to the general administration of the medical and dental provisions of the plan. Fees incurred are paid directly by the Company.

E. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

A. Basis of Accounting

The financial statements of the Plan are reported under the accrual method of accounting.

B. Estimates

In preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Cash and Cash Equivalents

For the purpose of the Statements of Net Assets Available for Plan Benefits, the Company considers all short-term investments in interest bearing accounts, securities, and other instruments with an original maturity of three months or less, to be equivalent to cash.

D. Payment of Benefits

Benefits are recognized when paid.

E. Other

Hader Industries, Inc. bears all administrative costs.

F. Other Plan Benefits

Plan obligations at March 31, 2025 and 2024 are for health and dental claims that have been processed and approved for payment or incurred but not reported at that date.

G. Subsequent Events

For the year-ended March 31, 2025, the Company has evaluated subsequent events for potential recognition and disclosure through December 31, 2025, the date the financial statements were available to be issued.

NOTE 3 - Tax Status

The Plan utilizes Hader Industries, Inc. Employee Benefit Trust. The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter from the Internal Revenue Service, dated June 30, 2000, and the Plan sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.
