Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform an audit of the financial statements of Friends of Youth 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and the Plan's Custodians did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) are presented for purposes of additional analysis and are not a required part of the financial statements but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

Auditor's Report on the 2024 Financial Statements

We were engaged to audit the statement of net assets available for benefits of the Plan as of June 30, 2024. As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information certified by the qualified institution.

Prior to July 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and the Plan's Custodians did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements had been affected by these conditions.

Our audit report, dated March 11, 2025, indicated that because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an opinion and accordingly, we did not, express an opinion on the 2024 financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of Friends of Youth 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under section 403(b) of the Internal Revenue Code (IRC) established for the benefit of eligible employees of Friends of Youth (the Agency). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant loans are not allowed under this Plan.

Custodians and Administration of the Plan

The Custodians of the Plan are Reliance Trust Company and Standard Insurance Company. The recordkeeper of the Plan is Standard Insurance Company. The Administrator of the Plan is the Agency. The Custodians hold all assets of the Plan in accordance with the service provider contracts with the Agency. The Agency determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Agency, unless excluded, are eligible to make voluntary salary reduction contributions to the Plan upon their date of hire. Excluded employees from eligibility in the Plan include non-resident aliens and employees who normally work less than 20 hours per week. Unless otherwise excluded, employees who have completed one year and 1,000 hours of service during the initial one year of service eligibility period, or 1,000 hours completed during the subsequent Plan year after the initial year of service, are eligible to receive employer contributions from the Agency.

Contributions

Participant Contributions – Participants are subject to an automatic 3% salary deferral contribution, unless the participant selects otherwise, up to the applicable limits of the IRC. The Plan allows for traditional pre-tax deferrals and Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) and may make catch up contributions if they are 50 years of age or older.

Employer Contributions – The Agency may contribute a discretionary percentage of elective salary deferrals, and this discretionary percentage is determined by the Board of Directors of the Agency. The discretionary percentage is based on a maximum of 3% of participant compensation. For 2025, the Agency matched participant contributions at a rate of 100% up to 3% of eligible compensation for each eligible participant.

Contributions are subject to certain limitations of the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Agency's contributions, and allocations of Plan earnings and losses and administrative expenses. Allocations are based on participant eligible compensation, participant contributions, or account balances, as defined.

Participants direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employees are subject to the following vesting schedule for employer contributions:

3 or more	100%

A participant becomes 100% vested if the participant reaches normal retirement age (65), dies, or becomes totally and permanently disabled while in the service of the Agency. Participants are always 100% vested in their employee contributions.

Forfeitures

The portion of a terminated participant account that is not vested (forfeitures) are used to reduce employer contributions or pay Plan expenses. Forfeitures of \$5,878 were generated during the year ended June 30, 2025, and \$12,727 were used to reduce employer contributions or pay Plan expenses during the year ended June 30, 2025. The balance of forfeitures as of June 30, 2025, was \$1,573. The balance of forfeitures as of June 30, 2024, was \$8,236.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or the participant's beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account on the later of: age 65; the tenth anniversary of initial participation in the Plan; or the date employment was terminated due to the reasons listed above.

Account balances of less than \$5,000 will be distributed as a lump sum within one year of termination of employment. If the account balance exceeds \$5,000, the participant may elect to receive his or her distribution as a lump sum or rollover after termination of employment. Distributions can also be made to participants during their employment with the Agency if they meet certain requirements (including upon attainment of age 59½ or under certain hardship provisions) as defined within the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2 – Summary of Significant Accounting Policies

Annual Reporting Requirements

Prior to January 1, 2009, Reliance Trust Company maintained records at a contract, not Plan level. Reliance Trust Company and Standard Insurance Company (The Standard), administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As such, the Employer, Reliance Trust Company nor The Standard have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments, with the exception of the fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Custodians. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contracts are valued at contract value. Contract value equals accumulated cash contributions and interest less distributions. See Note 5 for additional discussion.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Administrative expenses relating to Plan administration and the annual Plan audit may be paid by the Agency on a discretionary basis. The Plan paid \$46,257 of administration fees in the year ended June 30, 2025.

Additionally, the Agency pays certain expenses of the Plan. Expenses paid by the Agency are excluded from these financial statements. Certain investment expenses which are charged within investments are presented net of the appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through the date these financial statements were available to be issued, which was January 7, 2026.

Note 3 – Certified Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Standard Insurance Company, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2025 and 2024
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2025
- Investment information included in the schedule of assets (held at end of year) as of June 30, 2025 as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used at June 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are valued using Level 1 inputs.

The following tables present information about the Plan's assets that have been measured at fair value on a recurring basis as of June 30, 2025 and 2024, and indicate the classification by level of inputs within the fair value hierarchy described above:

Note 5 – Investment in Fully Benefit-Responsive Investment Contracts

The Plan invests in a fully benefit-responsive investment contract (traditional investment contracts) through a stable asset fund, which is commonly referred to as general account product. GAAP provides guidance with respect to financial statement presentation and disclosure of fully benefit-responsive investment contracts. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. These contracts have a guarantee of principal and a guaranteed minimum interest rate.

The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting interest rate for the investment contract was 3.14% at June 30, 2025. The crediting interest rate is based on an agreed-upon formula with the issuer and the characteristics of the underlying fixed income portfolio, but cannot be less than 1.0%. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the issuers ability to meet its financial obligations. The issuers ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value is not probable. Both management of the Plan and the contract sponsor can terminate the contract with 30 days advance notice, although the contract sponsor can only terminate the contract for reasonable cause. There are no unfunded commitments and no restrictions on redemptions. A surrender charge may apply to transfers or withdrawals from unmaturing guaranteed accounts.

Note 6 – Income Tax Status

The Plan has adopted a prototype plan sponsored by The Standard. The Standard received an opinion letter from the IRS, dated March 31, 2017, which states the prototype document, as then designed, satisfies applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 7 – Related Party and Party-in-Interest Transactions

Certain plan investments consist of guaranteed investment contracts managed by The Standard for the Plan year ended June 30, 2025. The Standard is the contract administrator and investment custodian of the Plan; therefore, transactions with The Standard qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants would become 100% vested in any employer contributions.
