### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Teichert, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Teichert, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Teichert, Inc. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ***Responsibilities of Management for the Financial Statements***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Teichert, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective April 1, 1962. The Plan has been amended throughout the years and last restated effective January 1, 2022 and most recently amended January 1, 2024. The Plan covers substantially all employees of Teichert, Inc. (the Company and the Sponsor), A. Teichert & Son, Inc., Teichert Pipelines, Inc., Triangle Properties, Inc., Santa Fe Aggregates, Inc., Pyramid Materials, Inc., Teichert Energy & Utilities Group, Inc., Teichert Electrical, Inc., Mathews Readymix, LLC, Spanish Springs Construction, Inc., Teichert Services Group, Inc., Teichert Maintenance & Supply, Inc., Stonebridge Properties, LLC, Teichert Asset Group, Inc, and effective January 1, 2024, Tahoe Pacific Construction, Inc. (participating employers). Excluded employees include leased employees, residents of Puerto Rico, and temporary employees scheduled to work less than 1,000 hours. The Plan allows employees whose compensation and conditions of employment are established by the terms of collective bargaining agreements to participate in the Plan except for the purpose of employer contributions. Other subsidiaries of Teichert, Inc. may adopt this Plan with the approval of the Board of Directors of Teichert, Inc. The Plan is subject to the provisions of ERISA. The Retirement Savings Plan Administrative Committee, appointed by the Board of Directors, is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

**Eligibility**

Employees are eligible to participate in the deferral component of the Plan on the first of the month following 30 days of employment. Long-term part-time employees that work at least 500 hours during three consecutive 12-month plan year periods are eligible to participate in the deferral component of the Plan. Participants are eligible for an employer match contribution component on the first of the month following 90 days of employment, provided they are not part of a collective bargaining agreement. Participants who are not part of a collective bargaining agreement are eligible for the profit-sharing contribution on the date of their employment.

**Employee Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage of their compensation contributed as pre-tax 401(k), after-tax 401(k), or Roth salary deferrals up to the maximum allowed under the IRC. The Plan includes an auto-enrollment provision whereby all newly eligible or rehired employees not under a collective bargaining agreement are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default funds until changed by the participant. The Plan also features automatic escalation whereby employee contributions increase each year by 1% up to a maximum 15% of eligible compensation unless designated otherwise under a salary deferral election.

Participants direct the investment of contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the calendar year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

**Employer Contributions**

The Company and its participating employers may choose to make discretionary matching contributions to eligible Plan participants. The matching contribution rate is determined annually based on a discretionary percentage of the employee's pre-tax and Roth 401(k) contributions. For the year ended March 31, 2024 and the period of April 1, 2024 through December 31, 2024, the employers' matching contribution is 100% of deferrals up to \$500 for Mathews Readymix, LLC union employees. Effective January 1, 2025, this match was revised to be 50% of the first 6% of eligible compensation. The employers' matching contribution for all other companies is 50% of the first 6% of eligible compensation deferred that a participant contributes to the Plan for the years ended March 31, 2025 and 2024. The matching contribution totaled \$3,011,157 and \$2,698,783 for the years ended March 31, 2025 and 2024, respectively.

The employers make a mandatory profit sharing contribution required by the Western Aggregates collective bargaining agreement. Eligible employees received a flat contribution of \$6,000 for the years ended March 31, 2025 and 2024. For the years ended March 31, 2025 and 2024, the mandatory profit sharing contribution totaled \$192,000 and \$198,000, respectively. The employers may also choose to make a discretionary profit-sharing contribution to eligible Plan participants. The discretionary profit-sharing contribution is based upon a participant's eligible compensation in relation to total compensation of all participants eligible to share in the contribution. For the years ended March 31, 2025 and 2024, the employers did not elect to make discretionary profit sharing contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the employer discretionary matching contribution, an allocation of the employer discretionary profit-sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and employer match contributions plus actual earnings thereon. Vesting in the employer profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age while employed by the Company or participating employer or terminates employment from the Company or participating employer due to death or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate charged will be set by reference to the "bank prime rate plus 1%" as reported by the U.S. Federal Reserve on the last business day of the calendar quarter effective for loans made on and after the first business day of the subsequent quarter. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

On termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution or installments. If a participant terminates employment and the participant's vested account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the Participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for in-service distributions (1) if a participant reaches age 59½ and (2) hardship distributions subject to Plan provisions.

**Forfeited Accounts**

Forfeited nonvested accounts are used to pay administrative expenses and to reduce future employer contributions. Unallocated forfeitures totaled \$3,050 and \$4,222 as of March 31, 2025 and 2024, respectively. There were \$8,990 and \$41,139 forfeitures used to reduce employer contributions for the years ended March 31, 2025 and 2024, respectively. There were \$13,738 and \$13,750 of forfeitures used to pay administrative expenses for the years ended March 31, 2025 and 2024, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 or 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through December 2, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Trust Company, LLC, the trustee, and Empower Annuity Insurance Company of America, the insurance company, (collectively referred to as Empower), the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of March 31, 2025 and 2024, and the related activity on the statements of changes in net assets available for benefits for the years ended March 31, 2025 and 2024, and the supplemental schedule of assets (held at end of year) as of March 31, 2025.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at March 31, 2025 and 2024.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust* – Valued based on the NAV of the collective trust fund. NAV is a readily determinable fair value and is the basis for current transactions. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities.

*Pooled Separate Accounts* – Valued daily at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a benefit-responsive group annuity contract with Empower Annuity insurance Company of America (Empower) (previously The Prudential Insurance Company of America). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.5%. Such interest rates are reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive group annuity contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer profit sharing contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been restated since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company (collectively Empower). Empower is the trustee and insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

**NOTE 10 TRANSFER TO (FROM) AFFILIATED PLAN**

The Teichert, Inc. Stock Bonus Plan allows the Plan Sponsor to convert terminated vested participant accounts from the Company common stock account to other investments. Following the conversion, the vested value of the accounts are transferred to this Plan for investment by the participant in a conversion account. During 2025 and 2024, amounts of \$757,159 and \$612,013, respectively, were transferred to this Plan from the Teichert, Inc. Stock Bonus Plan.

**NOTE 10 TRANSFER TO (FROM) AFFILIATED PLAN (CONTINUED)**

In conjunction with the above paragraph, once the participant elects distribution of the vested conversion account, funds are transferred back to the Teichert, Inc. Stock Bonus Plan for payment to the participant. During 2025 and 2024, amounts of \$146,800 and \$92,143, respectively, were transferred out of the Plan to the Teichert, Inc. Stock Bonus Plan.
