Reasonable Cause Statement – Late Form 5500 Filing

FEMA Disaster Declaration 4856 – Los Angeles Fires

The late filing of Form 5500 was due to circumstances beyond the plan administrator's reasonable control as a result of the federally declared disaster related to the Los Angeles fires under FEMA Disaster Declaration 4856.

During the disaster period, the plan administrator and related service providers experienced disruptions that limited access to records and systems necessary to complete and electronically file Form 5500 by the original due date. These conditions materially interfered with timely compliance despite the exercise of ordinary business care and prudence.

The plan administrator has a history of timely Form 5500 filings in prior years. Once normal operations were restored, the plan administrator promptly completed and submitted the required filing.

The delay was not due to willful neglect or disregard of filing requirements. The plan administrator respectfully requests that the late filing be accepted without penalty based on reasonable cause.
