Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fleetwood Group, Inc. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Fleetwood Group, Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of March 31, 2025 and 2024, and for the years ended March 31, 2025 and 2024 stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A: DESCRIPTION OF PLAN

The following description of the Fleetwood Group, Inc. (“Company”) 401(k) Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined-contribution plan covering all employees of Fleetwood Group, Inc. Employees who are at least twenty-one years of age and have completed six months and 1,000 hours of service are eligible on the first entry date of the plan after which the requirements have been achieved. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

Contributions – Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may also contribute voluntary after-tax funds to the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

The Company may make a discretionary matching contributions each year. For the years ended March 31, 2025 and 2024, the Company made a matching contributions of 20% of the first 4% of compensation that a participant contributes to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, the Company’s contributions on behalf of the participant, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in their elective contributions plus actual earnings thereon and any rollover contributions from other plans. Vesting in the Company’s contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 10% vested after one year of service, 20% after two years, and an additional 20% per year for years three through six. A participant is 100% vested after six years of credited service for any discretionary matching contributions. Additionally, a participant is 100% vested when the participant reaches normal retirement age or becomes totally disabled or upon death. Forfeited balances of terminated participants’ non-vested accounts are used to reduce future Company contributions.

NOTE A: DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants – Participants are eligible to borrow up to 50% of their vested account balance (up to \$50,000). The loans are secured by the vested balance in the participant’s account. Loans must be repaid over a period not to exceed five years and will bear interest at a rate that is comparable to other similar loans by independent parties at the time the loan is issued. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s account, or annual installments over a period of years such that the minimum distribution requirements, as defined by the Plan, are met. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows “hardship” withdrawals for participants with immediate financial need.

Forfeited Accounts - At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$8,109 and \$8,154, respectively. These accounts are used to reduce future employer contributions. For the years ended March 31, 2025 and 2024, employer contributions were reduced by \$6,291 and \$3,348, respectively, from forfeited non-vested accounts.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by investment advisors and custodians. See Note E for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 and 2024.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes excess contributions, if any, prior to June 15 of the following Plan year.

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payments of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events – Subsequent events were evaluated through December 18, 2025, which is the date the financial statements were available to be issued.

NOTE C: INFORMATION CERTIFIED BY CUSTODIANS (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at March 31, 2025 and 2024, and related investment income for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (collectively, Principal), which are qualified institutions.

NOTE D: GUARANTEED INVESTMENT CONTRACT

The Plan invests in the Principal Fixed Income Guaranteed Option, a fully benefit-responsive investment contract totaling \$0 and \$480,164 for 2025 and 2024. The average yield and crediting interest rates for 2024 was approximately 1.68%. During the year ended March 31, 2025, the Plan transferred investments in the Principal Fixed Income Guaranteed Option to other investment options.

Interest rates are established and declared for new contributions that will be received in the six months December – May and June - November. The rate is based on the return Principal expects on new investments made by it and held within the account, and it will always equal or exceed the contractually guaranteed rate.

All contributions received during the six month period will earn the declared interest rate until the end of the period.

At the beginning of each period, a new interest rate is established and declared. This rate is based on past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments.

All benefit responsive payments (as outlined in the Contract) made prior to Contract liquidation are made at book value (principal invested plus interest earned).

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as presented to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement with the consent of the issuer.

NOTE E: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ACS 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets and liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Collective investment trusts: Valued using the net asset value (NAV) provided by the administrator of the fund. The NAV, as provided by the administrator, is used to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund. Participant transactions (purchases and sales) may occur daily. Collective investment trusts are classified in Level 2 of the fair value hierarchy.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded and are classified in Level 1 of the fair value hierarchy.

NOTE F: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are held in a guaranteed investment contract maintained by Principal Life Insurance Company and Principal Trust Company (collectively, Principal). Principal provides custodian and record-keeping services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid to Principal for services amounted to \$21,855 and \$32,232 for 2025 and 2024, respectively. The Plan has other service providers, and such parties are parties-in-interest under ERISA.

NOTE G: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the provisions of the Plan to terminate the Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of a Plan termination, participants would become fully vested in their employer contributions.

NOTE H: REPORTABLE TRANSACTIONS

In order to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, it is necessary to provide a schedule of reportable transactions. However, for the year ended March 31, 2025, there were no reportable transactions, and accordingly, no schedule is provided.

NOTES TO FINANCIAL STATEMENTS**

NOTE I: TAX STATUS

The Plan is a non-standardized pre-approved plan sponsored by Principal Life Insurance Company. The pre-approved plan has received a favorable opinion letter from the Internal Revenue Service stating that the pre-approved plan, as designed, qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

The Plan has been amended since receiving the favorable opinion letter. However, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE J: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE K: PLAN AMENDMENTS

There were no significant plan amendments adopted by the Plan for the years ending March 31, 2025 and 2024.
