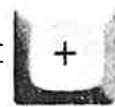

## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Building Service Employees Insurance  
Health and Welfare Fund

### **Opinion**

We have audited the accompanying financial statements of Building Service Employees Insurance Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Building Service Employees Insurance Health and Welfare Fund as of March 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Building Service Employees Insurance Health and Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Building Service Employees Insurance Health and Welfare Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

NOTE A – DESCRIPTION OF PLAN

The following description of the Building Service Employees Health and Welfare Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Fund's provisions.

General -The Plan provides health and dental benefits covering qualified members of the Building Service Employees Union. Members are eligible to participate in the Plan the first day of the month following 60 days of employment with a participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides for and maintains health, hospitalization, medical and dental benefits covering members of the union who meet the qualifications of the Plan. The benefits are fully covered by insurance.

Contributions – The Plan document provides that the participating employers make monthly contributions to the Fund for a specified amount for each worker as specified in the collective bargaining agreement.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements have been prepared on the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Estimates - The preparation of financial statements may require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fixed Assets - Fixed assets are stated at cost. Depreciation is provided using the straight-line method over the estimated useful lives of the assets. Additions and betterments are capitalized, while routine repairs and maintenance are expensed as incurred.

Payment of Benefits – Health claims and premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Administrative Expenses- All administrative expenses of maintaining the Plan are paid by the Plan.

Cash – Cash in the Plan consists of cash held in a non-interest bearing bank account.

NOTE B – SUMMARY OF ACCOUNTING POLICIES (Continued)

Subsequent Events - The Plan's management evaluated the need for disclosures and/or adjustments resulting from subsequent events through December 19, 2025, the date on which the financial statements were issued.

NOTE C – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter, from the Internal Revenue Service, and the Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

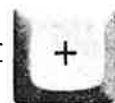
Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D – RISK AND UNCERTAINTIES

If the Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE E – TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Board of Trustees has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

Financial instruments that potentially subject the Fund to concentrations of credit risk consist principally of cash and cash equivalent accounts in financial institutions. Cash and cash equivalents exceeding federally insured limits totaled \$363,387 at March 31, 2025 and \$404,013 at March 31, 2024.
