Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Visiting Nurse Association of Southeast Missouri Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

General

The following description of Visiting Nurse Association of Southeast Missouri Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Visiting Nurse Association of Southeast Missouri, Inc. (the Company) for the benefit of its employees who meet the eligibility requirements set forth in the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Capital Bank and Trust Company serves as plan trustee.

Eligibility

The Plan covers all employees of the Company who are age 18 or older and have worked 650 hours or more within the six-month period following date of hire, with quarterly entry dates. For employees who do not meet the Plan's eligibility requirements during their initial six months of employment, subsequent plan eligibility entry is based upon completing a year of service (1,000 hours worked) during a plan year.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual pretax or Roth contributions up to the maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted. The Company may make discretionary matching or profit-sharing contributions as determined by the Company's Board of Directors. To receive an employer matching or profit-sharing contribution, an employee must be employed on the last day of the plan year and must have completed a year of service (as defined by the Plan) during the plan year unless termination was due to certain waiver conditions. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after five years of credited service.

Forfeited Accounts

Forfeited nonvested balances totaled \$4,630 and \$4,565 at June 30, 2025 and 2024, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. Forfeitures of \$0 and \$381 were applied toward plan expenses during the plan years ended June 30, 2025 and 2024, respectively. No forfeitures were used toward employer contributions for the plan years ended June 30, 2025 and 2024. The forfeiture balance of \$4,630 at June 30, 2025, was reallocated in September 2025 as an employer matching contribution based upon each eligible participant's pro rata share of participant contributions for the plan year ended June 30, 2025.

Payment of Benefits

Upon termination of service, an employee may elect to receive a lump-sum amount equal to the value of his account, a single-sum distribution of a portion of his account, or installments for a specified term. Participants with account balances not exceeding \$1,000 receive an automatic distribution of that balance without consent. Balances greater than \$1,000 but not exceeding \$5,000 (limit increased to \$7,000 effective December 31, 2023) are rolled over to an individual retirement account as designated by the Company, absent an election by the participant for distribution. Withdrawals for reasons other than termination are permitted under circumstances provided by the Plan.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by promissory notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on the prime rate published in the *Wall Street Journal* on the first business day of each month plus 1%.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan is considered to be in default if a participant fails to make all or any part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment was due. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan has unallocated plan expense accounts to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Company is responsible for determining what expenses the third-party administrator will reimburse from the accounts. All funds utilized from these accounts are treated as administrative expenses on the statements of changes in net assets available for benefits.

During the years ended June 30, 2025 and 2024, additions to the accounts from revenue sharing were \$20,484 and \$15,950, respectively, expenses paid from the accounts were \$17,700 and \$15,255, respectively, and reallocations to participants were \$0 and \$468, respectively. The balance in unallocated accounts at June 30, 2025 and 2024, was \$4,604 and \$1,618, respectively, and is included in the mutual funds balance on the statements of net assets available for benefits.

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2025 and 2024.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of June 30, 2025.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended June 30, 2025 and 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and are valued at the net asset value (NAV) of shares held by the Plan at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by The American Funds Group, which is an affiliate of Capital Bank and Trust Company (CB&T). CB&T is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly any other fees related to the Plan's operations.

The Plan paid \$1,750 and \$2,289 of direct recordkeeping fees to Capital Group Retirement Plan Services, an affiliate of CB&T, during the years ended June 30, 2025 and 2024, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, affected participants would become 100% vested in their employer contribution accounts.

Note 9. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by Capital Group Retirement Plan Services. This profit-sharing plan document has been pre-approved by the Internal Revenue Service according to an advisory letter dated June 30, 2020. The Plan has not obtained or requested a determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Subsequent Events

Subsequent events have been evaluated through January 5, 2026, which is the date the financial statements were available to be issued.
