Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Retirement Savings Plan for ELGI Compressor USA, Inc. (the “Plan”) as of and for the year ended March 31, 2025, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan’s internal control over financial reporting (internal control) as a basis for designing our auditing procedures for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and, therefore, there can be no assurance that all such deficiencies have been identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the plan’s financial statements will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in Retirement Savings Plan for ELGI Compressor USA, Inc.'s internal control to be significant deficiencies:

During our testing of employee contributions, we noted two payroll dates where the funds withheld from participants' accounts were not timely deposited. The first deposit in the amount of \$7,027.43 for pay date April 5, 2024 for Patton's Medical was not deposited until July 11, 2024. The second deposit in the amount of \$9,348.94 for pay date May 30, 2024 for Patton's Inc was not deposited until June 21, 2024. The Department of Labor requires that employee contributions be deposited as soon as is "reasonably possible," but no later than the 15th business day after the withholding month. We recommend management implement policies and procedures to ensure the timeliness of deposits and reconciliation between payroll deductions and plan administrator balances. This may include implementing automated alerts for deposits, integration between payroll and the third party plan administrator, regularly reviewing the deposit history to identify potential issues and improving reconciliation processes.

As part of testing of deposits to the trust account, we noted a deposit made on May 3, 2024 affecting 5 participants' accounts that did not correlate with any payroll reports. The amount was subsequently refunded two months later on July 3, 2024. In order to prevent and detect erroneously deposits from being made, we recommend that management review and reconcile the payroll deductions to deposits to the trust account on a timely basis for each pay period.

During our testing of employee contributions, we noted that the 401k deduction for a participant was computed on wages in excess of gross wages. While the 401k deduction per payroll report was the amount deposited in his or her participant account, the computation of the 401k deduction was in error as it included wages for hours of military leave that were not actually paid as confirmed by the company's payroll specialist. We also noted that for the same participant for one pay period the match was also computed on the military leave hours that were unpaid. We recommend management implement policies and procedures to review the mapping of the payroll reports for gross wages used for 401k computations to ensure they are correct and consistent with company and plan policy.

During our testing of participant data, we noted two instances where the payroll and benefits specialist was unable to provide a source document to verify the employee's date of birth. We recommend that the Company enhance its existing processes to maintain and retain documentation in employee files in a secure and centralized location to support plan operations.

The Company does not have sufficient resources to prepare the Plan's financial statements. As a result of a lack of resources, the financial statements were prepared by us.

This report is intended solely for the information and use of the management and board of directors of your organization.

The foregoing conditions were considered in determining the nature, timing and extent of audit tests to be applied in our examination of the financial statements, and this report of such conditions does not modify our reports on such financial statements.
