Note A – Description of Plan

The following brief description of the Safelite Group Associates' Retirement Savings Plan (the "Plan") is provided for general information purposes. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General Information

The Plan, originally established on January 1, 1992, is a defined contribution plan available to nonunion employees of Safelite Group, Inc. (the Plan Sponsor and Company). Employees become eligible to participate in the Plan upon reaching age 18 and completing 30-days of service, as defined by the Plan. Eligible employees may begin participating in the Plan on the first day of the month coinciding with or next following the date participants satisfy eligibility requirements. The discretionary employer matching contributions follow the same eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is qualified under the Internal Revenue Code (the "Code").

Contributions

Each year, participants may elect to defer pre-tax contributions up to the maximum allowed by the Internal Revenue Service ("IRS"). Participants that are age 50 or older and make the maximum allowable deferral to the Plan are entitled to contribute an additional catch-up contribution. Participants may direct investment of their account balances into various investment options offered by the Plan.

The Plan has automatic enrollment for all employees who meet the eligibility requirements. An automatic deferral pre-tax election of 3% is withheld if an election is not made by the date the participant becomes eligible. The automatic deferral election increases by 1% annually until the annual IRS maximum contribution limit is reached.

The Plan provides for the Company to make discretionary matching contributions. The Company will make discretionary matching contributions equal to 50% of participant elective deferrals, up to 8% of eligible compensation for all participants that have met the eligibility requirements. The Company's discretionary matching contributions for the year ended December 31, 2024 were \$18,883,719.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, plan earnings, and expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note A – Description of Plan (Continued)

Vesting

Participants are immediately vested in their elective deferral contributions and rollovers, plus any earnings thereon. Effective September 1, 2020, employer matching contributions are 0% vested prior to three years of service and 100% vested after three years of service.

For participants who terminated prior to September 1, 2020, employer matching contributions vest as follows: less than two years of service - 25%, more than two years of service, but less than five years of service - 60%, and five or more years of service - 100%. For all other participants, employer matching contributions earned prior to September 1, 2020, vest as follows: less than two years of service - 25%, more than two years of service, but less than three years of service - 60%, and three or more years of service - 100%.

Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) 50% of their vested account balance or (2) \$50,000 reduced by the excess, if any, of the participants highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan. Loan terms range from 1-5 years and cannot exceed 5 years unless the loan is for the purchase of a participant's principal residence, in which case the loan term can be up to 15 years.

The loans are secured by the vested balance in the participant's account. The loans are charged a commercially reasonable rate of interest based on interest rates charged for similar types of loans by other lenders, which currently range from 4.25% to 10.50% on outstanding loan balances at December 31, 2024. A participant may only have one loan outstanding at any time. Principal and interest is paid ratably through regular payroll deductions.

Payment of Benefits

Participants become eligible for benefit payments upon retirement, termination of employment, disability or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 59½ and after their account is fully vested. Participants may also receive distributions from the employee deferral or rollover balance for qualified financial hardships. Distributions may be made as a single lump sum payment, partial withdrawals of at least \$500 or installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary). Vested account balances that do not exceed \$7,000 may only be distributed in a single lump sum payment.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in all amounts in their account, including employer matching contributions and earnings thereon.

Forfeitures

Forfeitures resulting from the non-vested portion of participants' accounts who terminate prior to being fully vested are generally used first to pay any administrative expenses of the Plan. Any remaining forfeitures will be used to reduce employer matching contributions. As of December 31, 2024 and 2023, forfeited accounts totaled \$1,268,874 and \$2,250,715, respectively.

During 2024, \$541,102 of forfeitures were used to pay plan expenses, and \$4,695,904 of forfeiture were applied to reduce the employer matching contributions.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable or distributions from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation of fair value in investments. Administrative expenses paid by the Plan were \$1,784,908 for the year ended December 31, 2024.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments are recorded when approved. There were no approved but unpaid distribution requests at December 31, 2024 or 2023.

Note C – Investments (Information Certified By the Plan Trustee)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company at December 31, 2024 and 2023, and for the year ended December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note D – Fair Value Measurements

Accounting Standards Codification Topic 820, *Fair Value Measurements* ("ASC Topic 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets of the Plan:

- **Mutual funds (Level 1)** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Common collective trusts** – Investments in collective funds are valued based upon the redemption price of units held by the Plan. Unit values are determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates to obtain the investment's NAV. The Plan uses these NAVs as a practical expedient to determine the fair value of its investments in collective funds, so these investments are not classified within the fair value hierarchy. Investments in collective funds do not have a holding period and there are no unfunded commitments.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Tax Status

The Plan uses a non-standardized prototype plan document sponsored by The Vanguard Group. The Vanguard Group received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code, and therefore, the related trust is tax-exempt. The Plan Sponsor has determined that it is eligible for, and has chosen to rely on, the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator and the Plan's legal counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) of the Plan if the Plan has taken an uncertain tax position that is more likely than not to not be sustained upon examination by the IRS. There were no uncertain tax positions as of December 31, 2024 or 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note F – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note G – Parties-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Note G – Parties-In-Interest Transactions (Continued)

Certain plan investments are mutual funds managed by Vanguard Fiduciary Trust Company, the trustee, as defined by the Plan, and qualifies as a party-in-interest. The Plan also issues loans to participants, which are secured by the balances in the participants' accounts.

Certain administrative expenses are provided by the Company at no cost to the Plan and certain administrative expenses of the Plan are paid by the Company.

Fees paid by the Plan to Vanguard Fiduciary Trust Company for investment management services amounted to \$1,277,710 and \$918,635 for the years ended December 31, 2024 and 2023.

Note H – Subsequent Events

In connection with the preparation of the Plan's financial statements for the year ended December 31, 2024, events and transactions subsequent to December 31, 2024 through September 30, 2025 have been evaluated by the plan administrator for possible adjustment and/or disclosure.

As of the date of our report, the compliance testing for plan year ended December 31, 2024 was not finalized. The Company and the plan administrator are not aware of and do not anticipate any compliance issues based on the preliminary compliance testing results. The Company and plan administrator recognize that the final results could differ from the preliminary results, which may impact amounts reported and disclosed within the Plan's financial statements for the year ended December 31, 2024. Management expects that if compliance issues do arise, that any such issues will be resolved in a timely manner.

No additional subsequent events requiring financial statement adjustment and/or disclosure have been identified.
