Independent Auditor's Report

To the Plan Administrator and
Plan Participants of the Klarna 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Klarna 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Klarna 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Klarna 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Klarna 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

General

The following description of the Klarna 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan was established on January 1, 2015. The Plan is a defined contribution plan covering all employees who are employed by Klarna, Inc. (the “Company” or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Employees become eligible to participate in the Plan upon attaining age 21 and are eligible to enter the Plan on the first day of the month coinciding with the date the eligibility requirement is satisfied. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 6% deferral rate unless they affirmatively elect not to participate.

In conjunction with the Plan document amendment and restatement effective April 1, 2024, the Plan added an automatic escalation feature. Under this provision, participant deferral rates will automatically increase by 1% of compensation each year, up to a maximum deferral rate of 10% of compensation. The initial automatic increase will be applied as of the first payroll period beginning after the period in which the initial deferral amount is first withheld, with subsequent increases occurring at the beginning of each Plan Year.

Contributions

Participants may contribute to the Plan each year through elective deferrals of eligible compensation, subject to the limitations imposed by the Internal Revenue Code (the “Code”). Participants may also contribute amounts representing eligible rollover distributions from other qualified plans. Participants direct the investment of their contributions among the investment options offered by the Plan. For elective deferrals made by participants, the Company may make a flexible discretionary matching contribution equal to a uniform percentage of participant deferrals based on plan-eligible compensation. The matching contribution percentage is determined by the Company at the beginning of each plan year and was 50% of participant deferrals, up to 6% of eligible compensation, for the years ended December 31, 2024 and 2023.

In addition, the Company may make discretionary non-elective contributions. No discretionary non-elective contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant contributions, Company contributions, rollovers, an allocation of the Plan’s net earnings or losses and administrative expenses. Allocations are based on participant earnings, losses or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. A participant may authorize transfers among investment options at any time.

Vesting

Participants are immediately 100% vested in their voluntary contributions, including rollover contributions, and the related earnings. Company flexible discretionary matching contributions and the related earnings are also 100% vested upon contribution. Vesting in the Company's discretionary non-elective contributions, including related earnings, is based on years of continuous service and is subject to the following vesting schedule:

1	25%
2	50%
3	75%
4	100%

Participants also become fully vested upon termination due to retirement, death, or disability, or if the Plan is terminated. Non-vested benefits are forfeited upon termination for reasons other than normal retirement, death, or disability.

Payment of Benefits

On termination of service due to death, disability, retirement or attainment of age 59 1/2 (in-service distribution), a participant or his/her beneficiary may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or annual installments under a systematic withdrawal plan.

Participants may withdraw up to 100% of their elective accounts in the event of undue financial hardship as provided for in the Plan document.

Forfeited Accounts

Non-vested account balances are generally forfeited either upon full distribution of vested balances or completion of five consecutive years of breaks in service, as defined by the Plan document. Forfeitures are used to reduce Company contributions or to pay reasonable expenses of the Plan.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33,465 and \$4,809, respectively. During 2024 and 2023, forfeitures of \$11,540 and \$233,111, respectively, were applied to reduce the Company's flexible discretionary matching contributions or to pay reasonable Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum of \$50,000. The number of outstanding loans is limited to one per participant. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local and prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at

least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time. The Company has the right at any time, by action of its Board of Directors, to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

As part of a company restructuring, employees were terminated at various times throughout 2024. The total number of terminated participants exceeded 20% of Plan participants; accordingly, the Plan Sponsor determined that a partial plan termination occurred during the year. All participants affected by the terminations were fully vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Net Appreciation/Depreciation in Fair Value of Investments

Net realized and unrealized appreciation/depreciation are recorded in the accompanying statements of changes in net assets available for benefits as net appreciation in fair value of investments.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation or (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants, and the related flexible discretionary matching contributions from the Company, are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are recorded at the unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related loan fees are recorded as administrative expenses and are expensed as incurred.

Under certain circumstances, participant loans in default may be considered distributions from the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Brokerage fees, management fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be. Fees related to the administration of notes receivable from participants are allocated directly to the participant responsible for the expense.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds fair values are determined utilizing quoted market prices reported on the active market on which they are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Unaudited Information Certified by the Plan Trustee

All investment information disclosed in the accompanying financial statements and supplemental schedule of assets (held at year end), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was prepared by or derived from information certified by Reliance Trust Company (the "Trustee") and furnished to the plan administrator. The plan administrator has obtained certification from the Trustee that such information is complete and accurate with the meaning of CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

5. Tax Status

The Plan sponsor adopted a non-standardized pre-approved plan document. The IRS has determined and informed the pre-approved plan sponsor, by an opinion letter dated on June 30, 2020, that the pre-approved plan document is designed in accordance with applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan was not in compliance with certain provisions of the Plan document and Code. Plan management intends to take necessary corrective action to maintain the tax qualified status of the Plan; therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effect of a tax position is recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Parties-in-interest Transactions

T. Rowe Price Retirement Services is the Plan's recordkeeper, and thus is considered a party-in-interest. The Plan includes multiple investments that are managed by T. Rowe Price, recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan. These transactions qualify as party-in-interest transactions.

Notes receivable from participants, along with the related interest income, are also classified as party-in-interest transactions.

7. Prohibited Transaction

During 2024, 2022, 2021, 2020, and 2019 the Plan Sponsor erroneously remitted employees' deferral and loan repayments for several payroll periods to the Plan later than prescribed by the Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Plan Sponsor is in process of correcting these delinquent participant contributions with lost earnings.

8. Subsequent Events

Subsequent events have been evaluated through December 22, 2025, the date the financial statements were available to be issued.
