Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Jazwares, LLC Safe Harbor 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of Jazwares, LLC Safe Harbor 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Jazwares, LLC and subsidiaries (the "Company") and participating employers who have three months of service and are age 21 or older. Participating employers include First Act, LLC, Wicked Cool Toys, LLC, Kelly Toys Holdings, LLC, Kelly Amusement Holdings, LLC and Z Global Logistics, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Company management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Company has entered into an agreement whereby, John Hancock Life Insurance Company (USA) (the "Custodian") has been appointed the Custodian of the Plan's assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan.

On January 17, 2024, the Company's board of directors resolved to become a participating employer in the Mercer Wise Pooled Employer Plan ("Mercer Plan"), a pooled employer plan. Effective April 16, 2024, the Plan was frozen and merged into the Mercer Plan. On such date effective with the merger, approximately \$24,685,000 in Plan assets were transferred out of the Plan to the Mercer Plan, including approximately \$379,000 in John Hancock Stable Value Fund assets which were reregistered to the Mercer Plan effective April 16, 2024. Accordingly, as of April 16, 2024, the Plan no longer held any assets.

Contributions:

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes safe harbor matching contributions of 100% of the first 3%, plus 50% of the next 2%, of Plan compensation that a participant contributes to the Plan. Additional discretionary amounts may be contributed at the option of the Company. The Company did not make any discretionary employer contributions to the Plan with respect to the Plan for the period from January 1, 2024 through April 16, 2024. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Contributions into the Plan ceased effective April 16, 2024.

During 2022, the Company identified that for the plan years ended December 31, 2021, 2020 and 2019, certain plan compensation for certain employees had been excluded in error from the calculation of allowable employee contribution deferrals, and consequently employer matching contributions. Accordingly, in 2023, the Company contributed on behalf of the affected employees a portion of the amounts that would have been deferred by those employees on such plan compensation and matched the employee contributions that should have been deferred 100%, plus contributed lost earnings calculated thereon. A total of approximately \$583,000 was contributed by the Company in 2023 for such amounts. Such amount was accrued as Employer contributions receivable at December 31, 2023, in the accompanying Statement of net assets available for benefits.

1. Description of Plan (continued)

Participant accounts:

Each participant's account is credited with the participant's contributions, safe harbor matching contributions, as well as allocations of the Company's discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

As of April 16, 2024, 100% of the Plan's net assets were transferred to the Mercer Plan. Any participant account activity subsequent to April 16, 2024 was transacted under the Mercer Plan.

Vesting:

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service, in which a participant is 100% vested after six years of credited service.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined by the Company. Principal and interest are paid ratably through payroll deductions. As of April 16, 2024, 100% of the Plan's net assets were transferred to the Mercer Plan.

Payment of benefits:

On termination of service due to death, disability, retirement, or termination of employment, a participant or their beneficiary may receive the value of the participant's vested account balance as a lump sum distribution.

Forfeited accounts:

Forfeited non-vested account balances may be used to pay administrative expenses or reduce discretionary employer contributions. At April 16, 2024, forfeited non-vested accounts totaled \$3,600. At December 31, 2023, there were no forfeited non-vested accounts. For the period from January 1, 2024 through April 16, 2024, there were no forfeited non-vested account balances used to reduce discretionary employer contributions.

SECURE Act 2.0:

On December 29, 2022, the Setting Every Community Up for Retirement Act ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act, 2023. The SECURE 2.0 Act includes numerous reforms to retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules. As of April 16, 2024, and through December 23, 2025, the date the financial statements were available to be issued, Plan management believes Plan provisions conform with required SECURE 2.0 regulations, and it is the intent of Plan management to amend Plan provisions in the future, as needed.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

2. Summary of Accounting Policies (continued)

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes receivable from participants:

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through December 23, 2025, the date the financial statements were available to be issued.

3. Information Certified by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule of assets held at end of year, including investments and notes receivable from participants held at April 16, 2024 and December 31, 2023, and net appreciation in fair value of investments and dividends and interest income for the period from January 1, 2024 through April 16, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Pooled separate accounts – Pooled separate accounts are valued on a net unit basis on the last business day of the plan period. The fair values of these investments are determined by reference to the respective pooled separate account's underlying assets, with the Custodian specifying the source(s) used for underlying investment asset prices. In the event that a pooled separate account's initial valuation is not deemed reasonable, the Custodian may make adjustments to achieve a value believed to be more reflective of fair value.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023, for investments measured at fair value on a recurring basis.

5. Related Party Transactions

Certain Plan investments and related transactions were in investment funds managed by the Plan's Custodian and, therefore, these investments and transactions qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Effective April 16, 2024, the Plan was merged into the Mercer Plan and 100% of the Plan's net assets, totaling \$24,685,000 were transferred out of the Plan to the Mercer Plan. Accordingly, as of April 16, 2024, the Plan no longer held any assets.

7. Tax Status

The Company has adopted a prototype plan document that has received a favorable tax determination letter from the IRS dated June 30, 2020, stating that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan itself has not received a determination letter and the prototype plan has been amended since receiving that determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of net assets available for benefits.

The Plan filed the April 16, 2024 Form 5500 without the inclusion of the audited Plan financial statements. As a result, the Plan was not in compliance with the related filing requirements. Plan management has advised the Department of Labor ("DOL") that the Form 5500 will be amended to include the audited financial statements as soon as practicable. Plan management does not believe any potential penalties or resulting actions by the DOL will have a material effect on the financial condition of the Plan.



