#### Note 1. Description of Plan

The following description of Wayne's Electric, Inc. 401(K) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General:

The Plan is a defined contribution plan covering all employees of the Company who become immediately able to participate in the Plan upon employment. The Plan is subject to the provisions of ERISA. The Board of Trustees is responsible for oversight of the Plan. The investment fiduciary determines the appropriateness of the Plan's investment offerings, monitors investment performance, oversees participant investment cost benchmarks, and reports to the Plan's Board of Trustees.

##### Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation to a traditional plan as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to 100% of the Participant's "effectively available Compensation" (i.e. Compensation available after other withholding) subject to the statutory limits in Treasury Regulation Section 1.414-1(b)(1)(i). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor may elect to make a non-discriminating employer match at the option of the Board of Directors. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. During the year ended March 31, 2025 the Company made no additional employer matching or profit-sharing contributions. Contributions are subject to certain IRS limitations.

##### Participant accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (continued)

Vesting:

Participants are vested immediately in their contributions and employer matching contributions.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amounts equal to the value of the participant's vested interest in his or her account, or annual installments over a designated time period through an annuity.

Forfeited accounts:

At March 31, 2025, forfeited nonvested accounts totaled \$0. These accounts will be used to reduce future employer contributions and administrative expenses.

Basis of Accounting:

The financial statements of the Plan are prepared in accordance with Generally Accepted Accounting Principles.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Accounting Policies

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Fiduciary determines the plan's valuation policies utilizing information provided by the investment advisor, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Accounting Policies (continued)

Notes Receivable from Participants:

Participants may borrow from their fund accounts to the extent that such loan when added to the outstanding balance of all other loans to the participant does not exceed the lesser of (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made over the outstanding balance of plan loans on the date the loan is made, or (b) one-half the present value of the participant's vested interest in their account. The minimum loan a participant is eligible to take is \$1,000. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is established at a fixed rate by the Plan Administrator based on interest rates being charged on similar bank loans. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. At March 31, 2025, there were \$10,507 in participant loans that were reduced and recorded as benefit payments.

Payment of Benefits:

Benefits are recorded when paid. At March 31, 2025, there was \$539,377 in benefits paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

The Plan has evaluated subsequent events through January 15, 2025, the date the financial statements were available to be issued.

Note 3. Related-Party Transactions and Party in Interest Transactions

At March 31, 2025, there were \$7,080 in outstanding participant loans receivable to the officer-stockholder of the Plan sponsor.

Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the year ended March 31, 2025, as described in Note 2, the Plan made a direct payment to the third-party administrator of \$1,087 which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operations.

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

---

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

Level 2. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Fidelity Investments totaling \$114 and \$130 as of March 31, 2025, and 2024, respectively. Fidelity Investments maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is declared at the beginning of each year. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Fidelity Investments, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 7. Tax Status

The IRS has determined and informed the Company by a letter dated January 01, 2021, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Code. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
