To Whom It May Concern:

I am writing to request penalty relief for the late filing of the Form 5500 for the plan year ending December 31, 2024. The late filing resulted from an administrative transition that occurred during the year. Specifically, we hired a new Director of Finance and Operations, but due to an oversight, her information was not updated in the system to designate her as the plan administrator. As a result, she did not receive the filing notifications, and the deadline passed without our awareness.

Once we discovered the oversight, we immediately took corrective action. The new Director of Finance and Operations has now been properly added as the plan administrator, and she has been informed of her responsibilities related to the Form 5500 filing process. The 2024 Form 5500 has now been filed.

To prevent future occurrences, we have implemented internal procedures to ensure that plan administrator information is reviewed and updated promptly whenever staffing changes occur. Additionally, we have reinforced our internal compliance calendar and assigned clear responsibility for monitoring filing deadlines.

Because the late filing was the result of an unintentional administrative error during a staffing transition, and not due to willful neglect, we respectfully request that the associated penalties be waived.
