We have performed audits of the financial statements of the Calcium + Company, LLC 401(k) Plan (formerly the Calcium USA 401(k) Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Calcium + Company, LLC 401(k) Plan (formerly the Calcium USA 401(k) Plan) (the Plan) provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Calcium + Company, LLC (formerly Independence HealthCom Strategies Group, LLC d/b/a Calcium USA, LLC) (the Company or the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective October 1, 2024, the volume-submitter plan document was restated and readopted by the Employer. As part of the restatement, the name of the Employer was changed from Independence HealthCom Strategies Group, LLC d/b/a Calcium USA, LLC to Calcium + Company, LLC and the name of the Plan was changed from the Calcium USA 401(k) Plan to the Calcium + Company, LLC 401(k) Plan.

Eligibility: To be eligible for participation in the Plan and participate in employer contributions, an employee must be at least 21 years old. Certain employees are excluded from the Plan due to their employment classification, as defined in the Plan.

Contributions: Participants may make before-tax contributions and Roth contributions to the Plan by means of a compensation deferral agreement. Participants can contribute from 1% to 92% of their earnings, subject to certain limits that are set forth by the Internal Revenue Code (IRC). The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions in accordance with Code Section 414(v).

The Employer makes safe harbor matching contributions under the Plan of 100% of the first 3% and 50% of the next 2% of a participant's before-tax and Roth contributions up to 5% of the participant's compensation for the plan year.

The Plan allows for the Employer to make discretionary profit-sharing contributions to eligible participants. There were no discretionary profit-sharing contributions made for the year ended December 31, 2024.

Participants may direct their contributions and any related earnings into investment options.

Vesting: Participants' and safe harbor matching contributions and related earnings are fully vested. Profit sharing contributions are subject to a three-year graded vesting schedule. Also, participants who reach age 55, die, become disabled or die while performing qualified military service while employed are fully vested in profit sharing contributions regardless of service time with the Employers.

Benefits: Benefits equal to the vested value of the participant's account are payable upon retirement, termination, permanent disability, or death. Partial or full withdrawals of the participant's account balance are also available under certain circumstances as described in the Plan. Benefits are paid in the form of a lump-sum payment or installments.

Under the Plan, a participant who is an employee may, at any time, withdraw his or her rollover contributions plus earnings on those contributions. Additionally, a participant who is an employee and who has attained age 59-1/2 may withdraw all or part of his or her before-tax, Roth, matching, and earnings on those contributions. Before-tax and Roth contributions may be withdrawn by a currently employed participant under age 59-1/2 only in the case of hardship as determined by the plan administrator. Other withdrawal provisions apply to certain participants, as required by law.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Forfeitures: Forfeitures of terminated participants' nonvested accounts are used to reduce future employer retirement contributions or administrative expenses. At December 31, 2024 and 2023, forfeitures of \$24,005 and \$2,649 were available to reduce future contributions, respectively. Forfeitures applied against employer retirement contributions or administrative expenses for the year ended December 31, 2024 were \$6,351.

Notes Receivable from Participants: Participants may borrow up to lesser of \$50,000 or 50% of their vested account balance with a minimum note amount of \$1,000. Notes are repayable through payroll deductions. The repayment period is generally up to five years. However, if the note is for the purchase of a primary residence, the repayment period is up to 15 years. The interest rate is determined by the plan administrator based on prevailing market conditions and is fixed over the life of the note.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Employers' contributions and (b) Plan earnings/(losses). Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Plan Termination: Although the Employer has not expressed any intent to do so, the Employer reserves the right to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA and the Internal Revenue Code (IRC). In the event of Plan termination, employees will become 100% vested in their account balances and the Plan's net assets would be distributed according to each participant's account balance.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Expenses: Certain administrative expenses of the Plan are paid by the Employer. Certain recordkeeping and trust fees are paid by the Plan. Loan origination fees associated with the notes receivable from participants are included in the amount of the initial loan withdrawal. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income (loss) reported by the Plan.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Benefit Payments: Benefits are recorded when paid.

Risk and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants: Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 4 for a discussion of fair value measurements.

Purchases of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and notes receivable from participants as of December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

NOTE 4 – FAIR VALUE OF INVESTMENTS

Fair value is defined as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 – FAIR VALUE OF INVESTMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair value of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 Inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured at fair value on a reoccurring basis as of December 31, 2024 and 2023 are summarized below.

NOTE 5 – UNALLOCATED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds fully benefit-responsive unallocated investment contracts with MassMutual (Issuer). MassMutual maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contracts. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 1%. MassMutual's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The contract value of the Plan's fully benefit-responsive investment contracts was \$84,782 and \$57,430 as of December 31, 2024 and 2023, respectively.

The Plan's investment contracts specify certain conditions under which distributions from the contracts would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contracts limit the circumstances under which the Issuer may terminate the contracts. Examples of circumstances which would allow the Issuer to terminate the contracts include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contracts at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the volume-submitter plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original volume-submitter plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to federal income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. At December 31, 2024 and 2023, the investment contract is managed and issued by Empower and MassMutual, respectively, therefore, this investment and the Plan's payment of fees to Empower qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some professional fees for the administration and audit of the Plan are paid directly by the Company.
