## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Alpine Power Systems, Inc. Employee 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of March 31, 2025 and 2024 and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alpine Power Systems, Inc. Employee 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

## NOTES TO FINANCIAL STATEMENTS

March 31, 2025 and 2024

---

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Alpine Power Systems, Inc. Employee 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit-sharing plan covering all full-time employees of Alpine Power Systems, Inc. (the Company) who are 21 years of age or older except residents of Puerto Rico. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Plan provisions allow for automatic enrollment of eligible employees at a deferral rate of 6% of pre-tax annual compensation, as defined by the Plan. Participants may elect to contribute up to a maximum of 75% of their eligible compensation, as defined by the plan, subject to regulatory limitations. The Plan allows elective deferral contributions to be made as Roth contributions in the same manner as pre-tax deferrals except on an after-tax basis. Plan provisions allow for participants who have attained age 50 before the end of the plan year to make catch-up contributions. The employer match and profit-sharing portions of the Plan are discretionary and are determined by the Company's management. For the year ended March 31, 2025, the Company's contributions to the Plan were 50% of each eligible participant's applicable contributions, not to exceed 4% of the participant's compensation.

#### Forfeitures

If an employee terminates before his or her matching and non-elective contribution accounts have become fully vested, such portions are forfeited. Forfeitures may first be used to pay administrative expenses. Any remaining forfeitures will be used to reduce the Company's future contributions. For the year ended March 31, 2025, forfeitures used to reduce the Company's contributions totaled \$6,195. As of March 31, 2025 and 2024, forfeited non-vested accounts totaled \$16,892 and \$6,024, respectively.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear reasonable interest rates. Principal and interest are paid ratably through payroll deductions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are participant-directed.

## Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts is based on years of service as follows:

A participant's account becomes 100 percent vested at the time he or she attains early retirement age of 59-1/2 or normal retirement age of 65 while an employee at the Company.

## Payment of Benefits

On termination of service or retirement, the participant will receive partial withdrawals or one lump-sum cash payment equal to the vested interest in his or her account. Generally, all participants must begin withdrawing benefits no later than April 1, following the year age 70 ½ is attained. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon attainment of 59 ½.

## Death or Disability Benefits

Upon death or total and permanent disability prior to termination or retirement, the participant account becomes 100 percent vested regardless of service years. The participant (or beneficiary) receives a single lump-sum distribution of 100 percent of the account balance.

## Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and usage of other plan features are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair market value, as defined by accounting principles generally accepted in the United States (U.S. GAAP). See Note 4 for disclosure related to fair value measurement.

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of March 31, 2025 and 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of March 31, 2025.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains or losses, and the unrealized appreciation (depreciation) on investments.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Benefits are recorded when paid.

#### Date of Management's Review

The plan sponsor evaluated the Plan's March 31, 2025 financial statements for subsequent events through January 9, 2026, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

### **NOTE 3 - FAIR VALUE MEASUREMENTS**

Generally accepted accounting principles establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at March 31, 2025 and 2024. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund.

*Common/collective trusts:* Valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts and plan assets will be used solely to provide benefits for participants.

#### **NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Fidelity Management Trust Company, who is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest. In addition, certain Plan expenses paid by the plan sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

#### **NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

#### **NOTE 7 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 stating that the Volume Submitter Profit Sharing Plan, which the Plan adopted, was designed in accordance with applicable IRC requirements. The Company has not applied for a determination letter from the Internal Revenue Service regarding the qualification of the Plan as it applies to the Company, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with requirements of the Internal Revenue Code and should qualify for tax-exempt status as of the financial statement date. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

## NOTE 8 - SUMMARY OF INFORMATION CERTIFIED BY ASSET CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of March 31, 2025 and 2024.
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended March 31, 2025.
- Investment related information in the schedule of assets (held at end of year) as of March 31, 2025.
- Notes receivable from participants as of March 31, 2025 and 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.
