## **Synergy Contracting, LLC 401(k) Plan Notes to the Financial Statements**

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of Synergy Contracting, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan covering all non-union employees of Synergy Contracting, L.L.C., House to Homes, Inc., Pacifico Pools, L.L.C., Performance Engineered Concrete, L.L.C, and Summerset Cascina, LLC (collectively referred to as the Company), who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the trustees.

#### **Contributions**

Each year, participants in the Plan may contribute a portion of their pretax compensation, as defined in the Plan, not to exceed the limit of the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover), as well as after-tax contributions from their current compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. If the participant does not make an investment election, the contributions are invested in the Plan's default investment option. All participants are eligible for a safe harbor matching contribution. Under the safe harbor provisions, the Company matches 100% of elective deferrals up to 4% of eligible compensation. The Company's contributions are invested in the same manner as participant contributions. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions and safe harbor Company contributions, plus actual earnings thereon.

## Synergy Contracting, LLC 401(k) Plan Notes to the Financial Statements

### NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

#### Payment of Benefits

On termination of service due to death or retirement the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, annuity options, or a fixed period or fixed payment installment option. Terminated participants with vested balances less than \$5,000 can be distributed in a lump-sum without participant election. The Plan allows for in-service withdrawals of fully vested balances any time. Hardship distributions are also permitted for current employees.

#### Forfeitures

Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's contributions to the Plan are used in the following order: reduce the Company's matching contribution or offset plan expenses. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts. There was no forfeiture activity for the year ended December 31, 2024.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### Payment of Benefits

Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through December 1, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

*Pooled separate accounts:* consist of various investment options (i.e. common stock, mutual funds) and are valued at the NAV based on the market value of the underlying assets. While the majority of the underlying asset values are quoted prices, the NAV of the pooled separate accounts is not publicly quoted and are determined by the custodians of the Plan.

*Collective trusts:* Collective investment trusts (CIT) invest in collective trust funds as well as a variety of separate accounts and mutual funds. The fair value of all these investments are used in determining NAV of the CIT, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 4 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 5 - PLAN TERMINATION**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **NOTE 6 - CERTIFICATIONS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Global Investors Trust Company (the insurance company and custodian of the Plan).

### **NOTE 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts and collective investment trusts managed by Principal Life Insurance Company and Principal Global Investors Trust Company, the custodian or trustee of the Plan. The custodian or trustee provide custodial services or trustee services to the Plan through an agreement with the Company. These transactions qualify as party in interest transactions.

### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 - PROHIBITED TRANSACTIONS**

During the plan years ended December 31, 2020, 2022 and 2023, the plan sponsor inadvertently failed to deposit a total of \$19,500, \$11,495, and \$133, respectively, of participant contribution payments within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The participant contribution payments were remitted to the Plan during the 2021, 2023 and 2024 plan years, respectively. Lost earnings were remitted to the plan during the 2024 plan year.

During the plan year ended December 31, 2024, the plan sponsor inadvertently failed to deposit a total of \$1,023 of participant contribution payments within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions. \$225 of the participant contributions were remitted to the Plan during 2024, with the remaining, along with lost earnings, still to be remitted to the plan.



