Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2025 and 2024 Financial Statements

We have performed audits of the financial statements of Grand Lodge of Masons or Masonic Home, Inc. Defined Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 6, 2025 and August 31, 2024 and the related statements of changes in net assets available for benefits for the period from September 1, 2024 to March 6, 2025, and for the year ended August 31, 2024, and the statement of accumulated plan benefits as of August 31, 2024, and the related statement of changes in accumulated plan benefits for the year then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 6, 2025 and August 31, 2024, and for the period from September 1, 2024 through March 6, 2025 and the year ended August 31, 2024 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2025 and 2024 Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2025 and 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2025 and 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying 2025 and 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2025 and 2024 Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2025 and 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, on August 28, 2024, the Board of Directors adopted a resolution to terminate the Plan effective August 31, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the ongoing plan basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2025 and 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2025 and 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the 2025 and 2024 financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the 2025 and 2024 financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the 2025 and 2024 financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2025 and 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2025 and 2024 financial statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 1. Description of Plan

The following description of the Grand Lodge of Masons or Masonic Home, Inc. Defined Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined benefit plan established effective September 1, 1976, as restated September 1, 2018. Prior to the plan freeze, the Plan covered all employees of Grand Lodge of Masons in Massachusetts, Masonic Health System of Massachusetts, Inc. and Overlook Masonic Health Center, Inc. (collectively, the Plan Sponsor), excluding employees that are covered under a collective bargaining agreement, nonresident alien, leased employees, independent contractors who were later determined by the Internal Revenue Service (IRS) to be an employee and those employed at Overlook Visiting Nurse Association, Inc. or Overlook Communities, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Finance Committee as a sub-committee of the Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's Board of Directors.

Plan Termination

On August 28, the Board of Directors of the Plan Sponsor resolved to terminate the Plan effective August 31, 2024. Upon termination, all assets remaining in the Plan will be distributed to the participants subject to the applicable requirements of ERISA and in accordance with the provisions of the plan document. The actuary determined that additional funding through liquidation was required and accordingly the Plan Sponsor contributed \$1,099,300 to the Plan in the 2025 plan year. The Plan purchased a group annuity contract from United of Omaha Life Insurance Company in the amount of \$3,330,971 in January 2025. The Plan was fully liquidated as of March 6, 2025. In addition to the group annuity contract the Plan paid \$714,239 in lump sum benefit payments to former participants who elected to take lump sum settlements from the Plan and \$63,777 of benefits were transferred to the Pension Benefit Guaranty Corporation (PBGC) as part of the missing participants program. The liability assumption date of the annuities was January 22, 2025, and therefore, no participants remained in the Plan as of that date. Payments from the group annuity contract to former participants of the Plan commenced March 1, 2025.

The following attributes of the Plan were based on the plan document prior to termination.

Funding Policy

The Plan's funding policy is for the Plan Sponsor to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. The minimum funding requirements of ERISA were met in 2025 and 2024. As discussed above, the Plan was fully funded prior to liquidation.

Pension Benefits

Plan participants are entitled to their plan benefits after terminating employment with vested rights. Participants who have completed five years of credited service are fully vested. Participants retiring at the normal retirement age of 65 and who have completed at least five years of credited service are entitled to a pension benefit. The Plan permits early retirement to participants who have reached the age of 55 and have completed at least five years of credited service. Early retirees may elect to receive their vested accrued benefit commencing on their normal retirement date or an immediate pension equal to their vested accrued benefit. Early retirees who have accrued twenty-five years of credited service will receive an unreduced early retirement benefit, whereas early retirees with between five and twenty-four years of credited service will receive an actuarially reduced benefit. Participants may also elect to defer retirement and continue to work past the age of 65; however, upon reaching the age of 70.5, participants must begin receiving benefit payments. If employees terminate before rendering the required years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Plan Sponsor's contributions. Upon becoming vested, participants are entitled to an accrued benefit equal to 1.45% of the participants average compensation multiplied by their accrued service, not to exceed 35 years. Upon termination of employment, pension payments are normally paid in the form of a monthly annuity payable for their lifetime or, if married, in the form of a qualified joint or survivor annuity.

Death and Disability Benefits

If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefit is paid to the employee's beneficiary. Active employees who become totally disabled receive annual disability benefits that are equal to the equivalent normal retirement benefit they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age, at which time disabled participants will receive the normal retirement benefit computed as though they had been employed to normal retirement age, with their annual compensation remaining the same as at the time they became disabled.

2. Summary of Accounting Policies

Basis of Accounting

As a result of the resolution to terminate the Plan, the Plan considers liquidation to be imminent and, therefore, the financial statements of the Plan as of March 6, 2025 and August 31, 2024 and for the period from September 1, 2024 through March 6, 2025 and for the year ended August 31, 2024 are presented on the liquidation basis of accounting.

The financial statements of the Plan as of and for the year ended August 31, 2023 is presented on the ongoing accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments in the statements of changes in net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through June 16 2025, the date the financial statements were available to be issued.

3. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances, such as retirement, death, disability, and termination of employment, are included, to the extent they are attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of September 1, 2024. Had the valuation been performed as of August 31, there would be no material differences. The significant actuarial assumptions used in the valuation were:

Discount rate	5.50%
Interest Rate	5.17%
Mortality	The 2023 prescribed mortality table is being used and the compensation and maximum benefit limitations in effect at the beginning of the plan year. The mortality assumption has been updated based on Pri-2012 total dataset-based rate mortality table projected generationally using MP-2021.

The foregoing actuarial assumptions for September 1, 2023 through August 31, 2024 were based upon the presumption that the Plan would continue; however there were no material differences in assumptions even after considering the impact of the Plan termination as discussed in Note 1. There were no significant changes in the actuarial assumptions from the prior year.

The actuarial present value of the projected plan benefit obligation at September 1, 2023 was \$4,488,922 and the fair value on the Plan's investments were \$3,381,243 as of August 31, 2024. As disclosed in Note 1, in 2024, the Plan began the liquidation process by paying lump sum benefit payments to certain former participants and purchasing annuity contracts for the remaining participants. The Plan Sponsor made contributions of \$1,099,300 to fund the Plan prior to liquidation.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

As of August 31, 2024 and 2023, the Plan had investments of \$2,893,157 and \$2,741,188, concentrated in two pooled separate accounts, respectively.

Accordingly, Principal Life Insurance Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of March 6, 2025, August 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of August 31, 2024 and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the period from September 1, 2024 through March 6, 2025 and for the year ended August 31, 2024 and the information reported in the supplemental Schedule H, Line 4(j) - Schedule of Reportable Transactions for the period from September 1, 2024 through March 6, 2025 and the year ended August 31, 2024. 7. Related Party and Party In Interest Transactions

The Plan's investments are administered under a contract with Principal Life Insurance Company, the Trustee of the Plan. Contributions are held and managed by Principal Life Insurance Company, who invests cash received, interest and dividend income and makes distributions to participants. These transactions are party-in interest transactions under ERISA.

As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. These transactions are party-in interest transactions under ERISA.

8. Tax Status

The Plan adopted a volume submitter plan offered by Principal Life Insurance Company. The volume submitter plan received an IRS Opinion Letter dated February 28, 2023, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
