As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and

Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Plan Description

General

The following description of Brandywine Companies Group Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of Brandywine Auto Parts, Inc. and affiliated participating employers (collectively, the Employer), who are age 18 or older and have completed six months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The following are the affiliated participating employers for the year ended March 31, 2025:

Bowie Used Auto Parts, Inc.	Brandywine Investment Properties
Brandywine Auto Parts, LLC	Foreign Car Parts, Inc.
Brandywine Installation, LLC	Save More, Inc.

Administration

The Employer serves as the Plan Administrator and is responsible for the day-to-day operations and oversight of the Plan.

A third-party administrator processes and maintains the records of participant data. Empower Annuity Insurance Company of America (Empower Annuity Insurance) (formerly Empower Retirement, LLC) serves as the Plan's third-party administrator and recordkeeper. Empower Trust Company, LLC (formerly Great-West Trust Company, LLC) serves as the trustee for the Plan. Resources Investment Advisors, LLC provides consulting and investment advisory services to the Plan.

Participant Contributions

Participants may elect to contribute a percentage of their eligible pre-tax compensation, with a minimum limit of 1% of compensation per payroll period and a maximum limit of 20% of compensation per Plan year up to the amount allowable under current income tax regulations. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Contributions withheld are invested in accordance with the participant's election and may be redirected online at any time. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Employer Contributions

As defined in the Plan document, the Employer may match a portion of the participant contributions on a discretionary basis. The Employer may also make a discretionary non-elective contribution on behalf of eligible participants. Such contributions shall be allocated based on the ratio that each participants' compensation bears to the total compensation paid to all eligible participants. During the year ended March 31, 2025, no discretionary contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, allocations of the Employer discretionary non-elective contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferrals, rollover contributions, prior safe harbor matching contributions, and related earnings. Vesting in the Employer's discretionary matching and non-elective contributions is based on years of continuous service as follows:

A participant's account balance becomes 100% vested in Employer's discretionary matching and non-elective contributions, regardless of years of service, at age 65 or in the event of permanent disability, death, or by reason of, and as part of, a partial plan termination.

Payment of Benefits

Benefit payments are available to participants upon retirement (age 65), termination of employment, death, disability, or attainment of age 55 and ten years of service for early retirement. Upon termination, all inactive account balances that do not exceed \$1,000 may be automatically distributed to the participant. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Participants are entitled to a benefit equal to the vested portion of their account which will be distributed in the form of a lump sum payment. Distributions are subject to the applicable provisions of the Plan document. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½.

Forfeitures

At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$1,352 and \$541, respectively. These accounts may be used to pay administrative expenses and reduce Employer contributions. The Employer did not use any forfeitures to pay administrative expenses and/or fund employer contributions in the year ended March 31, 2025.

Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 maximum loan amount is reduced by the participant's highest outstanding note balance during the one-year period before the note was made less the outstanding note balance on the date the new note is issued. The notes are secured by the participant's vested balance and no more than two outstanding notes are permitted at any time.

Such notes bear interest at 1% above the prime rate and must be repaid to the Plan over a period of five years or less, unless used to purchase a principal residence which period is up to 15 years. The specified terms and conditions of such notes are established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid directly by the Employer, or by the Plan and/or Plan participants, as defined in the Plan. Expenses paid by the Employer are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant's note balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Contributions and Contributions Receivable

Participant contributions and any related employer contributions are recognized in the period during which the Employer makes the respective payroll deduction from the participant's compensation.

3. Information Certified by Trustee and Insurance Company

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Empower Annuity Insurance, qualified institutions.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Mutual Funds - Mutual funds are registered investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds held by the Plan are traded on national securities exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fixed Annuity Contract

The Plan invests in a fully benefit-responsive investment contract with Empower Annuity Insurance via a fixed annuity contract. Empower Annuity Insurance maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Empower Annuity Insurance. The Fixed Annuity Contract is included in the financial statements at contract value, which approximates fair value, as the contract crediting rate resets quarterly, and the contracts are fully benefit-responsive. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Fixed Annuity Contract credits interest rates net of cost of capital and expenses covered by the fund and the guarantee provisions.

There are no events that limit the ability of the Plan to withdraw contract value or otherwise transact at contract value with Empower Annuity Insurance as the contract issuer. Empower Annuity Insurance may defer processing distribution or transfer requests if transactions cannot be executed or settled due to the closing or disruption of financial markets or exchanges.

The Employer may terminate the contract with 60 days advance written notice to the contract owner. Upon such notice, the contract owner may choose lump sum payment with market value adjustment, payment at contract value after 12 or 36 months, or payment in 20 quarterly installments, with interest continuing under the same terms as if the contract remained in force.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

7. Tax Status

The Plan is operating under a prototype non-standardized pre-approved profit-sharing plan sponsored by Empower Trust Company, LLC. The IRS has determined and informed the prototype plan by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the prototype plan, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investments, which in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Related Party and Party-in-Interest Transactions

Certain plan investments are managed by Empower Trust Company, the trustee, and Empower Annuity Insurance, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Notes receivable from participants are also considered exempt party-in-interest transactions.

10. Subsequent Events

Management has evaluated events and transactions for potential recognition or disclosure through the independent auditor's report December 22, 2025, the date the financial statements were available to be issued.
