Note 1 – Summary of Plan

The following description of the Heidtman Steel Retirement Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for complete information about the Plan.

General

The Plan is a defined contribution plan covering substantially all employees of Heidtman Steel Products, Inc. and affiliated employers (the Company and Plan Sponsor) who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with an allocation of the Company's contributions, the participant's contributions, and an allocation of Plan earnings (losses) based upon participant balances. Participants direct the investment of their accounts, with the exception of Centaur, Inc. Class C common stock balances, among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested balance of the participant's account.

Notes Receivable from Participants

Participants may borrow from their accounts, as defined by the Plan, a minimum of \$1,000 up to the lesser of fifty percent of the vested balance or \$50,000. Terms of the loan are based on the terms of the individual promissory note. The loans are secured by the balance of the participant's account and bear a reasonable rate of interest not to exceed the maximum rate permitted by law. Principal and interest are paid through payroll deductions.

Contributions

The Company may elect to contribute a discretionary nonelective contribution which is allocated to eligible participants as a percentage of their eligible wages. The Company made no discretionary nonelective contributions for the years ended March 31, 2025 and 2024.

The Company may elect to contribute a discretionary matching contribution. For the years ended March 31, 2025 and 2024, the Company elected to match 100% of the first 4% of each eligible participant's deferral contributions.

Contributions (continued)

Participants may elect to defer as contributions an amount up to the maximum allowable by law. Unless they specify otherwise, eligible newly hired and rehired employees will be auto enrolled at an initial pre-tax contribution of 4% with a 1% annual increase to a maximum pre-tax contribution rate of 15%, as further defined in the Plan document.

Vesting

Upon retirement, disability, or death, participants (or their beneficiaries) are entitled to receive the full value of their accounts. Upon termination of employment for any reason other than retirement, disability, or death, a participant is entitled to the vested interest in his or her account. Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting of employer contributions is based upon years of continuous service. Employer contributions and related earnings (losses) become fully vested according to the following schedule.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are to be used to pay administrative expenses, to be allocated to participants annually as additional nonelective contributions, or to be used to reduce Company contributions (as further defined in the Plan document). Forfeited balances available amounted to \$26,897 and \$33,704 at March 31, 2025 and 2024, respectively. Forfeitures totaling \$384,738 and \$102,882 were used to reduce the Company's contributions or to pay administrative expenses for the years ended March 31, 2025 and 2024, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, participants become fully vested in the total value of their account.

Administrative Expenses

Certain administrative expenses are paid by the Plan, as allowed by the Plan document. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments were held by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) during the years ended March 31, 2025 and 2024.

The appraised fair value of Centaur, Inc. Class C common stock is determined annually by an independent valuation company. This appraisal was based upon a combination of the market, income, and cost valuation techniques, consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of company assets and liabilities.

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

Common/collective trust funds (CCTs) represent investments with various investment managers. Units held in CCTs, including stable value funds, are fair valued at net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The Standard Insurance Company Stable Asset II is a guaranteed interest account valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Life insurance policies, for which the Plan is the sole beneficiary, are valued at cash surrender value.

Investment Valuation and Income Recognition (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Most significantly, an estimate of the fair market value of Centaur, Inc. Class C common stock is determined annually by an independent valuation company and is used by management in the preparation of the Plan's financial statements. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through January 7, 2026, the date the financial statements were available to be issued.

Note 3 – Investments

Most of the investment information disclosed in the accompanying financial statements and supplemental schedules as of and for the years ended March 31, 2025 and 2024, including investments held, net appreciation (depreciation) of investments, and interest and dividends, were obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by Principal Trust Company. See Note 4 for a description of other investments held in the Plan.

Note 3 – Investments (continued)

For the years ended March 31, 2025 and 2024, investments held by the Plan (including investments purchased, sold, as well as held during the year, but excluding the other investments described in Note 4) appreciated (depreciated) by \$2,907,627 and \$7,670,682, respectively.

For the years ended March 31, 2025 and 2024, interest and dividend income from investments as defined above amounted to \$128,531 and \$144,082, respectively.

Note 4 – Other Investments

Other investments held in the Plan, which are not certified as complete and accurate, include Centaur, Inc. Class C common stock and the cash surrender value of life insurance.

The investment in Centaur, Inc. Class C common stock is held by the Plan Sponsor. As of March 31, 2025 and 2024, the fair value of the stock was \$3,604,740 and \$6,021,825, respectively, and the net appreciation (depreciation) in fair value for the years then ended was \$(1,513,411) and \$(572,501), respectively.

The cash value of life insurance was \$428,771 and \$506,688 as of March 31, 2025 and 2024, respectively, and the net change in the cash value of life insurance for the years then ended was \$44,354 and \$17,439, respectively.

Note 5 – Guaranteed Interest Account

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The guaranteed interest account permits the issuer or the Plan to terminate the agreement prior to the scheduled maturity date as a result of specific occurrences as defined in the contract.

Note 6 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value, as of March 31, 2025 and 2024. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 7 – Related Party Transactions

On March 31, 1987, the shareholders of Centaur established a class of common stock, Class C, to be held solely by the retirement plan trusts of Centaur or its subsidiaries, representing the only nonparticipant-directed investment in the Plan. Centaur must redeem shares of the Class C common stock upon request of the Plan Sponsor.

At March 31, 2025, the Plan held 1,095 shares of Centaur, Inc. Class C common stock, valued at estimated fair value of \$3,604,740 (\$3,292 per share). At March 31, 2024, the Plan held 1,275 shares of Centaur, Inc. Class C common stock, valued at estimated fair value of \$6,021,825 (\$4,723 per share). The net appreciation (depreciation) in the fair value of the Class C common stock for the years then ended was \$(1,513,411) and \$(572,501), respectively.

The Company periodically advances funds to the Plan for redemption of shares from terminated or retired participants. The Company may choose either to return shares to treasury stock or to reduce future contributions by the amount of such advances, which totaled \$852,850 and \$945,614 during plan year 2025 and 2024, respectively. In each plan year 2025 and 2024, 180 shares were returned to treasury stock.

Note 8 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the pre-approved plan upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan has since been amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
