No new accounting policies were adopted and the application of existing policies was not changed during the Plan year ending March 31, 2025. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of the investments at each reporting date are based on fair value assumptions. We evaluated the key factors and assumptions used to develop the fair value of the investments in determining that their fair value is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of Fair Value Measurements in Note 4 to the financial statements. Even though the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

Eligibility

During the audit, it was noted that the plan sponsor had incorrectly classified interns as ineligible for the 401(k) plan, despite their eligibility under the plan's terms. Additionally, some interns who transitioned to full-time employment were not enrolled in the plan in a timely manner. The plan sponsor is collaborating with the TPA to calculate and make the necessary corrective contributions. We recommend implementing a periodic review of employee classifications and eligibility status, especially during onboarding and status changes, this is to ensure timely enrollment and compliance with plan requirements.

Error in Payroll

During our payroll testing, it was noted that for one of our testing selections the payrate support did not agree to the payrate in the Paylocity system, resulting in an error in total compensation. We recommend performing an internal audit to confirm there are no other discrepancies, and to implement procedures to ensure pay rates are accurately input into the payroll system.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated January 6, 2026.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

With respect to the ERISA-required supplemental schedules accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Island Kinetics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The Island Kinetics, Inc. 401(k) Plan (the Plan) is a defined contribution plan providing retirement income, disability, termination, and death benefits to eligible employees. The Plan was adopted effective April 1, 2001 with a year end of March 31. The Plan was amended and restated effective April 1, 2022. The Plan is administered by Island Kinetics, Inc. dba Covalence Laboratories (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2024, Skin Script, LLC became an adopting employer of the plan.

The following description of the Plan provides general information. Participants and other interested parties should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility

All employees, except those covered by a collective bargaining agreement, non-resident aliens, and leased employees, shall become eligible to participate in the deferral component of the Plan after completing one hour of service. Effective April 1, 2025, interns are also excluded from eligible employees. Participants are eligible for the discretionary employer match and profit sharing contribution after completing one year of service. A year of service is defined as a plan year during which an employee works at least 1,000 hours. Once eligibility requirements are met, a participant must complete at least 501 hours of service during the Plan year or be employed by the Company on the last day of the Plan year to receive the discretionary employer match or profit sharing contribution. A participant may enter the Plan for the purposes of the discretionary employer match or profit sharing on the 1st day of the 1st and 7th month on the plan year coinciding with or next following the date they become eligible.

Contributions

Participants may elect to defer salary in an amount not to exceed 90% of their total eligible compensation; subject to Internal Revenue Service limitations. The Plan has automatic enrollment of newly eligible participants unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contribution are invested in the designated default fund until changed by the participant. Participant who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified matching or profit sharing contribution to the Plan. For the years ended March 31, 2025 and 2024, the Company elected to make a matching contribution of \$63,000 and \$50,000, respectively, which was allocated on a pro-rata basis. There were no Company profit sharing contributions for the years ended March 31, 2025 and 2024.

Participants may also contribute amounts representing distribution from other qualified defined benefit and contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A participant's account is credited with the participant's contributions, allocations of (a) the Company's matching and profit sharing contributions and (b) plan earnings. A participant's account is debited with an allocation of plan losses and charged with administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. Allocation of the Company's matching contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon at all times. Participants vest in employer matching and profit sharing contributions based upon the following schedule:

The full amount credited to a participant's account shall be fully vested upon attaining normal retirement age, death, or by reason of permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate. Notes must be repaid over a period not to exceed five years, unless the loan is for the purchase of the participants primary residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. A participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. For terminations due to death the value of the vested interest may also be paid in installments. The Plan allows for in-service distributions once a participant reaches normal retirement age, defined as the attainment of age 55 and the third anniversary of Plan participant. Effective April 1, 2025, the Plan was amended to change the normal retirement age to 65. The Plan also allows for hardship distributions subject to Plan provisions.

If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment to be distributed to the participant directly, less any applicable taxes. If the balance is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participants name.

Forfeitures

At March 31, 2025 and 2024, there were \$13,161 and \$9,553, respectively, of forfeited nonvested accounts. For the year ending March 31, 2025, employer contributions were reduced by \$3,400, from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of March 31, 2025 and 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended March 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the asset custodian of the Plan).

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

Investments and investment income related to self-directed brokerage accounts are not covered by the certification from the qualified institution and, accordingly, have been subjected to audit procedures. The fair value of investments held in self-directed brokerage accounts as of March 31, 2025 was \$1,662,279, and the related investment income for the year then ended was \$145,609.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments or redemption restrictions associated with these investments.

Self-directed brokerage accounts: Self-directed brokerage accounts consist of interest bearing cash, U.S. government securities, corporate debt instruments, mutual funds, cash equivalents, common stocks and unit investment trusts. Corporate stocks are valued at the daily closing price of the investment. These investments are registered with the Securities and Exchange commission and are actively traded. Interest bearing cash is valued at carrying value which is representative of its fair value based on its short term nature. Corporate bonds are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks or a broker quote is available. Corporate bonds are included in level 2, all other investments held in self-directed brokerage accounts are level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TERMINATION

Although the Company has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in all plan sponsor contributions.

NOTE 6 - INCOME TAXES

The Company adopted the CCH Incorporated Volume Submitter Profit Sharing Plan with CODA which obtained its latest opinion letter on June 30, 2020. In this letter, the Internal Revenue Service states that the Plan is acceptable under Section 401 of the Code for use by the employers for the benefit of their employees. Although the plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with applicable requirements of the Code. Therefore, no provision for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan issues notes receivable to participants which are secured by the balances in participants' accounts. The Plan paid certain administrative fees for the year ending March 31, 2025. The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. These transactions qualify as party-in-interest transactions for which a statutory exception exemption exists.

NOTE 9 - PROHIBITED TRANSACTIONS

During the 2024 Plan year, it was determined that certain employees who were eligible to participate per plan provisions, had erroneously been excluded from the Plan. The Plan sponsor has made a corrective contribution in the amount of \$16,061 subsequent to year-end.

For the 2024 Plan year, it was determined that certain employee deferrals and loan repayments to the plan totaling \$18,172 were not remitted timely. The Plan sponsor has made a corrective contribution for the lost earnings during the 2025 Plan year.

NOTE 10 - SUBSEQUENT EVENTS

Effective April 1, 2025, the Plan was amended to exclude interns from eligible employees and to change the normal retirement age to 65, as described in Note 1.

Management has evaluated subsequent events through January 2, 2026, the date the financial statements were available to be issued and concluded that there were no other events that require recording or disclosure in the financial statements as of March 31, 2025.
