Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nuclear Care Partners Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nuclear Care Partners Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

General

The following description of Nuclear Care Partners Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Nuclear Care Partners, LLC (Company) for the benefit of its employees. The Plan is available to all employees who have completed three months of service, excluding union employees, those under a collective bargaining agreement, nonresident aliens, and leased employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Charles Schwab Trust Bank (Schwab Trust Bank) serves as the custodian of the Plan, Matrix Trust Company serves as the Plan's sub-custodian, and Newport Group, Inc., (Newport Group) serves as the Plan's recordkeeper. During 2024, Newport Group delegated responsibility for servicing the Plan to its affiliate Ascensus, LLC, and the Plan migrated to Ascensus, LLC's recordkeeping platform in April 2024. In connection with the recordkeeping platform migration, there was a brief "blackout period" starting April 16, 2024, which ended during the week of April 18, 2024. During the blackout period, participants were unable to direct or diversify the assets held in their account or obtain distributions or loans until the new recordkeeper had time to accurately complete the migration.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make pre-tax or Roth contributions up to the maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Company may make discretionary employer matching and profit-sharing contributions, as determined annually by the Company. Participants who have completed one year of service, worked 1,000 hours or more during the plan year, and are employed on the last day of the plan year are eligible to receive an allocation of the company discretionary contributions once formally determined subsequent to year-end. No discretionary profit-sharing contribution was made by the Company in 2024 or 2023.

Contributions are subject to certain limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after five years of credited service, or upon death, disability, or attainment of normal retirement age of 65 while in active service of the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are covered by demand notes and are repayable over a period not to exceed five years (except loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. The loans are secured by the balance in the participant's account and bear an interest rate of prime rate plus two percent. The maximum number of loans a participant may have outstanding at one time is one.

Payment of Benefits

Upon termination of service, vested participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Vested participants with account balances exceeding \$1,000 but not exceeding \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator, absent an election by the participant. Participants with account balances exceeding \$5,000 may elect to receive a lump-sum distribution equal to their vested value. Withdrawals for reasons other than terminations are permitted under circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,998 and \$0, respectively, which may be used to pay plan administrative expenses, reduce future employer contributions, or be allocated to participants as additional employer contributions. Forfeitures of \$0 and \$1,732 were used to reduce employer matching contributions paid during 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds, money market funds, and exchange traded funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities.

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 investments held include mutual funds, money market funds, and exchange traded funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are money market funds managed by an affiliate of TDA Trust. TDA Trust is the former custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid certain direct custodial, investment advisory, and record-keeping fees of \$38,170 and \$24,442 during the years ended December 31, 2024 and 2023, respectively. Certain fees incurred by the Plan are included in net appreciation (depreciation) in fair value of the investment, as they are paid indirectly through revenue sharing, rather than direct payments from Plan assets. The Company pays certain other administrative fees related to the Plan's operations and provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, affected participants would become 100 percent vested in all accounts.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan document sponsored by TD Ameritrade Trust Company. This plan document has been filed with the Internal Revenue Service and obtained an opinion letter dated June 30, 2020, stating the form of the plan is acceptable. Therefore, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through January 09, 2026 which is the date the financial statements were available to be issued.
