Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Environmental Research Group, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Environmental Research Group, LLC (the "Company" or "Employer") who have three months of service and are not union employees, nonresident aliens, leased employees, or residents of Puerto Rico. Eligible employees may enter the Plan on the first day of the calendar quarter following meeting the eligibility requirements. The Plan is subject to the provisions of ERISA. The Trustee is responsible for oversight of the Plan.

Effective January 1, 2024, the Plan entered into a merger and transfer agreement (the "Agreement") with the AmaTerra Environmental, Inc. 401(k) Plan (the "AmaTerra Plan") in which the assets and account balances of all the participants in the AmaTerra Plan were transferred and assigned to the Plan. In connection with the merger, the employees of AmaTerra Environmental, Inc. became participants in the Plan, and the Plan was amended to recognize employees' service with AmaTerra Environmental, Inc. for purposes of eligibility, vesting, and allocations within the Plan. Voya Retirement Insurance and Annuity Company was the custodian of the AmaTerra Plan assets and, effective January 26, 2024, the AmaTerra Plan assets were transferred to Capital Bank and Trust Company.

Contributions

Each year, participants may contribute a percentage of eligible compensation up to the maximum amount allowed by the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes a safe harbor nonelective contribution to eligible participants' accounts equal to 3% of eligible compensation to the Plan. Additional profit sharing amounts may be contributed at the discretion of the Company. For the year ended December 31, 2024, the Company made a \$200,331 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Notes to Financial Statements

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's nonelective and profit sharing contributions (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The notes receivable are secured by the balance in the participant's account, and bear interest at the Prime rate plus 1%. Notes must be repaid within five years, unless the purpose is to obtain a mortgage on a primary residence, whereas the loan must be repaid within fifteen years. Principal and interest are prepaid or paid ratably through payroll deductions.

Payment of Benefits

On termination of service, death, or disability, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for distributions upon attainment of age 59 ½ or in certain hardship situations while actively employed.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$0, respectively. These accounts will be used to reduce future employer contributions. In 2024, there were no employer contributions reduced by forfeited nonvested accounts.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes to Financial Statements

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Profit sharing contributions from the Company are recorded in the year in which the participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Notes to Financial Statements

Subsequent Events

The Plan has evaluated subsequent events through January 9, 2026, the date the financial statements were available to be issued.

Note 3. Information Prepared and Certified by the Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company and Voya Retirement Insurance and Annuity Company, the custodians of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers between levels during the year ended December 31, 2024.

Note 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Signature Estate Securities, Inc., investment advisor, and Retirement Planners & Administrator, third party administrator, provide services to the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes to Financial Statements

Capital Bank and Trust Company provides certain administrative services to the Plan, pursuant to an agreement, and receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan. If the revenue received by Capital Bank and Trust Company from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During 2024, there were no excess amounts allocated to participants based on their respective account balance. The Plan or Plan Sponsor may make direct payments to Capital Bank and Trust Company for administrative expenses not covered by revenue sharing.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan uses a pre-approved document for its original plan documents and amendments. The pre-approved plan provider has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was received; however, the Plan Administrator believes the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
