Opinion

We have audited the financial statements of Rummel, Klepper & Kahl, LLP Health Plan (the Plan), which comprise the statements of net assets available for benefits and the statements of benefit obligations as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and the statements of changes in benefit obligations for the years ended March 31, 2025 and 2024, and the related notes to the financial statements (collectively, the financial statements).

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Rummel, Klepper & Kahl, LLP Health Plan (the Plan) provides only general information. Participants should refer to Plan documents for a complete description of the Plan provisions.

General

The Plan provides medical, long-term and short-term disability, life, accidental death and dismemberment, and prescription drug coverage to participants. Rummel, Klepper & Kahl, LLP (the Sponsor) established a trust fund, dated March 26, 2004, to be held for the benefit of the eligible employees and their eligible dependents under and in accordance with the Plan. At each enrollment period, provisions, such as participant contribution rates, coverage, deductibles, co-pays, and out-of-pocket maximums, may change. The Plan and the Trust are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is also impacted by the Medicare Prescription Drug, Improvement, and Modernization Act of 2003.

Benefits

Employees of the Sponsor are eligible to participate in the Plan if they work at least 30 hours per week on a full-time basis. Dependents of the participants are eligible for benefits from the Plan. Benefits are paid with the assets of the Trust or the Sponsor, and by group insurance contracts purchased by the Sponsor.

Prior to April 1, 2023, the Plan provided benefits to certain former partner and nonpartner participants after retirement. Effective April 1, 2023, the Plan was amended to make nonpartner employees ineligible to receive retiree medical benefits. The Plan currently provides benefits to former participants who retired from the Sponsor as a partner, but only if and to the extent that his or her partnership agreement provides for coverage as a retiree (as determined by the Sponsor). The benefit is provided to the spouse of the participant that meets the criteria immediately upon the partner's retirement and can continue coverage after the retired partner's death. Participants who retired and qualified for post-retirement benefits before April 1, 2023, continue to receive those benefits, despite the change in eligibility under the amendment.

Administrative Expenses

Certain expenses for administering the Plan are paid directly by the Sponsor and are excluded from the accompanying financial statements.

Contributions

The Sponsor's policy is to contribute annually the estimated amount reasonably and actuarially necessary to fund claims incurred but unpaid as of the close of the Sponsor's fiscal year for benefits provided by the Plan. The Sponsor also contributes to the Plan by paying all stop loss insurance premiums, disability, life, accidental death and dismemberment insurance premiums, and administrative expenses of the Plan. Participants are required to withhold specified amounts from their bi-weekly pay for Plan expenses based on their Plan elections.

Notes to Financial Statements

Participants that elect benefits under certain medical plans are entitled to maintain a Health Savings Account. The Sponsor makes a pre-determined annual contribution to the Plan on behalf of the participant. Participants may elect to make contributions up to Internal Revenue Service annual limits.

Stop-Loss Coverage

The Sponsor maintains an agreement for stop-loss coverage with an insurance company to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount). For the years ended March 31, 2025 and 2024, claims of individual employees in excess of \$175,000 per year were paid through this stop-loss coverage.

Self-Insured Benefits

All Plan benefits up to the stop loss coverage threshold are self-insured. The claims for self-insured benefits are processed by the Plan's independent claims processors under administrative services only (ASO) arrangements. The claims processors pay the claims directly to or on behalf of the participants and are then reimbursed by the Plan's Trust or the general assets of the Sponsor. Despite the Plan's use of independent claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Other

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees and their dependents, and to terminate the Plan subject to the provisions set forth in ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. Premiums paid by the Company are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor after claims are submitted and approved by the Plan.

Notes to Financial Statements

Rebates

Rebates due from the Plan's benefits manager are recorded when earned. Rebates due as of the financial statement date are reported as a receivable, with the offset being netted against benefits paid. Pharmacy rebates totaling \$2,771,739 and \$1,697,621, respectively, have been netted with benefits paid in the accompanying statement of changes in net assets available for benefits for the year ended March 31, 2025 and 2024.

Stop-Loss Premiums and Reimbursements

Premiums for stop loss insurance are included in stop-loss insurance premiums in the accompanying statements of changes in net assets available for benefits. Effective April 1, 2024, stop-loss reimbursements are recorded as receivables when the underlying claims have been incurred by participants and are considered collectible. The corresponding amounts are netted with benefits paid in the accompanying statements of changes in net assets available for benefits. Stop-loss reimbursements totaling \$1,632,555 and \$1,351,343 have been netted with benefits paid for the years ended March 31, 2025 and 2024, respectively.

Subsequent Events

The Plan evaluated subsequent events after March 31, 2025 through January 9, 2026, the date the financial statements were available to be issued. No significant events were identified that would affect the presentation of the financial statements.

Note 3. Claims Incurred But Not Reported

Plan obligations at March 31, 2025 and 2024, for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's independent claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The actuary uses a standard actuarial lag factor method to calculate the claims incurred but not reported obligation. This method is used to develop a reserve estimate for all months except the last two months (one for prescription drugs) closest to the valuation date. The method uses actual historical claims data for the Plan, beginning with the twelve months prior to the current valuation date to develop completion factors specific to its own claim payment patterns. The historical claims data includes the incurred and paid dates, and does not include stop loss reimbursements or prescription drug rebates. Circumstances that would skew the historical payment patterns that are unlikely to represent current payment patterns are taken into account. As of March 31, 2025 and 2024, the Plan has elected to report the claim reserve with a 15% provision for adverse deviation to cover run-out with a higher probability.

Note 4. Post-retirement Benefits

As discussed in Note 1, the Plan provides benefits to certain former participants and spouses. Retiree contributions are not required for retired partners and their spouses. Medicare eligible retired partners are required to enroll in Medicare Parts A and B to be eligible for retiree benefits. Benefits are reduced for amounts paid by other payers, including Medicare. A post-retirement benefit obligation has been recognized for retiree medical benefits for eligible participants upon retirement. The benefit obligation represents the actuarial present value of

Notes to Financial Statements

the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligation represents the amounts that are expected to be funded by contributions from the Sponsor and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Sponsor.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The Plan's actuary used the Projected Unit Credit Method for determining the Accumulated Post-retirement Benefit Obligation (APBO) related to the post-retirement benefits as of March 31, 2025 and 2024:

As of March 31, 2025 and 2024, the actuary also assumed various retirement age rates ranging from 3% at age 55 to 100% at age 65 and mortality based upon Pri-2012 Headcount-Weighted Mortality Table with white collar adjustment using mortality improvement based on the MP-2021 rates.

The weighted average healthcare cost trend rate assumption has a significant effect on the amounts reported as post-retirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of March 31, 2025 and 2024 by \$789,933 and \$749,956, respectively.

Note 5. Income Taxes

The Trust established under the Plan to hold the Plan's assets is a Qualified Asset Account described in Section 419A of the Internal Revenue Code (the Code). Within limits provided in Section 419A(c), contributions to the Trust are deductible by the Sponsor under Section 419 of the Code. The Sponsor is subject to income taxes on investment income of the Trust. The Sponsor has not obtained a favorable tax determination letter; however, it believes the Trust qualifies and operates in accordance with applicable sections of the Code.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to the year ended March 31, 2022.

Note 6. Cash

The Plan maintains the majority of its cash on deposit at one financial institution which, at times, may exceed federally insured limits. At March 31, 2025 and 2024, the Plan had \$1,248,500 and \$1,199,200, respectively, on deposit in excess of FDIC insured limits. The Plan has not experienced any losses in such accounts.

As of March 31, 2025 and 2024, cash totaling \$250,000 was held in an uninsured escrow account maintained by an independent administrator for the payment of out-of-network claims.

Note 7. Party-In-Interest Transactions

The Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan pays fees to the following service providers: CareFirst Administrators for processing medical claims; Metropolitan Life Insurance Company for vision, dental, long-term disability, life, and accident and dismemberment insurance premiums; Sun Life Financial for stop loss premiums; Discovery Benefits/WEX Inc. for COBRA and Health Savings Accounts administration; CAREOperative for online healthcare pricing information; Silberstein Insurance Group for insurance brokerage services; and Quantum Health for participant healthcare navigation. Such transactions qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

Note 8. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
