Opinion

Notes to Financial Statements

1. Description of Plan

The following description of Joe's Stone Crabs, Inc. Profit Sharing Plan and Trust (the Plan) is provided for general information purpose only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General

The Plan was adopted on July 1, 1981 by Joe's Stone Crabs, Inc. The Plan was originally restated effective July 1, 1984 with subsequent restatements effective July 1, 1990, July 1, 2001, July 1, 2009, July 1, 2015 and July 1, 2022. Joe's Stone Crabs, Inc. (Joe's), Stone Crabs, Inc. (SCI) and Ernest Hamilton Stone Crabs Corp. (EHSC) (collectively, the Company or the Employers) is the sponsor of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

The custodian of the Plan is LPL Financial Services (LPL). The recordkeeper of the Plan is Pension Services, Inc. The administrator of the Plan is Joe's Stone Crabs, Inc. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

There is no age requirement to enter the Plan. Eligible participants are those employees of the employer who were employed by January 1 of the plan year (six month of service), continued to be employed at the close of the stone crab season (May 15) and have worked at an average rate of not less than 25 hours per week during the stone crab season (October 15 to May 15).

Contributions

Contributions to the Plan are at the discretion of Joe's and SCI. For EHSC, the contributions are based on a calculation using the average contribution amounts of Joe's and SCI, based on a formula as defined by the Plan, and multiplied by their number of participants.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

With the consent of the Plan Administrator, employees may voluntarily make contributions to the Plan, with these contributions being allocated directly to their Voluntary Contribution Account. As of June 30, 2025 and 2024, there were no Voluntary Contribution Accounts in the Plan. Investment decisions are made in the best interests of the participants.

Allocations

Employers' contributions and participants' forfeitures (\$40,866 in 2025 and \$23,060 in 2024) are allocated to each eligible participant's Employer Contribution Account in the same proportion that each participant's points for the plan year bear to the total points of all such eligible individuals.

Points are awarded to participants based on one point (1) per \$100 of salary up to a maximum of 700 salary points and points for the years of service as follows:

The Plan's earnings (losses) are allocated to a participant's account based on each participant's account balance as a percentage of all participants' account balances.

Participant Accounts

Each participant's account is credited with the employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are 20% vested in their Employer Contribution Account after two years in the Plan. Vesting increases by 20% every subsequent year, with full vesting after six years. Participants are 100% vested in amounts rolled over into the Plan and in their Voluntary Contribution Account.

Forfeitures

If a participant resigns or is terminated prior to being fully vested, the participant will forfeit that portion of their Employer Contribution Account which is not vested. Forfeitures may be used by the Plan for several purposes such as the payment of Plan expenses. Any forfeitures not used by the Plan will be added to Employer's discretionary profit-sharing contribution and allocated to participants eligible to share in such contribution in the same manner as any such discretionary profit-sharing contribution.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. Upon termination, a Plan participant will receive the amounts allocated to his or her account in which he or she is vested in one lump-sum payment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of 90 days or less to be cash equivalents.

Credit Risk

Financial instruments which potentially subject the Plan to concentration of credit risk consist principally of cash and cash equivalents. The Plan tries to limit the amount of its credit exposure by placing its cash and cash equivalents with high quality financial institutions.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from corroborated by observable market data by correlation or other mean.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June 30, 2025 and 2024. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds and Exchange Traded Funds (ETF) - Valued at the daily closing price as reported by the fund. Mutual funds and ETFs held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and ETFs held by the Plan are deemed to be actively traded.

Real Estate Investment Trusts - Certain REIT securities are valued at the net asset value (NAV) based on the fair value of the underlying real estate holdings. The value of the underlying real estate properties is determined by an external appraisal on a periodic basis, which are estimates based on independent appraisals using the discounted cash flow method and applying market discount rates and capitalization rates. Certain REIT securities are valued at the closing price reported on the active market on which the individual securities are traded.

U.S. Treasury Bills - U.S. treasury bills are valued based on quoted market prices of identical instruments in active markets.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2025 and 2024, there were no purchases or sales of the Real estate investment trust.

The Plan's policy is to recognize transfers into and out of the Level 3 at the end of the reporting period.

There were no transfers into or out of Level 3 during the year ended June 30, 2025. During the year ended June 30, 2024, \$74,276 was transferred out of Level 3 to Level 1.

4. Tax Status

The Plan uses a pre-approved plan document sponsored by Mark A Schwab & Associates Inc. Mark A Schwab & Associates Inc. received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAS requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes any uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

5. Plan Termination

Although the Employers have not expressed any intent to terminate the Plan, they reserve the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the account balances will be distributed to participants in accordance with the terms of the Plan.

6. Related Party and Party-in-Interest Transactions

Certain employees of the Employers provide administrative services to the Plan. These employees are not paid by the Plan for their services. The Plan paid for administrative and investment management services amounting to \$76,579 during 2025. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

As of June 30, 2025 and 2024, there were three and five investments held that individually accounted for more than 10% of total investments, respectively.
