Independent Auditor's Report

To The Administrative Committee and Plan Participants of the
Southwest Spine & Pain, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Southwest Spine & Pain, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Southwest Spine & Pain, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Emphasis of Matter

As discussed in Note 3 to the financial statements, the Company elected to terminate the Plan during the plan year ended December 31, 2024. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Southwest Spine & Pain, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 – Plan Description

The following brief description of the Southwest Spine & Pain, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General – Southwest Spine & Pain, LLC is a member of a controlled group. The Plan covers affiliated employers of the controlled group including Frieden Pain Management PC, JBHL Spine and Pain Care PC, RWO Enterprises PC, Hoelzer Consulting, PLLC, Freedom Equity, PLLC, Tributum, PLLC, and Vista Healthcare Management, LLC (collectively referred to as the Company). The Company established the Plan effective as of January 1, 2017 and the Plan was restated effective June 27, 2024. The Plan is a defined contribution plan covering employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees are eligible to participate in the Plan if they have completed one year of service and are at least 21 years of age. Employees are credited with a year of service at the end of the twelve month period beginning on the date of hire if they have been credited with at least 1,000 hours of service during such period. Employees enter the plan on the first day of the fourth and tenth months of the plan year after they meet the eligibility requirements.

Contributions – Each year, participants may elect to contribute up to the maximum amount of compensation allowed by Code Sections 402(g) and 414(v) not to exceed the limits of Code Sections 401(k), 404, and 415 (for 2024 the limit is \$23,000). This amount is indexed periodically for changes in the cost-of-living index. This limit applies to all employee 401(k) contributions made during a tax year to any 401(k) plans maintained by a present or former employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The plan allows for a discretionary company match of the participant's contribution. The Company did not elect to make a matching contribution for the year ended December 31, 2024. The Plan also allows for profit sharing contributions at the Company's discretion. Profit sharing contributions are allocated to participants using the grouping method. Participants are eligible for profit sharing and matching contributions if they have met the initial eligibility requirements (age 21 or older and completed one year of service), are employed on the last day of the plan year, and have completed 1,000 hours of service during the plan year. Employee contributions are funded each pay period and employer discretionary match and profit sharing are made annually after the plan year-end (amounts are accrued as a receivable each year, as applicable). The Company elected not to make a profit sharing contribution for the year ended December 31, 2024.

Investment Options – Upon enrollment in the Plan, a participant may direct deferrals and employer contributions in selected investment options. Participants may change their investment options at any time.

Note 1 – Plan Description (Continued)

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant’s account and carried interest at rates ranging from 9.75% to 10.50%, which were commensurate with local prevailing rates at the time funds were borrowed, as determined by the plan administrator. Principal and interest was paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant’s residence. A participant may have no more than one outstanding loan at any time.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary match and profit sharing portion of their accounts plus actual earnings thereon is based on years of continuous service. A year of service requires completion of 1,000 hours of service. A participant is 100% vested after five years of credited service for employer match contributions (with 20% vesting each year under a five-year graded vesting schedule) and is 100% vested after four years of credited service for profit sharing contributions (with 25% vesting each year under a four-year graded vesting schedule).

Payment of Benefits and Withdrawals – On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Distributions may be made at the participant’s election prior to termination for hardships as defined in the Plan document.

Forfeited Accounts – Forfeited accounts are used to reduce future employer contributions or Plan administrative expenses. Forfeited nonvested accounts total \$0 and \$12,649 as of December 31, 2024 and 2023, respectively. During the plan year ended December 31, 2024, \$13,548 of nonvested participant funds were forfeited. Forfeitures of \$25,642 were used to reduce employer contributions and forfeitures of \$834 were used to reduce administrative expenses.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The Company terminated the plan effective December 15, 2024 and all assets were transferred from the plan prior to year-end. As a result, the Plan has changed its basis of accounting from the accrual method used in presenting the financial statements as of December 31, 2023 to the liquidation basis used in presenting the financial statements as of December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable and Allowance for Credit Losses – Contributions receivable consists of contributions from participants and/or the plan sponsor that have not yet been remitted to the Plan. The allowance estimate is derived from a review of the Plan’s historical losses based on the age of receivables and the type of receivable. This estimate is adjusted for the trustee’s assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. The Plan believes historical loss information is a reasonable starting point in which to calculate the expected allowance for credit losses. Actual credit losses could differ from the estimate. Assets are presented in the financial statements at the net amount expected to be collected. As of December 31, 2024 and 2023, the Plan has recorded no allowance for credit losses as it is not considered material to the financial statements.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Corrective Distributions Payable – Amounts payable to participants totaling \$0 and \$92,932 as of December 31, 2024 and 2023, respectively, for contributions that caused the Plan to fail ADP and ACP testing, are recorded as corrective distributions payable with a corresponding decrease to participant contributions. Failed tests were corrected by distributing the excess contributions.

Payment of Benefits – Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024 and 2023. The Plan does not allow for in-service distributions.

Administrative Expenses – Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Plan Termination

Management of Southwest Spine & Pain, LLC approved the termination of the plan and transfer of its assets into the Principal Ease 401(k) Plan effective December 15, 2024. As a result, all assets were transferred from the Plan into the Principal Ease 401(k) plan prior to December 31, 2024. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Final valuation was determined based on all participants being 100% vested, and all assets were transferred out of the plan as soon as possible after the termination date.

When the Plan terminates, benefits are not insured by the Pension Benefit Guaranty Corporation (PBGC). Under the law, PBGC insurance does not cover the type of plans called defined contribution plans. This Plan is a defined contribution plan and, therefore, is not covered.

Note 5 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. FASB Accounting Standards Codification 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash – The fair value of interest-bearing cash is based on cash value at year-end.

Mutual Funds – The fair value of mutual funds is based on quoted market prices.

Transfers Between Levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluated the transfers between levels based upon the nature of the financial instruments and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of level 3.

Note 6 – Tax Status

The Plan uses a Non-Standardized Pre-Approved Profit Sharing plan sponsored by PCS Retirement LLC which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the Pre-Approved document satisfies the applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. Generally, three tax years remain subject to examination by tax jurisdictions.

Note 7 – Exempt Party-in-Interest Transactions

Fees paid by the Plan to service providers amounted to \$30,738 for the year ended December 31, 2024 and are considered to be exempt party-in-interest transactions.

Party-in-interest balances include notes receivable from participants of \$0 and \$9,824 as of December 31, 2024 and 2023, respectively, and are considered exempt party-in-interest amounts.

Note 8 – Nonexempt Party-in-Interest Transactions

During the year ended December 31, 2024, the Company remitted participant contributions of \$6,354 to the trustee later than required by Department of Labor (DOL) Regulation 2510.3-102. The delinquent contributions have not been corrected as of December 31, 2024.

During the year ended December 31, 2023, the Company remitted participant contributions of \$34,502 and loan repayments of \$2,484 to the trustee later than required by Department of Labor (DOL) Regulation 2510.3-102. The delinquent contributions were corrected outside VFCP as of December 31, 2024.

Note 9 – Subsequent Events

Subsequent events have been evaluated through December 23, 2025, which is the date the financial statements were available to be issued.
