Note 1 - Plan Description

The following description of Frontier Dental 401(k) Plan (the "Plan"), formerly Frontier Dental Laboratories I 401(k) Profit Sharing Plan & Trust, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Frontier Dental Holdings, LLC (the "Company") who have completed three months of service and are age 18 or older with the exclusion of union employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2025, the Plan was amended, resulting in the plan name being changed to Denbright Dental Labs 401(k) Plan.

Contributions

The Plan provides for employee salary 401(k) contributions on a pretax and post-tax (Roth) basis up to the maximum tax-deferred limitations established by the Internal Revenue Code. Once eligible, there is an automatic employee deferral of 2 percent unless the employee elects a different percentage or amount. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2024. The lost earnings related to the late contributions are expected to be remitted in 2025.

The Plan provides for flexible discretionary employer matching contributions of 100 percent of the participant's contribution up to 1 percent of eligible compensation deferred plus 50 percent of the participant's contribution up to the next 5 percent of eligible compensation, with a maximum match not to exceed 3.5 percent of the employee eligible compensation. Total match for 2024 is \$719,568.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participants' account and bear interest at market rates. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary deferrals, rollover contributions employer matching contributions, employer nonelective contributions, and any income or loss thereon.

Benefit Payments

Distributions are payable upon retirement, death, disability, attainment of age 59½, or termination of employment in the form of a partial or lump-sum amount equal to the vested balance of a participant's account.

Note 1 - Plan Description (Continued)

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrators must approve any such hardship withdrawals.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Mid Atlantic Trust Company; Reliance Trust Company; Nationwide Trust Company, FSB; Matrix Trust Company; and Charles Schwab Trust Bank. Mid Atlantic Trust Company; Reliance Trust Company; Nationwide Trust Company, FSB; Matrix Trust Company; and Charles Schwab Trust Bank served as trustees of the Plan during the year; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including December 12, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

In 2024, the Plan changed its trustee from Mid Atlantic Trust Company; Reliance Trust Company; Nationwide Trust Company, FSB; and Matrix Trust Company to Charles Schwab Trust Bank. Mid Atlantic Trust Company; Reliance Trust Company; Matrix Trust Company; and Charles Schwab Trust Bank (collectively, the "Certifying Trustees") held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit except for approximately \$40,000 of investment gains and losses, which are uncertified. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Certifying Trustees.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 5 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Guaranteed Investment Contract

The Plan has a benefit-responsive investment contract with The Standard Insurance Company (SIC). SIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 1 percent. When establishing interest crediting rates for this product, SIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 7 - Plan Merger

Effective January 1, 2024, participants of the D&S Dental Laboratory, Inc 401(k) Savings Plan; Dental Lab Aesthetics LLC 401(k) Profit Sharing Plan and Trust; Nu-Art Dental Inc. 401(k) Profit Sharing Plan and Trust; Burbank Dental Laboratory, LLC Salary Deferral Plan; and Friendship Dental Laboratories 401(k) Profit Sharing Plan and Trust merged into the Plan. Accordingly, the related assets, participants, and their related account balances of approximately \$28,460,000 were transferred into the Plan during 2024.

Note 8 - Subsequent Events

Subsequent to year end, the Absolute Dental Services, Inc. 401(k) Profit Sharing Plan was merged into the Plan. Accordingly, assets of approximately \$4,150,000 were transferred into the Plan.
