To Whom It May Concern,

Alliance Bus Group, Inc. ceased operations in 2021 when another company acquired the assets of the company and the employees were hired by the acquiring company. Alliance worked with our 401k service provider to close down the 401k program. We were told that they had completed the work to shut down the plan and no future action was required. We recently were forwarded a letter from the IRS noting the Form 5500 was not filed for 2023. We then contacted our old service provider and they informed us the former employee that serviced our account was incorrect and they did not close the program as they had claimed to us. As a result, we identified that the 2023 and 2024 form 5500s were not filed on time and we are now filing those as quick as we became aware of the issue. All participants in the 401(k) plan withdrew all remaining balances in 2024, so the plan is no longer holding any assets. We apologize in advance for the discrepancy.
