The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - PLAN DESCRIPTION

The following is a brief description of the Rockefeller Philanthropy Advisors 401(k) Plan (the "Plan"), which was adopted and commenced on January 1, 2011. Participants should refer to the Plan document for more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution pension plan covering eligible employees of Rockefeller Philanthropy Advisors, Inc. (the "Organization"), except leased employees, independent contract employees, and full-time students employed on a part-time basis. Full-time employees become eligible and may enroll as of the first day of the month following completion of one month of service. Part-time employees, who work less than 20 hours per week, are eligible to participate as of the first day of the month following completion of a 12-month period during which they are credited with 1,000 hours of service. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan has an auto-enrollment feature whereby eligible employees will be auto-enrolled into the Plan at a default deferral rate of 3%.

The Plan permits conversion of plan assets into a Roth feature within the Plan.

Effective July 1, 2022, the Plan was amended and restated to reflect certain statutory changes.

##### **Contributions**

Each year, participants may make voluntary, elective pre-tax and/or after-tax contributions to the Plan, a percentage or dollar amount of their annual compensation, as defined in the Plan. Participants, who have attained 50 years old before the end of the Plan year, are eligible to make catch-up contributions. The maximum voluntary pre-tax contribution permitted by federal tax law was \$23,000 in 2024, and the maximum allowable catch-up contribution for 2024 was \$7,500 for a total maximum contribution of \$30,500 for eligible participants during 2024. Participants may also contribute amounts representing distributions from other qualified, defined benefit or defined contribution plans.

The Organization matched 100% of the first 3% of pre-tax contributions, including any catch-up contributions. The Employer match is subject to an annual true-up. The Organization made a safe-harbor non-elective employer contribution in the amount of 3% of eligible compensation, to allow the Plan to satisfy nondiscrimination tests under Section 401(k) of the Internal Revenue Code (the "Code"). Per the Plan document, there is also an employer basic contribution in which the Organization contributed 3% of eligible compensation for organization employees.

Contributions are subject to certain federal limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the allocation of the Organization's contributions and plan earnings thereon and charged with certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are always 100% vested in their accounts attributable to the following contributions: elective pre-tax deferrals including catch-up contributions, employee (after-tax) contributions, rollover contributions, and safe-harbor contributions.

All employees, irrespective of their years of service with the Organization, are 100% vested in their employer contributions.

The interest of each participant in their basic and matching contribution accounts is 100% vested upon normal retirement, death or disability.

***Notes Receivable From Participants***

Subject to terms and conditions imposed by applicable tax regulations, participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Loan terms range from one to five years, or for a longer period if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Loan repayments are made through payroll deductions. A participant may have three loans outstanding at one time. A loan default resulting in a taxable distribution (and early withdrawal penalties, if applicable) will occur if payment is not made by the last day of the calendar quarter following the calendar quarter in which the loan repayment was due.

***Payment of Benefits***

Upon retirement, hardship or termination, or for termination of service for other reasons, vested benefits can be distributed in either a lump-sum benefit or an alternative form of payment, as permitted under the Plan. If the participant's vested benefit does not exceed \$5,000, the Plan Administrator may direct the trustee to distribute, in a lump-sum payment, the participant's vested benefits. In accordance with Internal Revenue Service (the "IRS") regulations, participants must first exhaust all other assets available before obtaining a hardship withdrawal. All hardship withdrawals must be approved by the Plan Administrator and may only be taken against employee deferral balances.

***Investment Options***

Contributions are invested according to the options elected by the participants among the then available investment options. The investment options include various funds, which provide participants the opportunity to select from various returns on investment alternatives. There are no non-participant directed accounts.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,766 and \$12,174, respectively. During 2024, \$191 was used to reduce administrative expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Units of the collective trust fund is valued at the net asset value (“NAV”) as reported by the sponsor of the fund. Shares of mutual funds are valued at quoted market prices. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from such estimates.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and asset management fees are charged directly to the participant’s account and are included in administrative expenses. Other investment related expenses are included in net depreciation of fair value of investments.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company (“Fidelity”), the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Total investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan follows guidance that establishes a single authoritative definition of fair value measurements used in financial statements, provides enhanced guidance for measuring the fair value of assets and liabilities and requires additional disclosures related to the extent to which assets and liabilities are measured at fair value, the information used to measure fair value, and the effect of fair value measurements on earnings. Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants exclusive of any transaction costs and are determined by either the principal market or the most advantageous market. The principal market

is the market with the greatest level of activity and volume for the asset or liability. Absent a principal market to measure fair value, the Plan would use the most advantageous market, which is the market that the Plan would receive the highest selling price for the asset or pay the lowest price to settle the liability, after considering transaction costs. However, when using the most advantageous market, transaction costs are only considered to determine which market is the most advantageous, and these costs are then excluded when applying a fair value measurement.

The guidance creates a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below, with Level 1 having the highest priority and Level 3 having the lowest:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There are no changes in the methodologies used at December 31, 2024 and 2023:

*Collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are units of a collective trust and shares of mutual funds managed by affiliates of Fidelity, the Plan's trustee. Fees paid by the Plan for the investment management services are included in net depreciation in fair value of investments. In addition to the administrative expenses disclosed in the statement of changes in net assets available for benefits, the Organization also pays directly, fees related to the Plan's operations. The Plan also permits notes receivable from participants. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules under ERISA.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 - TAX STATUS & PLAN OPERATIONS**

The underlying standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401(a) of the Code. Any employer adopting this form of the Plan is considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

For the plan years ended December 31, 2024 and 2023, the Plan identified certain operational errors related to the calculation of eligible compensation, deferral limits, and delays in processing of automatic enrollment and deferral changes. Specifically, the Plan allowed certain participants to defer contributions on certain

compensation that is not part of eligible compensation under the plan instrument (severance and bonus). Additionally, the Plan allowed certain participants to defer contributions on earnings above the IRS compensation limits. Lastly, the Plan identified certain participants who were not enrolled timely in accordance with the Plan's automatic enrollment provisions and participants whose deferral changes were not processed timely.

As of December 31, 2024, the Plan reported employee contributions receivable in the amount of \$10,172 to correct identified operational errors and due to timing of year-end payroll.

As of December 31, 2024, the Plan reported employer contributions receivable in the amount of \$59,427, which is net of \$178,439 to correct identified operational errors and will be offset by available forfeitures in 2026.

The operational errors are being corrected by the Plan Administrator in a manner consistent with the general correction principles under the IRS Employee Plans Compliance Resolution System (EPCRS), as currently prescribed in Rev Proc 2021-30. Changes to administrative procedures have been implemented to prevent recurrences of these types of errors in the future.

Besides the operational errors described above, the Plan Administrator believes the Plan is being operated in compliance in all material respects with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan's investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks that determine the value of the Funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is possible that changes in market conditions in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During Plan years 2024, 2023, and 2022, certain participant contributions and loan repayments totaling \$670,607, \$2,643,242, and \$84, respectively, were not remitted in a timely manner in accordance with the U.S. Department of Labor regulations. These non-timely remittances are considered prohibited transactions. The Organization is currently working with Fidelity to remit all late remittances and lost earnings on all non-timely contributions.

**NOTE 10 - SUBSEQUENT EVENTS**

The Organization has evaluated events and transactions for potential recognition or disclosure through January 12, 2026, which is the date the financial statements were available to be issued, and determined that there were no circumstances that warranted recognition or disclosure of those events or transactions in the financial statements as of December 31, 2024.
