Notes to Financial Statements

Note 1: Plan Description

The following description of the MCC, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering all eligible classes of employees of MCC, Inc. and Black Creek Limestone Company (the "Companies") who have completed 30 days of continuous service and have reached the age of 18. Employees are allowed to enter the Plan and receive Company discretionary matching contributions on the first day of the month following meeting eligibility requirements. To be eligible to receive any Company discretionary nonelective contributions, participants must complete one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Contributions

Each year, participants are allowed to contribute to the Plan up to 75% of annual eligible compensation, as defined in the plan document, on a pre-tax or Roth basis. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to not participate in the Plan or make an alternate deferral election. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. All participants deferring less than 15% are subject to a 1% annual increase in their deferral rate each July 1, up to a maximum of 15% of eligible compensation, unless they affirmatively elect to defer less than 15%.

The Companies' matching and nonelective contributions are discretionary. For the year ended March 31, 2025, the Companies made discretionary matching contributions equal to 50% of each participant contributions up to 8% of eligible compensation. Rollover contributions are not matched. There were no discretionary nonelective contributions for 2025.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' discretionary matching contributions, and allocations of (a) the Companies' discretionary nonelective contributions, (b) plan earnings or losses, and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' discretionary matching and nonelective contributions is based on years of service. Participants vest at a rate of 20% each year beginning with the second year of credited service and become fully vested after six years of service. In addition, participants become fully vested upon death or disability as well as attainment of normal retirement age of 59 1/2 if employed with the Companies on such date.

Payment of Benefits

Plan benefits are available at normal retirement (age 59 1/2), disability, death, or termination of employment. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. Distributions are allowed in the event of a financial hardship if certain conditions are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Companies before becoming 100% vested in the Companies' discretionary matching and nonelective contributions. There were forfeited nonvested accounts totaling \$6,976 at March 31, 2025 and \$12,191 at March 31, 2024. The Companies may decide in its discretion how to use forfeitures under the plan document. During 2025, forfeited accounts of \$23,413 were used to reduce discretionary matching contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment advisory fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income.

Fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through January 8, 2026, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Fair value of the common/collective trust fund is based on quoted NAV of the underlying investments held by the common/collective trust fund. The common/collective trust invests in a fully benefit-responsive guaranteed investment contract whose underlying investments are pooled separate accounts that invest in funds that are actively traded and must publish their daily NAV and transact at that price.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and non-interest-bearing cash held at March 31, 2025 and 2024, and net appreciation in fair value of investments, and interest and dividends for the year ended March 31, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company ("Matrix"), the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

OneAmerica Retirement Services, LLC ("OneAmerica") is the recordkeeper of the Plan, and UBS Financial Services, Inc. ("UBS") serves as the investment advisor for the Plan. Transactions with these parties qualify as party-in-interest transactions. For 2025, fees paid to OneAmerica for recordkeeping and administrative services were \$42,500, and fees paid to UBS for investment advisory services were \$62,528. Certain fees for investment management services during the plan year ended March 31, 2025, are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. These transactions are not prohibited transactions under ERISA regulations.

Note 6: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter dated August 19, 2020, which states the non-standardized pre-approved plan document as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receipt of the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the plan document to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Companies' additional discretionary matching and nonelective contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
