**SUMMARY ANNUAL REPORT**  
for  
**Southeast Arkansas Economic Development District Tax-Deferred Annuity Plan**

This is a summary of the annual report for Southeast Arkansas Economic Development District Tax-Deferred Annuity Plan, 71-0397601/002 for 07/01/2024 through 06/30/2025. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

*Basic Financial Statement*

Plan expenses were \$594,514. These expenses included \$3,084 in administrative expenses, \$591,430 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 56 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan was \$2,279,975 as of 06/30/2025 compared to \$2,553,509 as of 07/01/2024. During the plan year the plan experienced a decrease in its net assets of (\$273,534). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$320,980, including employer contributions of \$74,859, employee contributions of \$75,184 and earnings from investments of \$170,937.

The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at P.O.
