INDEPENDENT AUDITORS' REPORT

To the Participants, Trustee, and Plan Administrator
Stronghold Engineering, Inc. Health & Welfare Plan

Opinion

We have audited the financial statements of the Stronghold Engineering, Inc. Health & Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the statements of benefit obligations as of December 31, 2024 and 2023 and the related statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Stronghold Engineering, Inc. Health & Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stronghold Engineering, Inc. Health & Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

1. DESCRIPTION OF PLAN:

The following description of the Stronghold Engineering, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a health and welfare plan covering eligible employees, as defined, of Stronghold Engineering, Inc. (the Employer or Company). The Plan and Trust were established June 1, 2023 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator, along with various advisors, is responsible for oversight of the Plan.

Benefits

The Plan provides medical, prescription, dental, vision, and short-term disability coverage for eligible participants and their beneficiaries on a self-funded basis. Other benefits such as medical, vision, life insurance, accident, and stop loss coverage are funded through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan.

Eligibility

Salaried administrative employees are eligible to participate in the Plan on the first day of the month following two months of continuous employment. Hourly field employees are eligible to participate in the Plan on the first day of the month following 160 hours worked.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight of the last day of the month in which eligibility ceases. The Plan also provides continuation of benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes contributions for participating employees covered under the Plan. For employees covered under contracts issued by federal, state, municipal or other contracting authorities which require the payment of specified prevailing rates, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

Stop loss coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits for claims in excess of \$100,000 per year per subscriber. The amount of stop-loss reimbursements netted against health and other benefit claims paid for the year ended December 31, 2024 totaled approximately \$437,046.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of credit risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Contributions receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid.

Insurance premiums payable

Insurance premiums payable are based upon the actual premiums due for the year but paid by the Plan after year-end.

Benefit claims payable but not reported

The obligation for benefit claims incurred, but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported and paid by the Plan after year-end. The estimate was calculated using available claims experience data and projected future claims.

Expenses

The Plan pays administrative expenses that consist of administrative fees, accounting fees, and other miscellaneous expenses. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. Certain other expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

Subsequent events

The Plan has evaluated subsequent events through December 31, 2025, the date the financial statements were available to be issued.

3. INCOME TAXES:

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscretionary manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

As noted in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

6. RISKS AND UNCERTAINTIES:

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
