Notes to Financial Statements

(1) Description of the Plan

The following description of the USW Local 318 (the "Union") Health and Welfare Trust Fund (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the plan provisions.

General - The Plan is a defined benefit health and welfare plan which was established in January 1955 under a collective bargaining agreement. The Plan provides benefits to eligible members of USW Local 318 who are employed by participating employers. The administration of the Plan is the responsibility of the Board of Trustees, comprised of union and employer trustees. The investments of the Plan are managed by investment advisors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Contributing employers are required to make contributions to the Plan on behalf of each participant on the basis of a rate fixed by the applicable collectible bargaining agreement in effect. The contribution rates vary depending on the level of benefits negotiated. Employee participants are not required to contribute to the Plan.

Eligibility - The Plan provides benefits to eligible participants and specified dependents if such participants are regular full-time employees (40 hours per week) of an employer who makes contributions to the Plan and has met the 90 day waiting period for benefits.

Benefits - The Plan provides dental coverage to eligible employees of employers who have a collective bargaining agreement with the USW Local 318 Union. Participants receive benefits through Cigna Insurance Co. ("Cigna") and such benefits are being provided on a fully insured basis.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employers' Contributions - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a percentage of the participating employers' monthly payroll for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection, including subsequent period collection activity. As of May 31, 2025 and 2024, the Plan did not record any allowance for credit losses for employers' contributions receivable.

Notes to Financial Statements

(2) Summary of Significant Accounting Policies (Continued)

Deferred Employers' Contributions - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on an agreed upon hourly rate and are billed a month in advance. Contributions paid prior to year-end are recorded as deferred contributions. As of March 31, 2025 and 2024, the amount of deferred contributions were \$903 and \$8,863, respectively.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits - Premiums paid are recorded as benefit payments in the accompanying statement of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through January 9, 2026, the date on which the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(3) Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 as compared to March 31, 2024.

Interest Bearing Cash Accounts: Valued using amortized cost, which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(4) Pension Withdrawal Liability

Effective July 1, 2012, all employees of the Plan were terminated. Those employees were participants in the USW International Union's Defined Benefit Pension Plan (the "Pension Plan"). As a result, in September 2013, the Pension Plan assessed a withdrawal liability against the Plan for \$303,348. Plan management and legal counsel originally contested this liability. Due to a 20-year payment cap per ERISA section 4219, the total amount due to the International Pension Plan was determined to be limited to \$169,339. The Plan is required to make monthly payments of \$706 until the \$169,339 withdrawal liability is paid off or settled. The Plan repaid \$7,761 and \$8,467 for the years ended March 31, 2025 and 2024, respectively. Amounts due to the Pension Plan for the withdrawal liability as of March 31, 2025 and 2024 were \$73,381 and \$81,142, respectively.

(5) Tax Status

The Plan has received an exemption letter from the IRS dated January 1955, stating that the plan was in compliance with the applicable requirements of the provisions of Section 501(c)(9) of the IRC. No federal or state income taxes have been recorded in 2025 for unrelated business taxable income. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Plan Termination

In the event of the termination, the Plan assets will be used to continue the payment of the benefits provided to eligible employees, their dependents and beneficiary or next of kin, and to otherwise effectuate the purpose of the Plan.

(7) Significant Participating Employers

During the years ended March 31, 2025 and 2024, the Plan had the following employers which individually represented 10% or more of total contributions:

In the event these participating employers were to suspend contributions, the Plan would retain the risk of meeting current plan obligations until the appropriate adjustments were made.

(8) Risk and Uncertainties

Investment Securities - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Credit Risk - Cash consists of monies held in interest and non-interest-bearing transaction accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At March 31, 2025 and 2024, the Plan's had no cash balance that exceeded federally insured limits.


